Note 1: Description of Fund

The following description of the Local 400 Food Terminal Employees Welfare Fund (the “Fund”) only provides general information about the Fund’s provisions. Participants should refer to the Fund agreement for a complete description of the Fund’s provisions.

General

The Fund is a multiemployer defined benefit health and welfare plan that was established by an agreement and declaration of trust, which was amended on September 12, 1992, pursuant to a collective bargaining agreement (CBA) between Commission House Drivers Union Local 400, affiliated with the International Brotherhood of Teamsters (the “Union”) and participating employers. The Fund is governed and managed by the board of trustees (the Trustees and the Plan Administrator). The Local 400 Welfare & Pension Funds Administrative Fund, a separate not-for-profit entity created by the Union, serves the Fund and other plans for the same union members. It administers the collection and investment of funds received from participating employers for providing medical and other benefits to participants in the Fund. In addition, the Fund covers administrative personnel employed by the Union. The Fund provides benefits for eligible participants and their eligible dependents and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Fund’s Board of Trustees has the right under the Fund to modify the benefits provided to members.

Fund assets are held in a voluntary employees’ beneficiary association (VEBA) trust.

Eligibility

To become eligible for benefits, a participant must be currently employed and have been employed for 90 days by a participating employer on a full-time basis. Once the eligibility requirements are met, certain eligible dependents are also covered under the Fund upon submission of the applicable enrollment form and supporting documents to the Plan Administrator.

Generally, a participant will remain eligible as long as actively employed with a participating employer. Participants may also continue to remain eligible for benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Retired employees are eligible for benefits (in excess of Medicare coverage) provided they have attained at least age 50, submitted a proper application within 60 days of their retirement date, and had at least 30 continuous months of active employment with participating employers immediately before retirement. Once the eligibility requirements are met, certain eligible dependents are also covered under the Fund upon submission of the applicable enrollment form and supporting documents to the Plan Administrator.

Contributions

Participating employers contribute various amounts based upon criteria as specified in current collective bargaining agreements between the employers and the Union.

Contributions (continued)

Participant contributions are allowed to provide COBRA benefits, and participants pay the full cost of such benefits.

Postretirement benefit contributions are made by the participating retirees themselves. The contributing rates vary depending upon certain factors such as age, Medicare eligibility, in-state vs. out-of-state, and type of plan.

Benefits

The Fund provides health benefits (medical, hospital, surgical, major medical, prescription drugs, dental, vision, and hearing), life insurance, and accident and sickness benefits to full-time, active employees of a participating employer and to their covered dependents. Additionally, the Fund also provides continuation of certain benefits upon termination of employment through COBRA.

Insured Benefits

Health, prescription drug benefits, dental, vision, and hearing claims of active participants, and their dependents, are processed and fully insured by Medical Mutual of Ohio. Health claims and prescription drug benefits of retired participants, and their dependents, are fully insured by Humana, Inc. Life insurance claims for active participants are processed by Dearborn National Life Insurance Company until August 30, 2024. As of September 1, 2024, life insurance claims are processed by Medical Mutual of Ohio.

Self-Insured Benefits

Accident and sickness claims for active employees are processed in-house by Fund personnel. Dental, vision, and hearing claims for Medicare eligible, retired participants who opt in for that coverage are processed in-house by Fund personnel. Death benefits for eligible retired participants are processed in-house by Fund personnel. Ultimate responsibility for payments to providers and participants is retained by the Fund.

Note 2: Summary of Significant Accounting Policies

Basis of Presentation

The Fund follows authoritative guidance issued by the Financial Accounting Standards Board (FASB) which established the FASB Accounting Standards Codification (ASC) as the single source of authoritative accounting principles generally accepted in the United States of America.

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared using the accrual basis of accounting. The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Note 2: Summary of Significant Accounting Policies (continued)

Cash

The Fund maintains its cash accounts at a national financial institution. The balance, at times, may exceed federally insured limits.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Board of Trustees determines the Fund's valuation policies and procedures. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Fund's gains and losses on investments bought and sold as well as held during the year.

Employer Contributions Receivable

Employer contributions receivable represent amounts due from employers that were received subsequent to year-end. Therefore, the carrying amount of these receivables is not reduced by an allowance for amounts that will not be collected.

Property and Equipment

Property and equipment are recorded at cost, which approximates fair value. Although the assets are fully depreciated, the assets are still in service and, thus, reflected on the accompanying statements of net assets available for benefits.

Deferred Revenue

Deferred revenue consists of retiree self-pay contributions received for insurance coverage yet to be incurred.

Payment of Benefits

Premiums paid by the Fund are recorded as "premiums and benefits" in the accompanying statements of changes in net assets available for benefits. Benefit payments to participants are recorded upon distribution.

Fees and Other Expenses

The Plan Administrator allocates certain administrative and record-keeping costs to the Fund, in addition to the cost of payroll and related payroll benefits directly attributable to the Fund. In computing these allocated costs, the administrative time incurred was considered in relation to the various other entities administered by the Local 400 Welfare & Pension Funds Administrative Fund. These expenses are reported in administrative expenses on the statements of changes in net assets available for benefits.

Subsequent Events

Management has evaluated subsequent events for the Fund through October 9, 2025, the date the financial statements were available to be issued.

Note 3: Certified Investments

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024 and 2023 and net appreciation in fair value of investments, interest and dividends for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by KeyBank National Association (the custodian of the Fund).

Note 4: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Fund has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market mutual fund: Valued at the daily closing price as reported by the fund. The money market fund is an open-end mutual fund that is registered with the Securities and Exchange Commission. This fund is required to publish its daily net asset value (NAV) and to transact at that price. The money market fund is deemed to be actively traded.

Fixed income exchange-traded fund: Valued at the daily closing price as reported by the fund. The mutual fund held by the Fund is an open-end mutual fund that is registered with the SEC. The fund is required to publish its daily net asset value (NAV) and to transact at that price. The mutual fund held by the Fund is deemed to be actively traded.

Note 5: Shared Lease Obligations

The Fund shares in lease obligations and common administrative expenses with the Pension Fund and the Union. The Fund's allocated expenses are recorded with administrative expenses in the statements of changes in net assets available for benefits. Short-term lease expense totaled \$13,701 and \$15,920 for the years ended December 31, 2024 and 2023, respectively.

Note 6: Multi-Employer Benefit Plans

The Pension Fund that the Fund participated in was a multi-employer pension plan that covered all of the Fund's eligible employees. Contributions to the Pension Fund were based upon the collective bargaining agreements. Effective July 27, 2009, the Pension Fund was terminated through the mass withdrawal of all participating employers. As a result of this action, no additional employer contributions will be required in the future. However, the Fund is subject to a withdrawal liability in the amount of \$1,114,717 at both December 31, 2024 and 2023. The liability was calculated by actuaries and is based on federal law and guidelines.

Although the pension withdrawal liability is a legal obligation, the Fund is currently only required to pay quarterly installments of \$7,732 into perpetuity. This amount is comprised of entirely interest expense. Therefore, no reduction has been made to the withdrawal liability principal. While the present value of scheduled payments could change in the future based on actuarially calculated adjustments, changes to other employers' obligations, or settlements reached with the Pension Fund, it is quite possible that the outstanding pension withdrawal liability (i.e., the principal) will never be paid.

Note 8: Tax Status

The Fund has received an exemption letter from the Internal Revenue Service (IRS) dated December 3, 1963, stating that the VEBA trust established under the Fund was in compliance with the applicable requirements of the provisions of Section 501(c)(9) of the Internal Revenue Code (IRC). No federal or state income taxes have been recorded in 2024 or 2023 for unrelated business taxable income.

The Fund and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Plan Administrator believes that the Fund is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Fund management to evaluate tax positions taken by the Fund and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Fund is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9: Priorities Upon Termination of the Fund

Although the board of trustees has not expressed intent to discontinue the Fund, they may do so at any time subject to the provisions of ERISA and the terms of the CBA. In the event of termination of the Fund, the assets of the Fund would continue to be used to pay reasonable administrative expenses and to distribute and apply remaining surplus as the Trustees so determine, until no assets remain.

Note 10: Related-Party Transactions

The Fund shares facilities and certain expenses with the Union and the Pension Fund. The Fund was allocated expenses of \$70,357 and \$87,500 during the years ended December 31, 2024 and 2023, respectively. Amounts owed to the Fund to the Union for overpayment of shared expenses was \$34,566 and \$28,035 at December 31, 2024 and 2023, respectively.

The trust agreement allows the Union to make monthly contributions to the Fund on behalf of its employees to obtain health and welfare benefits. Total contribution revenue received for the Pension Fund and the Fund's employees, by the Fund, for the years ended December 31, 2024 and 2023 was \$34,632 and \$38,628, respectively. Total contribution revenue received for Union employees, by the Fund, for the years ended December 31, 2024 and 2023 was \$17,316 and \$17,316, respectively.

Note 11: Party-in-Interest

Certain Fund investments are managed by the KeyBank National Association and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Fund for investment management services are considered to be party-in-interest transactions.

Note 12: Risks and Uncertainties

The Fund invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.
