## Independent Auditor's Report

To the Plan Administrator of Equifax Inc. Major Medical Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Equifax Inc. Major Medical Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits—modified cash basis as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits—modified cash basis for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Equifax Inc. Major Medical Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

## ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Equifax Inc. Major Medical Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2; this includes determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- exercise professional judgment and maintain professional skepticism throughout the audit.
- identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Equifax Inc. Major Medical Plan's internal control. Accordingly, no such opinion is expressed.
- evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Equifax Inc. Major Medical Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## ***Basis of Accounting***

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America and, as a result, the financial statements may not be suitable for another purpose. Our opinion is not modified with respect to this matter.

## ***Other Matter - Supplemental Schedule Required by ERISA***

The supplemental schedule of Schedule H, Line 4j - Schedule of Reportable Transactions for the year ended December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. **1. Description of Plan**

The following description of the Equifax Inc. Major Medical Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

*General*

The Plan provides medical, dental, vision benefits, and flexible spending accounts to active salaried employees of Equifax Inc. (the Company) and any of its participating United States subsidiaries and their dependents. In addition, all Consolidated Omnibus Budget Reconciliation Act (COBRA) benefits are provided by the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator is responsible for oversight of the Plan. Effective January 1, 2011, the Company adopted the Equifax Retiree Healthcare Program (Retiree Plan), a spin-off of the Plan. All participants classified as either retirees or former employees who have continued medical coverage by reason of receiving Company long-term disability benefits transferred from the Plan to the Retiree Plan. However, dental and vision coverage is still provided to these participants through the Plan. In addition, the 401(h) account assets and the postretirement obligation were transferred to the Retiree Plan.

*Benefits*

The following provides a description of the benefits provided by the Plan during 2024:

**Medical Benefits**

**OAP PPO Option.** Participants may elect coverage under an OAP PPO option. The out-of-pocket cost to the participant is based on the use of in-network or out-of-network providers. Once the participant's \$1,000 deductible (\$3,000 for family) has been met, the Plan will pay 80% of the reasonable and customary charges, until the participant has paid the out-of-pocket maximum of \$3,000 (\$9,000 for family). Then, the Plan will pay 100% of eligible expenses up to the maximum lifetime benefit as defined.

**CDHP Options.** Participants may elect coverage under one of the three Consumer-Driver Health Plan (CDHP) options.

The CDHP 10 option is structured as a traditional CDHP plan with a \$2,000 deductible and a \$2,500 out of pocket maximum. Preventative care is covered at 100%. Co-pays are limited. Employees pay a percentage of cost after the deductible is met.

**1. Description of Plan (Continued)**

The CDHP 20 option is structured as a traditional CDHP plan with a \$3,000 deductible and a \$3,500 out of pocket maximum. Preventative care is covered at 100%. Co-pays are limited. Employees pay a percentage of cost after the deductible is met.

The CDHP 30 option is structured as a traditional CDHP plan with a \$4,000 deductible and a \$6,750 out of pocket maximum. Preventative care is covered at 100%. Co-pays are limited. Employees pay a percentage of cost after the deductible is met.

**Dental Benefits**

Dental costs incurred by participants, their beneficiaries, and dependents are self-insured. The Plan contracted CIGNA to provide claims administration services.

**Dental PPO Enhanced.** The Plan covers the preventative, general, major, and orthodontic services, providing preventative services at 100%, general services at 90%, major services at 60%, and orthodontic services at 50%. There is an annual deductible of \$50 per person (\$150 per family) and a maximum benefit of \$2,000 per year, per person for non-orthodontic services. For orthodontic services, there is a special deductible of \$50 per person and a \$2,000 per person lifetime maximum deductible. There is no deductible for preventative services.

**Dental HMO.** The Plan provides coverage for in-network care only and participants will be assigned a network general dentist. Preventative care services are covered at 100%. The Plan sets the cost for basic restorative, major restorative, orthodontia and implants based on a Participant Charge Schedule (PCS). The PCS is a list of fees for each covered service within the Plan.

**Vision Benefits**

Vision costs incurred by participants, their beneficiaries, and dependents are fully insured by an insurance contract with EyeMed Vision Care. The Plan pays for annual vision examinations with a \$15 copayment. The Plan pays for corrective lenses, contacts (when medically necessary), and allows \$115 toward frames. Each covered person is entitled to one eye exam each calendar year, one set of frames every two calendar years, one set of lenses each calendar year, and one pair of contacts each calendar year. EyeMed Vision Care's Network consists of private practicing optometrists, ophthalmologists, opticians, and an optical retailer.

*Stop-loss coverage*

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits. It covers individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims.

**2. Summary of Accounting Policies**

*Basis of Accounting*

The accompanying financial statements have been prepared using the modified cash basis of accounting which is a basis of accounting other than accounting principles generally accepted in the United States of America (U.S. GAAP). Accordingly, additions are included in the year in which they are collected and deductions are included in the year in which they are disbursed; however, earnings on investments include adjustments to fair value.

*Contributions*

Contributions from Plan participants and the Company are recorded in the year in which the employee contributions are withheld from compensation.

*Use of Estimates*

The preparation of financial statements in accordance with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Payment of benefits*

Benefits are paid to participants in accordance with the provisions of the plan. Claims are processed and paid by the third-party administrator from plan assets. Benefit payments include medical, dental, and vision claims incurred and approved for payment during the plan year.

**2. Summary of Accounting Policies (Continued)**

*Expenses*

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators, the trustee, and the actuary. These expenses are reported on the statement of changes in net assets available for benefits - modified cash basis as administrative expenses. All other administrative expenses, such as professional fees, are paid by the Company on behalf of the Plan.

*Stop-Loss Coverage*

Premiums for stop loss insurance are included in insurance premiums in the accompanying statement of changes in net assets available for benefits - modified cash basis. Stop loss refunds totaling \$1,016,494 have been netted with claims paid in the accompanying statement of changes in net assets available for benefits - modified cash basis for the year ended December 31, 2024.

*Refunds*

Refunds from the Plan's service providers are recorded when paid. Pharmacy rebates totaling \$5,547,210 have been netted with claims paid in the accompanying statement of changes in net assets available for benefits - modified cash basis for the year ended December 31, 2024.

*Health Reimbursement Arrangement*

If a participant is enrolled in any of the CDHP plans, they are eligible for the Health Savings Account (HSA). This account allows participants to set aside pre-tax dollars for health care expenses. The account is owned fully by the participant. Funds never expire and can be saved and invested for future eligible expenses. This account is administered by Fidelity Investments.

*Subsequent Events*

Subsequent events were evaluated through October 15, 2025, the date the modified cash basis financial statements were available to be issued.

**3. Information Certified by Trustee**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Principal Bank, the Trustee of the Plan, has certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits—Modified Cash Basis as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits—Modified Cash Basis for the year ended December 31, 2024 and the information reported in the supplemental Schedule H, Line 4(j) - Schedule of Reportable Transactions for the year ended December 31, 2024.

**4. Plan Obligations**

Plan obligations at December 31, 2024 and 2023 for claims incurred by active participants but not reported at that date and for claims reported by not paid are estimated by the Plan's management based on past experience. Claims payable are also included in the Plan obligation. There were no claims payable as of December 31, 2024 and 2023.

As of December 31, 2024 and 2023 claims incurred but not yet reported were estimated to be \$7,220,100 and \$6,629,200, respectively.

**6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

**7. Tax Status**

The VEBA trust funding the Plan received an exemption letter from the Internal Revenue Service (IRS) dated November 2, 1977, stating that the trust is tax-exempt under the provisions of Section 501(c)(9) of the Internal Revenue Code (IRC). However, as a result of the Plan's funding policy, from time to time the trust may be subject to income taxes. No federal or state income taxes have been recorded in 2024 for unrelated business taxable income. In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
