### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Golden Valley Electric Association, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

## Notes to Financial Statements

---

### 1. Description of the Plan

The following description of the Golden Valley Electric Association 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### *General*

The Plan was adopted effective January 1, 1989 and most recently restated effective July 26, 2021 by Golden Valley Electric Association. Golden Valley Electric Association (the Company or the Employer) is the sponsor of the Plan. The Plan is a contributory defined contribution plan covering all eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 as amended (ERISA) and the Internal Revenue Code (IRC).

#### *Trustee and Administration of the Plan*

The trustee and recordkeeper of the Plan is Fidelity Management Trust Company (Fidelity or trustee). The administrator of the Plan is the Company. The trustee holds all assets of the Plan in accordance with the service provider contract with the Company. Plan management determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### *Eligibility*

All employees are eligible to participate in the Plan unless they are a leased employee, a resident of Puerto Rico or covered by a collective bargaining agreement, unless the agreement requires the employee to be included under the Plan. The Company has a number of collective bargaining agreements which requires the Company to allow the employees to participate in the deferral portion of the Plan. Employees must be age eighteen or older and have three-months of consecutive service to participate in the deferral portion of the Plan. To be eligible for the employer matching contribution and employer fixed nonelective contributions, participants must complete one year of service in which there were at least 1,000 hours of service. Only eligible employees who were eligible to participate in the Plan after December 31, 2011 are eligible for employer fixed nonelective contribution. An eligible participant can enter the Plan on the first day of the month immediately after meeting the eligibility requirements.

#### *Contributions*

Each year, eligible employees may defer up to 75% of pretax annual compensation, as defined in the Plan. The Plan also allows for Roth 401(k) contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contributions plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

The Company makes matching contributions equal to 100% of participant contributions, up to 6% of eligible compensation. The Company also makes fixed nonelective contributions for eligible employees equal to 6% of eligible compensation.

### ***Participant Accounts***

Each participant's account is credited with the participant's contribution, employer matching contributions, employer fixed nonelective contributions, as well as allocations of the Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Notes Receivable from Participants***

Participants are permitted to borrow a minimum of \$1,000 of their vested benefits under the Plan. Participants may borrow up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000, reduced by the highest outstanding loan balance in their account during the prior 12-month period. Loans are secured by the participant's account and bear an interest rate that commensurate with the local prevailing rates as determined by the Plan Administrator, which would be made under similar circumstances and is fixed for the term of the loan. The notes are repaid ratably through payroll deductions over a period of five years or less, unless used to purchase a principal residence, in which case the terms may exceed five years. These loans are subject to certain restrictions as defined by the Plan Document and applicable restrictions under the IRC. Also, each participant may not have more than one loan outstanding at any time.

### ***Vesting***

Participants are 100% vested in their individual deferral and rollover contributions and the allocated earnings thereon. Vesting in the employer contributions portion of their account plus earnings thereon vest according to a three-year cliff vesting schedule.

### ***Forfeited Accounts***

Forfeitures occur when participants terminate employment before becoming 100% vested with respect to their employer contributions. Forfeitures are used to pay administrative expenses and to reduce employer contributions. At December 31, 2024 and 2023, the total unallocated forfeitures were \$44,935 and \$213,388, respectively. There were \$195,881 of forfeited funds used to pay employer contribution in 2024.

### ***Benefit Payments***

Upon termination of service, retirement, death, or disability, participants may elect to receive the vested interest in their accounts as a lump sum distribution or installment distributions. Participants with vested account balance below \$5,000 but above \$1,000 will have their benefits distributed to an individual retirement account (IRA) without their consent. Participants' vested interest of \$1,000 or less will be distributed in a lump sum as soon as practicable following termination of employment, regardless of whether they consented to receive it. Financial hardship withdrawals are permitted, as defined in the Plan agreement. Participants may also withdrawal an amount at age 59½ if certain criteria are met.

### 2. Summary of Accounting Policies

#### *Basis of Accounting*

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

#### *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### *Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investment advisor and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent loans are treated as distributions based upon the terms of the plan document. Related fees are recorded as administrative expenses and are expenses when they are incurred.

#### *Contributions*

Participant contributions and any related employer matching and fixed nonelective contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation.

#### *Payment of Benefits*

Benefits are recorded when paid.

#### *Administrative Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

### 3. Information Certified by Fidelity Management Trust Company

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity, a qualified institution.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

### 4. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

*Level 1:* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2:* Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

*Mutual funds and money market funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-directed brokerage accounts:* These accounts are comprised of common stock, mutual funds and money market funds. Common stock is valued at the published market price on an active market. The mutual funds and money market funds are valued at the NAV that is quoted on an active market and is determined based on the fair value of the underlying assets at the end of each day.

*Common collective trust fund (CCT):* Valued at the NAV of units of a collective trust fund. The NAV, as provided by the trustee of the CCT, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily. This investment is a direct filing entity. The CCT provides for daily redemptions by the Plan at reported NAV with no advance notice. There are no unfunded commitments related to this investment.

The methods described above may produce a fair value calculation that may not be indicative of net asset value or reflective of future fair value. Furthermore, while the Plan's valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different estimates of fair value at the reporting date.

*\* In accordance with Subtopic 820-10, the common collective trust fund has not been classified in the fair value hierarchy since it is measured at net asset value per share (or its equivalent), as a practical expedient for fair value.*

### **5. Tax Status**

The Plan uses a pre-approved plan document sponsored by Fidelity Management and Research Company (FMR). FMR received an opinion letter from the IRS, dated June 30, 2020, which states that the pre-approved plan document, as then designed, satisfies the applicable provisions of the IRC. Although the Plan has been amended since the date of the opinion letter, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

### **6. Termination of the Plan**

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all remaining assets in the affected participants' accounts shall be distributed to the participants and beneficiaries of the Plan in the order provided for by ERISA. In the event the Plan is terminated, participants would become 100% vested in their accounts.

### **7. Related-Party Transactions and Party-in-Interest Transactions**

Certain plan investments are funds and accounts that are managed by Fidelity. Participant loan and certain distribution processing fees are paid to Fidelity by participants. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

### **8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **9. Subsequent Events**

The Plan has evaluated subsequent events through October 15, 2025, the date on which the financial statements were available to be issued.

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Golden Valley Electric Association, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. ### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment



information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- the certified investment information in the supplemental schedule agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### 1. Description of the Plan

The following description of the Golden Valley Electric Association 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### *General*

The Plan was adopted effective January 1, 1989 and most recently restated effective July 26, 2021 by Golden Valley Electric Association. Golden Valley Electric Association (the Company or the Employer) is the sponsor of the Plan. The Plan is a contributory defined contribution plan covering all eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 as amended (ERISA) and the Internal Revenue Code (IRC).

#### *Trustee and Administration of the Plan*

The trustee and recordkeeper of the Plan is Fidelity Management Trust Company (Fidelity or trustee). The administrator of the Plan is the Company. The trustee holds all assets of the Plan in accordance with the service provider contract with the Company. Plan management determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### *Eligibility*

All employees are eligible to participate in the Plan unless they are a leased employee, a resident of Puerto Rico or covered by a collective bargaining agreement, unless the agreement requires the employee to be included under the Plan. The Company has a number of collective bargaining agreements which requires the Company to allow the employees to participate in the deferral portion of the Plan. Employees must be age eighteen or older and have three-months of consecutive service to participate in the deferral portion of the Plan. To be eligible for the employer matching contribution and employer fixed nonelective contributions, participants must complete one year of service in which there were at least 1,000 hours of service. Only eligible employees who were eligible to participate in the Plan after December 31, 2011 are eligible for employer fixed nonelective contribution. An eligible participant can enter the Plan on the first day of the month immediately after meeting the eligibility requirements.

#### *Contributions*

Each year, eligible employees may defer up to 75% of pretax annual compensation, as defined in the Plan. The Plan also allows for Roth 401(k) contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contributions plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

The Company makes matching contributions equal to 100% of participant contributions, up to 6% of eligible compensation. The Company also makes fixed nonelective contributions for eligible employees equal to 6% of eligible compensation.

### ***Participant Accounts***

Each participant's account is credited with the participant's contribution, employer matching contributions, employer fixed nonelective contributions, as well as allocations of the Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Notes Receivable from Participants***

Participants are permitted to borrow a minimum of \$1,000 of their vested benefits under the Plan. Participants may borrow up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000, reduced by the highest outstanding loan balance in their account during the prior 12-month period. Loans are secured by the participant's account and bear an interest rate that commensurate with the local prevailing rates as determined by the Plan Administrator, which would be made under similar circumstances and is fixed for the term of the loan. The notes are repaid ratably through payroll deductions over a period of five years or less, unless used to purchase a principal residence, in which case the terms may exceed five years. These loans are subject to certain restrictions as defined by the Plan Document and applicable restrictions under the IRC. Also, each participant may not have more than one loan outstanding at any time.

### ***Vesting***

Participants are 100% vested in their individual deferral and rollover contributions and the allocated earnings thereon. Vesting in the employer contributions portion of their account plus earnings thereon vest according to a three-year cliff vesting schedule.

### ***Forfeited Accounts***

Forfeitures occur when participants terminate employment before becoming 100% vested with respect to their employer contributions. Forfeitures are used to pay administrative expenses and to reduce employer contributions. At December 31, 2024 and 2023, the total unallocated forfeitures were \$44,935 and \$213,388, respectively. There were \$195,881 of forfeited funds used to pay employer contribution in 2024.

### ***Benefit Payments***

Upon termination of service, retirement, death, or disability, participants may elect to receive the vested interest in their accounts as a lump sum distribution or installment distributions. Participants with vested account balance below \$5,000 but above \$1,000 will have their benefits distributed to an individual retirement account (IRA) without their consent. Participants' vested interest of \$1,000 or less will be distributed in a lump sum as soon as practicable following termination of employment, regardless of whether they consented to receive it. Financial hardship withdrawals are permitted, as defined in the Plan agreement. Participants may also withdrawal an amount at age 59½ if certain criteria are met.

### 2. Summary of Accounting Policies

#### *Basis of Accounting*

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

#### *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### *Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investment advisor and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent loans are treated as distributions based upon the terms of the plan document. Related fees are recorded as administrative expenses and are expenses when they are incurred.

#### *Contributions*

Participant contributions and any related employer matching and fixed nonelective contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation.

#### *Payment of Benefits*

Benefits are recorded when paid.

#### *Administrative Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

### 3. Information Certified by Fidelity Management Trust Company

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity, a qualified institution.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

### 4. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

*Level 1:* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2:* Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

*Mutual funds and money market funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-directed brokerage accounts:* These accounts are comprised of common stock, mutual funds and money market funds. Common stock is valued at the published market price on an active market. The mutual funds and money market funds are valued at the NAV that is quoted on an active market and is determined based on the fair value of the underlying assets at the end of each day.

*Common collective trust fund (CCT):* Valued at the NAV of units of a collective trust fund. The NAV, as provided by the trustee of the CCT, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily. This investment is a direct filing entity. The CCT provides for daily redemptions by the Plan at reported NAV with no advance notice. There are no unfunded commitments related to this investment.

The methods described above may produce a fair value calculation that may not be indicative of net asset value or reflective of future fair value. Furthermore, while the Plan's valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different estimates of fair value at the reporting date.

*\* In accordance with Subtopic 820-10, the common collective trust fund has not been classified in the fair value hierarchy since it is measured at net asset value per share (or its equivalent), as a practical expedient for fair value.*

### **5. Tax Status**

The Plan uses a pre-approved plan document sponsored by Fidelity Management and Research Company (FMR). FMR received an opinion letter from the IRS, dated June 30, 2020, which states that the pre-approved plan document, as then designed, satisfies the applicable provisions of the IRC. Although the Plan has been amended since the date of the opinion letter, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

### **6. Termination of the Plan**

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all remaining assets in the affected participants' accounts shall be distributed to the participants and beneficiaries of the Plan in the order provided for by ERISA. In the event the Plan is terminated, participants would become 100% vested in their accounts.

### **7. Related-Party Transactions and Party-in-Interest Transactions**

Certain plan investments are funds and accounts that are managed by Fidelity. Participant loan and certain distribution processing fees are paid to Fidelity by participants. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

### **8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **9. Subsequent Events**

The Plan has evaluated subsequent events through October 15, 2025, the date on which the financial statements were available to be issued.
