Opinion

We have audited the financial statements of the Welfare Benefits Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of benefit obligations and net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in benefit obligations and net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

As discussed in Note 3 to the financial statements, the 2023 financial statements have been restated to correct misstatements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

NOTE 1. DESCRIPTION OF THE PLAN

The following description of the Welfare Benefits Plan (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a health and welfare benefit plan of Olin Corporation (Olin or Employer). The Plan is intended to provide eligible employees and certain retired employees with access to benefits for medical, prescription drugs, dental, vision, critical illness, life insurance, flexible spending, accident insurance, short-term disability, long-term disability, term life insurance, and employee assistance. The Plan was intended to qualify under Section 501(c)(9) of the Internal Revenue Code of 1986, as amended (Code). The Plan is subject to the applicable provisions of the *Employee Retirement Income Security Act of 1974*, as amended (ERISA).

Eligibility

The Plan is available to substantially all full-time employees and certain retired employees. Eligibility for benefits under the Plan depends upon employment type and whether the employee is represented by a collective bargaining agreement.

Benefit Payments

Benefits are based on the relevant programs the employee has elected to participate in or those that are provided to the specific employee. Benefits are paid based on the Plan's provisions.

Trust Fund Management

The Plan is managed through a Voluntary Employees' Beneficiary Association trust (VEBA Trust). Portions of the Plan are subject to an agreement between Principal Custody Solutions (Trustee) and Olin. Under the terms of the VEBA Trust agreement, the Trustee is responsible for the safekeeping of Plan assets in the VEBA Trust and the maintenance of records relating to receipts and disbursements from the VEBA Trust, and the maintenance of accounting records and any other records relating to the VEBA Trust.

Plan Termination

Although it has not expressed any intent to do so, Olin has the right under the Plan to terminate the Plan, subject to the provisions of ERISA.

Under the terms of an agreement entered into effective April 14, 2000 between Olin and the United States Department of Defense, any surplus assets remaining upon termination of the VEBA Trust, after satisfaction of all participant benefit obligations and payment of necessary administrative

expenses, are required to be distributed to the United States Department of Defense, in accordance with the terms and conditions of the agreement.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America (United States).

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Benefit Obligations

Postemployment Benefit Obligations

The postemployment benefit obligations represent the total actuarial present value of estimated future benefits that are attributed to employee service rendered through December 31, 2024 and 2023 and estimated future insurance premium payments for certain currently retired and disabled employees. Postemployment benefit obligations include future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and dependents and (2) active employees and their beneficiaries and dependents after separation from employment. Future postemployment benefit obligations are actuarially estimated from costs per participant reduced by the present value of contributions and are adjusted for the time value of money. Prior to an active employee's full eligibility date, the postemployment benefit obligation is the portion of the expected postemployment benefit obligation that is attributed to that employee's service rendered through the valuation date.

The actuarial present value of the expected postemployment benefit obligations is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims cost data to estimate future annual incurred claims, discounts for interest, and the probability of payment (by means of decrements such as those for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment.

For measurement purposes, the rate of increase in the per capita cost of the covered health care benefits annual rate was assumed to be 7.00% in both 2024 and 2023. In both 2024 and 2023, the covered health care benefits annual rate was assumed to be decreasing to an ultimate rate of 4.50% over the subsequent ten year period, and to remain at that level thereafter.

For the years ended both December 31, 2024 and 2023, the Plan measured service and interest costs utilizing a single weighted-average discount rate derived from the yield curve used to measure the Plan obligations. The single effective rate used for the December 31, 2024 and 2023 valuation was 5.60% and 5.20%, respectively. The Pri-2012 Blue Collar headcount-weighted mortality tables, with the Scale-SSA 2021 mortality improvement scale was used for both the disabled and healthy

mortality and the Projected Unit Credit funding method was used for both the December 31, 2024 and 2023 valuations.

The weighted average health care cost trend rate assumption has a significant effect on the amounts reported in the accompanying financial statements. If the assumed rates increased by one percentage point at December 31, 2024 and 2023, the accumulated postemployment benefit obligation would increase by \$662,389 and \$1,211,840, respectively.

The Medicare Prescription Drug, Improvement and Modernization Act of 2003 provides for prescription drug benefits under Medicare, as well as a subsidy to employers who sponsor an actuarially equivalent plan. The Plan included funding for benefits of certain retired employees of Olin. The Plan's postemployment benefit obligations and the changes in postemployment benefit obligations are presented net of the Medicare subsidy applicable to these benefits.

These estimates and assumptions are based upon the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of plan benefit obligations.

Claims Payable and Claims Incurred But Not Reported

Plan benefit obligations at December 31, 2024 and 2023 include liabilities for current claims incurred and reported, but have not yet been paid and also for estimated claims incurred by active participants, but not reported at that date, which is based on historical claims data.

Benefit Payments

Benefit payments are recorded when paid.

Receivables and Credit Losses

The Plan evaluates the collectability of receivables based on our current estimate of credit losses expected to be incurred over the life of the receivable. We measure credit losses on uncollected receivables through an allowance for doubtful receivables which is based on a combination of factors including both historical collection experience and reasonable estimates that affect the expected collectability of the receivable. These factors include historical uncollectable experience, industry conditions of the counterparty to the receivable, and general market conditions. The estimation of credit losses is performed on the individual receivable. This estimate is periodically adjusted when we become aware of a specific counterparty's inability to meet its financial obligations. There were no estimated credit losses on outstanding receivables at both December 31, 2024 and 2023.

Prepaid Expenses

The Plan records assets for expenses that have been paid prior to the incurring the underlying expense.

Investment Valuation and Income Recognition

The Plan performs fair value measurements in accordance with Financial Accounting Standards Board Accounting Standards Codification (ASC) 820, *Fair Value Measurement* (ASC 820).

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Plan Transfers

The Plan enters into related party transactions with the Health Plan for Retirees due to the movement of certain employees upon the attainment of age 65 from the Plan to the Health Plan for Retirees. These related party transactions are recorded in the statement of changes in benefit obligations and net assets available for benefits as transfers in from (out to) the the Health Plan for Retirees.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the amounts reported in the statements of benefit obligations and net assets available for benefits.

Users of these financial statements should be aware that the financial markets' volatility may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments as of December 31, 2024 may not necessarily be indicative of amounts that could be realized in a current market exchange.

The actuarial present value of postemployment benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates and employee demographics, all of which are subject to change. In addition, claims incurred but not reported are based on current and prior year claims and are also subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

Contributions

Premiums paid for benefits offered by the Plan vary depending on the type of coverage selected by each individual employee. Olin contributes to the Plan to cover benefit payments. Both participant contributions and Employer contributions are recorded in the statement of changes in benefit obligations and net assets available for benefits.

Pharmacy Rebates

The Plan records rebates from the Plan's pharmacy benefit manager as rebate income. Refunds due at year-end are recorded as a receivable on the statements of changes in benefit obligations and net assets available for benefits, with the offset being recorded as rebate income on the statement of changes in benefit obligations and net assets available for benefits.

Revenue Sharing Arrangements

The Plan has certain revenue sharing arrangements with the Plan's third party administrators. These arrangements provide income to the Plan which can be used to offset Plan administrative expenses. Income received from the Plan's revenue sharing arrangements are recorded as rebate income on the statement of changes in benefit obligations and net assets available for benefits, while receivables for any earned, but unused benefits are recorded as a receivable on the statements of changes in benefit obligations and net assets available for benefits.

Administrative Expenses

Expenses such as trustee, recordkeeping, third party administrator, auditing, legal, and miscellaneous administrative fees are paid directly by the Plan or by Olin and are recorded in the statement of changes in benefit obligations and net assets available for benefits. Certain administrative functions of the Plan are performed by officers or employees of Olin. No such officer or employee receives compensation from the Plan.

Funding Policy

The Plan is funded on an as needed basis from the general assets of Olin, including any benefit obligations in excess of net assets available for benefits.

Reclassifications

The Plan reclassified \$1,845,227 of postemployment benefit obligations currently payable from postemployment benefit obligations, net of postemployment benefit obligations currently payable to conform to the current year presentation for the year ended December 31, 2023. The postemployment benefit obligations, net of postemployment benefit obligations currently payable for current retirees and other participants fully eligible for benefits were reduced by \$1,513,489 and \$331,738, respectively, for the year ended December 31, 2023. This reclassification did not change the excess of benefit obligations over net assets available for benefits for the year ended December 31, 2023.

NOTE 3. PRIOR PERIOD ADJUSTMENT

For the year ended December 31, 2023, an error was identified related to the allocation of investments, at fair value and accrued income to which the Plan did not have proper title, resulting in an overstatement of investments, at fair value, accrued income, and net assets available for benefits. Accordingly, there was an corresponding increase on the excess of benefit obligations over net assets available for benefits for the year ended December 31, 2023.

This change constitutes a change in accounting principle and has been applied retrospectively to the prior period presented. NOTE 6. FAIR VALUE MEASUREMENTS

ASC 820 provides the framework for measuring fair value which includes a hierarchy that prioritizes the inputs and valuation techniques used to measure fair value. The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs were unadjusted, quoted prices in active markets for identical assets or liabilities at the measurement date.

Level 2 – Inputs, other than quoted prices included in Level 1, were either directly or indirectly observable for the asset or liability including quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data, for substantially the full term of the assets or liabilities.

Level 3 – Inputs significant to the valuation model were unobservable and reflected the Plan's best estimate of assumptions to measure the assets or liabilities at fair value.

Fair value measurement levels within the fair value hierarchy are based on the lowest level input that is significant to the fair value measurement in its entirety. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used during the years ended December 31, 2024 and 2023:

- **Money Market Funds:** Money market funds are valued at net asset value (NAV) based on quoted market prices. Investments may be redeemed on a daily basis and it is probable that the Plan will sell the investments for the NAV. There are no redemption restrictions and no significant redemption notice periods applicable to the Plan. There are also no unfunded commitments for these investments.

- Mutual Funds: Mutual funds are valued at quoted market prices. All mutual funds are deemed to be actively traded.

NOTE 7. TAX STATUS

The assets of the Plan are held in a VEBA Trust. The VEBA Trust funding benefits of the Plan received an exemption letter dated October 16, 1980 from the Internal Revenue Service stating that the VEBA Trust is exempt from federal income taxes under section 501(c)(9) of the Code, except for the portion of the trust activity related to the government owned, contractor operated facilities including the Ravenna Army Ammunition Plant, Badger Army Ammunition Plant, and Lake City Army Ammunition Plant, which are subject to unrelated business income tax and certain state taxes which are included in administrative expenses. Although the Plan has been amended since receiving the exemption letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax position taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in process.

NOTE 8. PARTY-IN-INTEREST TRANSACTIONS

The Plan had party-in-interest transactions with the Trustee of \$2,351 for the year ended December 31, 2024 which are included in administrative expenses. The Plan also has receivables from Olin of \$79,500 for expenses which the Plan paid on behalf of Olin. These qualify as allowable party-in-interest transactions.
