### Notes to Financial Statements

#### NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### ***Basis of Accounting***

The accompanying financial statements of Dubois Chemicals, Inc. Retirement Savings Plan (the "Plan") have been prepared on the accrual basis.

##### ***Investment Valuation and Income Recognition***

Investments are reported at fair value except for the fully benefit-responsive investment contract, which is reported at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment securities, in general, are exposed to various risks such as interest rate, credit and overall market volatility risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

##### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

##### ***Related-Party Transactions***

Certain Plan investments are managed by the Voya Institutional Trust Company. Voya Institutional Trust Company is the asset custodian and trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest.

Several employees of DuBois Chemicals, Inc. (the "Company") provide administrative services to the Plan. These services include Plan oversight and day-to-day Plan administration. The Plan is not charged by the Company for the services of the employees to the Plan.

#### NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

##### *Estimates*

The preparation of financial statements in conformity with United States generally accepted accounting principles ("GAAP") requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

##### *Benefit Payments*

Benefit payments are recorded when paid.

##### *Expenses*

Certain expenses of the Plan were paid by the Company and accordingly, are not reflected in the Plan's financial statements. Certain investment related expenses are included in net appreciation in fair value of investments.

##### *Subsequent Events*

The Company has evaluated subsequent events from the balance sheet date of December 31, 2024, through October 14, 2025, which is the date these financial statements were available to be issued.

#### NOTE 2 DESCRIPTION OF THE PLAN

The following description of the Plan provides only general information. Participants should refer to their Plan document for a more complete description of the Plan's provisions.

##### *General*

The original effective date of the Plan was September 26, 2008. The Plan was amended and restated effective November 1, 2022. The Plan is a defined contribution plan. All full-time employees of the Company and its subsidiaries, who are 21 years of age, except part-time and leased employees and certain nonresident aliens who have no earned income from sources within the United States, are able to participate after 90 consecutive days of service. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

##### *Contributions*

A participant may contribute up to 100% of eligible compensation. However, employee contributions may not exceed limitations established under Section 402(g) of the Internal Revenue Code of 1986, as amended, which was \$23,000 at December 31, 2024. Also, for 2024, Section 414(v) of the Internal Revenue Code of 1986, as amended, allowed annual maximum catch-up contribution of \$7,500. Participants are eligible to make pre-tax and Roth after-tax contributions to the Plan. The Plan has an auto enrollment feature for participants who become eligible on or after the effective date. The automatic enrollment is 3% with an automatic escalation of 1% annually until they have reached 6%.

### Notes to Financial Statements (Continued)

#### NOTE 2 DESCRIPTION OF THE PLAN (CONTINUED)

##### *Contributions (Continued)*

The Plan allows for the Company to make employer matching contributions throughout the Plan year and a discretionary profit-sharing contribution at the end of each Plan year. The profit sharing contribution is allocated to participants based on the participant's compensation as a percentage of the total compensation of all participants eligible for the profit sharing contribution. During 2024, the Company made safe harbor matching employer contributions to those employees who elect deferral contributions. The Company contributed 100% of the participant's elective deferral up to 3% of their eligible compensation plus 50% of salary deferrals between 3% and 5% of eligible compensation.

Participants designate the percentage of their deferral and company contributions to be invested in any of the Plan's investment funds or may use self-directed investments. Participants may change the percentage of contributions invested in each account and may make transfers between accounts at any time during the year. A participant may change the amount of his or her elective deferral contributions at any time during the year.

##### *Rollover Contributions*

Participants may rollover their taxable portion of funds previously held for their account in another employee benefit plan to the Plan on a tax-free basis. During 2024, the Plan received \$705,726 in rollover contributions.

##### *Participant Accounts*

Each participant's account is credited with the participant's and Company's contributions and a pro-rata allocation of the Plan's earnings. The pro-rata allocation is based upon the proportion of individual account balances to total participants' account balances in the respective investment funds. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### *Vesting*

Participants become immediately vested at the time of participation in the Plan in their contributions plus actual earnings thereon. The Plan has adopted safe harbor employer match provisions. As a result, participants are immediately vested in employer match contributions. Participants become partially vested in profit sharing contributions after one year of service with 100% vested after five years of credited service. Assets from all merged plans are 100% vested. Forfeited balances of terminated participants' non-vested accounts are applied to offset administrative expenses of the Plan. Forfeitures exceeding these expenses shall be used to reduce employer contributions. During 2024, no forfeitures were used to reduce employer contributions and no forfeitures were used to offset fees. The balance of unallocated forfeitures was \$68,330 and \$54,194 as of December 31, 2024 and 2023, respectively.

#### NOTE 2 DESCRIPTION OF THE PLAN (CONTINUED)

##### *Payment of Benefits*

Upon a participant's retirement, death, total and permanent disability, other termination of employment with the Company or termination of the Plan, the participant's account is distributed by a lump sum distribution.

In-service distributions are permissible from the Plan for participants that have obtained the age of 59 1/2. Rollover balances are also eligible for distribution at any time. Participants electing in-service distributions may elect to receive all or a portion of their vested benefits in a lump sum payment.

In conditions of a financial hardship, as defined, a participant may apply to the Plan administrator for approval to withdraw that portion of his 401(k) deferral account balance necessary to meet the financial hardship, subject to the limitations of the Plan and the Internal Revenue Code.

##### *Notes Receivable from Participants*

Participant loans are available on amounts in the participant's account. The minimum loan amount is \$1,000 and the maximum loan amount is the lesser of one-half of the participant's vested account balance or \$50,000. The vested participant account balance will be used as collateral for any loan. All loans shall bear a reasonable rate of interest as determined by the Plan administrator. All loans must be repaid within five years except in the case of a loan for the purpose of acquiring a home. Participants may only have two loans outstanding at any given time.

#### NOTE 3 TAX STATUS

The Plan Sponsor has adopted a prototype plan which has received an opinion letter from the Internal Revenue Service dated June 30, 2020, which states the provider's prototype, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan itself has not received a determination letter from the Internal Revenue Service. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, therefore, no provision for income taxes has been included in the Plan's financial statements.

#### NOTE 4 FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan entered into a fully benefit-responsive investment contract with Voya. Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Voya is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1.00%. The crediting rate is reviewed at least annually for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) transfers to the fixed account from other plan sources greater than permitted, (2) certain transfers to competing investment options or deletion of equity wash provisions, or (3) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under Employee Retirement Income Security Act of 1974. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

#### NOTE 5 FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs.

The hierarchy is broken down into three levels based on the ability to observe inputs as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Value at the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission ("SEC"). These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-directed brokerage accounts:* Accounts primarily consist of money market funds, mutual funds and common stocks that are valued on the basis of readily determinable market prices.

*Variable annuity contracts:* Valued at the total NAV of the shares held at year end which is based on the fair value of the underlying investments. The Plan's interest in the variable annuity contract is valued based on the information reported by the contract holder.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
