To the Trustees and Participants

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Tigua, Inc. 401(K) Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit needs not to extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. NOTES TO FINANCIAL STATEMENTS

Note 1. Plan Description

The following description of the Tigua, Inc. 401(K) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the plan's provisions.

General: The Plan is sponsored by Tigua, Inc., Tigua Enterprises, Tigua Technologies, Tigua Construction, Tigua Smoke Shop, Inc., and Tigua Facility Services (the Companies). The Plan is a defined contribution plan and was established for the benefit of the employees of the Companies. The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (IRC) and similar state tax laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration of Plan Assets: The Plan is administered by MAP Retirement. The Plan's assets, which consist principally of mutual funds, are held by the Custodian of the Plan, Matrix Trust Company. Contributions are held and managed by the Custodian, which invests cash received, interest, and dividend income and makes distributions to participants.

Eligibility: Full time and part time employees over the age of 18 are eligible to participate in the Plan upon completion of 3 months of service. Employees that are in a collective bargaining agreement (union), non-resident aliens, Service Contract Act employees, leased employees, and reclassified employees are excluded from the Plan. The entry date is immediate upon commencement date or if later, upon satisfaction of eligibility conditions. Full and part time eligible and enrolled employees can receive employer Safe Harbor Matching Contributions.

Contributions: Each year, participants may make contributions up to the maximum percentage allowable by the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may roll over amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of contributions to selected investments as made available and determined by the Plan. Participants may change their investment options any time throughout the year via direct phone or online access.

Employer Contributions: As of January 1, 2024, the Companies currently allow eligible participants to receive a Safe Harbor Matching Contribution equal to 100% of the amount contributed to the Plan for each payroll period up to 3% of Plan Compensation, plus an amount equal to 50% of the amount contributed to the Plan for each payroll period that exceeds 3% of Plan Compensation but does not exceed 5% of Plan Compensation.

Participant Accounts: Each participant's account is credited with the participant's contribution and allocations of (a) the Companies' contribution and (b) plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1. Plan Description (continued)

Vesting: Participants are vested immediately in their contributions plus actual earnings thereon. Additionally, participants are 100 percent vested in Qualified Non-Elective Contributions, Safe Harbor Employer Contributions, and Rollover Contributions. Vesting in the Companies' other employer contribution portion of the accounts is based on years of continuous service. A participant is 100 percent vested after five years of credited service.

Investment Options: Upon enrollment in the Plan, a participant must direct amounts contributed to selected investments as made available and determined by Matrix Trust Company. Participants may change their investment options any time throughout the year.

Payment of Benefits: On termination of service due to death, disability, retirement, or termination for other reasons, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

Contributions Receivable: Contributions from Plan participants and the related matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Forfeited accounts: Forfeited, non-vested account balances at December 31, 2024 totaled to \$0. In 2024, \$42,734 was paid from forfeited accounts to pay employer contributions as stated in the plan document. Accumulated forfeitures will be applied to pay expenses or reduce the employer contribution in 2025.

Note 2. Significant Accounting Policies

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: Mutual Fund Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Funds held in Insurance Companies are reported at contract value, as they meet the fully benefit-responsive investment contract criteria. See Note 3 for discussion of fair value measurements and Note 4 for discussion of investment value measurement for Investment Contracts with an Insurance Company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Note 2. Significant Accounting Policies (continued)

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. The loans are secured by the balance in the participant's account and bear interest at an interest rate equal to the Prime Rate plus 2%. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits: Benefits are recorded when paid.

Subsequent Events: The plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.

Note 3. Fair Value Measurements

FASB ASC 820-10-35, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10-35 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Note 3. Fair Value Measurements (continued)

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4. Investment Contracts with an Insurance Company

The Plan has a benefit-responsive deposit administration contract (DA) with CMFG Life Insurance Company. This is a traditional GIC contract which is guaranteed by CMFG Life Insurance Company. CMFG Life Insurance Company maintains the Plan's deposits in a general account, to which it adds interest at the contract rate. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rates are based on a formula agreed upon with the issuer. Contract value for the guaranteed investment contracts was \$6,223 for December 31, 2024.

Note 5. Administrative Expenses

Certain expenses incurred in connection with the general administration of the Plan are paid by the Plan and are recorded in the accompanying statement of changes in net assets available for benefits as administrative expenses. Certain administrative functions are performed by officers or employees of the Companies. No such officer or employee receives compensation from the Plan. Except for after tax fees, express mail service and loan origination fees associated with notes receivable from participants, administrative expenses of maintaining the Plan are paid by the Companies.

Note 6. Information Certified by Trustee

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the plan's independent auditors not to perform any auditing procedures with respect to the value of mutual fund investments, insurance contract investments, and notes receivables which were \$1,563,889, \$6,223, and \$50,716 as of December 31, 2024 certified by Matrix Trust Company and CMFG Life Insurance Company, except for comparing such information certified by the Trustee to information included in the Plan's financial statements and supplemental schedule.

Matrix Trust Company also certified to the completeness and accuracy of \$4,134 of interest income related to the aforementioned notes receivable for the year ended December 31, 2024, \$60 of interest income related to the aforementioned insurance contract investment, \$327 of interest income related to cash accounts, \$49,415 of dividend income, and a change of \$114,552 in net appreciation in fair value of investments, including gains and losses on investments bought and sold, as well as held during the year.

Note 7. Plan Termination

Although it has not expressed any intent to do so, The Companies have the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts. Any unallocated assets of the plan shall be allocated to participant accounts and distributed in such a manner as the Companies may determine.

Note 8. Tax Status

The IRS has determined and informed the Companies by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable section of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and therefore believes that the plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS.

The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, no uncertain positions are taken or are expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes the Plan is no longer subject to income tax examinations for plan years prior to 2021.

Note 9. Related-Party Transactions

Certain Plan investments are shares of mutual funds managed by Matrix Trust Company. Matrix Trust Company is the custodian as defined by the plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to the custodian amounted to \$18,672 for the year ended December 31, 2024.
