Brewery X 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Brewery X 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for plan benefits for the years then ended and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Brewery X 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 1 to the financial statements, is complete and accurate.

Opinion

NOTES TO THE FINANCIAL STATEMENTS

December 31, 2024

NOTE 1: DESCRIPTION OF THE PLAN

On January 1, 2023, Brewery X, LLC (the "Company") adopted a 401(k) plan known as Brewery X 401(k) Plan (the "Plan"). The following description of the Plan only provides general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

During 2023, the Plan received a transfer of assets totaling \$135,550 from a prior pooled employer plan in which the plan sponsor was a participating employer before adopting their own retirement plan.

General

The Plan is a defined contribution plan covering all eligible employees. Employees are eligible to participate in the plan once they have attained the minimum age of 21 and have met the 12-month service requirement. Eligible employees are automatically enrolled to contribute 6% of their compensation to the Plan, unless they affirmatively elect not to participate within the first 90 days of enrollment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Company and Plan trustee administer the Plan.

Plan Custodian and Recordkeeper

The trustee of the Plan is Matrix Trust Company ("Matrix"). Recordkeeping services are provided by Human Interest, Inc. under an agreement with the Plan. Certain information included in the accompanying financial statements and supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the years then ended, were obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Matrix Trust Company.

Contributions and Funding Policy

Each year, participants may contribute up to 90% of their annual compensation, and up to 50% of compensation for ROTH deferrals, as defined in the Plan, up to the maximum contribution amount permitted under the Internal Revenue Code. The maximum participant elective contribution allowed for the years ended December 31, 2024 and 2023 was \$23,000 and \$22,500, respectively (\$30,500 and \$30,000 for participants age 50 and over, respectively). Participants direct the investment of their contributions into the investment options offered by the Plan. The Plan currently offers mutual funds. The Plan allows participants to roll over eligible amounts to the Plan from other qualified retirement plans.

Employee contributions are matched by Company contributions of 100% of the first 1% plus 50% up to the next 6% of the employees' eligible compensation. During the years ended December 31, 2024 and 2023, the Company made total matching contributions totaling \$166,346 and \$120,826, respectively, to the Plan.

NOTE 1: DESCRIPTION OF THE PLAN (continued)

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of a) the Company's matching contribution and, b) Plan earnings, and charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined.

Vesting

Participant accounts are immediately vested in employee contributions plus earnings thereon. Vesting in the Company's matching contributions is based on a two-year cliff vesting schedule in which participants are vested at 0% after one year of service and 100% after two years of service. A year of service is defined as 1,000 hours worked during the year.

Forfeitures

Forfeitures of non-vested employer contributions may be used to offset administrative expenses, reduce employer contributions, or as a non-elective contribution. During the year ended December 31, 2024, the Plan incurred forfeitures totaling \$25,626, of which \$23,430 was used to offset employer matching contributions. The remaining unapplied forfeitures of \$2,196 are reported as cash in the statement of net assets available for plan benefits to be used in future periods.

Notes Receivable from Participants

Loans to participants are authorized by the administrator and trustees who are responsible for determining the terms and conditions. These loans are available to all participants on a non-discriminatory basis. The minimum amount of any loan is \$1,000 and may not exceed the lesser of 50% of the participants vested account balance as of the date of loan origination, or \$50,000. The loans generally must be repaid through payroll deductions over a period not to exceed five years. The notes are secured by the balance in the participant's account and bear interest at 9.50% during 2024. Interest rates are determined by the Plan administrator based on prevailing market rates. Participant loans in the amount of \$11,599 and \$1,005 at December 31, 2024 and 2023, respectively, are included in the accompanying financial statements under the caption "Notes receivable from participants."

Payment of Benefits

Upon termination of service before the normal retirement age, a participant with benefits over \$5,000 may elect to defer distribution until normal retirement age or receive a lump sum payment equal to the vested share of the participant's account.

In service distributions are permitted by the Plan after age 59 ½. In addition, the Plan allows participants to make early withdrawals for certain financial hardships. Distribution of benefits can also be accessed in the event of disability or death.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual method of accounting. Investments held by a defined contribution plan are required to be reported at fair value.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”) requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Plan investments are included in the accompanying financial statements, which are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Interest earned to date is included in the investment value. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Dividends are recorded at the ex-dividend date.

Notes Receivable from Participants

Notes receivables from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024. If participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments. Administrative and other expenses are recorded as incurred.

Payment of Benefits

Benefits are reported when paid.

NOTE 3: FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1 – Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at measurement date.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly.

Level 3 – Inputs that are unobservable inputs for the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities Exchange Commission. These funds are required to publish their net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The following tables set forth by level, within the fair value hierarchy, the Plan’s assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lower level of any input that is significant to the fair value measurement.

There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

- (a) In accordance with *Subtopic 820-10, Fair Value Measurement, Overall*, certain investments that were measured at NAV per share, using the practical expedient, have not been classified in the fair value hierarchy. The fair value amounts, presented in this table are to permit reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for benefits.

NOTE 4: PLAN TERMINATION

Although the Company has not expressed an intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan.

NOTE 5: TAX STATUS

The Internal Revenue Service has determined and informed the Company, by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

NOTE 6: RELATED PARTY TRANSACTIONS

All Plan investments held at December 31, 2024 and 2023 were managed by Matrix Trust Company and qualify as party-in-interest transactions. Fees paid by the Plan for administrative services totaled \$8,541 and \$2,061 for the years ended December 31, 2024 and 2023, respectively. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Delinquent participant contributions represent non-exempt party-in-interest transactions. During the year ended December 31, 2023, there were delinquent participant contributions of \$2,034 related to the Plan and as a result, lost earnings of \$2 were deposited to the Plan during 2024.

NOTE 7: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 8: DELINQUENT FILING AND DFVC PARTICIPATION

For the plan year ending December 31, 2023, the Form 5500 was not filed by the required deadline. The Plan sponsor voluntarily participated in the Department of Labor's Delinquent Filer Voluntary Compliance Program (DFVC Program) and remitted the applicable reduced penalty in accordance with the program's requirements.

NOTE 9: OPERATIONAL FAILURES CORRECTION

During 2024, the Plan Sponsor and recordkeeper identified an error in the application of vesting provisions that resulted in certain terminated participants receiving distributions in excess of their vested account balances. The error was due to an issue in vesting reporting during the time the distributions were processed. As of the date of this report, the corrective actions for the vesting reporting error were pending completion. Management has represented that it intends to correct the issue in accordance with the IRS Employee Plans Compliance Resolution System ("EPCRS") and applicable DOL guidance. Failure to properly correct these operational errors could, if left unresolved, affect the Plan's continued tax-qualified status under the Internal Revenue Code.

NOTE 10: SUBSEQUENT EVENTS

Subsequent events were evaluated through October 15, 2025, which is the date the financial statements were available to be issued.
