NOTES TO FINANCIAL STATEMENTS AS OF DECEMBER 31, 2024 AND 2023, AND FOR THE YEAR ENDED DECEMBER 31, 2024

1. DESCRIPTION OF THE PLAN

The following description of the MUFG Bank, Ltd. Health Benefit Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the summary plan description for a complete description of the Plan’s provisions.

General—The Plan was established on December 1, 2022, for the purpose of providing medical, dental, vision, and certain long-term disability (LTD) benefits to eligible active employees, disabled participants, retirees, and their eligible dependents and qualified beneficiaries. The participating employers in the Plan include MUFG Bank, Ltd. (MUFG, the “Bank”) and certain MUFG affiliates (collectively, the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration—The Human Capital Management Committee oversees the activities of the Benefit Plans Committee (the “Committee” and the “Plan Administrator”), which oversees the activities of the Plan. The responsibilities of the Committee include interpreting the terms of the Plan, determining eligibility for coverage and benefits under the Plan, preparing investment guidelines, designating investment managers, and monitoring investment and investment manager performance.

Eligibility (Actives)—All full-time or part-time employees who are scheduled to work at least 17 1/2 hours a week are eligible to join the Plan.

Eligible employees may elect to cover their eligible dependents, also included under the provisions of the Plan, generally defined as the participating employee’s spouse, domestic partner, and eligible children. An employee, in addition to covered dependents, who ceases to be a participant in the Plan may be entitled to elect and pay for any optional extension of benefits provided under the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Medical, Dental, and Vision—The claims for self-insured benefits are processed by the Plan’s third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by the 401(h) account (see “401(h) Account” section that follows) or the general assets of the Company. Despite the Plan’s utilization of third-party claims processors, ultimate responsibility for payments to providers and participants is retained by the Plan. The Plan has entered into a stop-loss insurance arrangement to limit its exposure for self-insured benefits (individual participant claims over \$500,000). The Plan also offers medical and dental benefits offered by health and dental maintenance organizations that are fully-insured, and the Plan bears no risk of additional cost.

Contributions (Actives)—Participating employees contribute a set amount throughout the Plan year, generally via semimonthly or biweekly payroll deductions. The Company contributes at a rate that, together with the employee contributions, is sufficient to pay expected claims, premiums, and administrative expenses. The contribution rate is based on levels of coverage and Plan experience and may change in future Plan years.

Contributions (Retirees)—Participating retirees contribute a set amount throughout the Plan year by remitting payment to the Company through a third-party administrator. The Company contributes at a rate that, together with the retiree contributions, is sufficient to pay expected claims, premiums, and administrative expenses. The contribution rate is based on levels of coverage and Plan experience, as well as eligibility thresholds based on factors including a retiree’s age and service at retirement, and may change in future Plan years.

Participants enrolled in the UnitedHealthcare (UHC) high-deductible medical plan option may establish a tax-advantaged savings vehicle known as a health savings account (HSA) to pay for qualified medical expenses that they or their eligible dependents incur. Contributions to the HSA may be made by the participant or the Company. The HSA is owned by the participant and is not part of the Plan. Contributions to HSAs and payments of qualified medical expenses from HSAs are not included in the statement of changes in net assets available for benefits.

The health reimbursement account (HRA) is available to participants as a medical plan option. An HRA is a nominal account attributed to each participant who elects this benefit, per the Internal Revenue Service (IRS). Claims are paid first from the HRA; after the HRA is exhausted, a plan deductible and medical coverage apply. Unused HRA balances may be carried over to subsequent years but are not funded until claims are incurred and presented to the claims administrator for payment. Through December 31, 2023, the HRA benefit was administered under Anthem. Effective January 1, 2024, the HRA transitioned to UHC. As of December 31, 2023, the amount of the unused Anthem HRA totaled \$680,420. As of December 31, 2024, the amount of unused UHC HRA totaled \$758,538.

Long-Term Disability—The MUFG Long Term Disability Benefit Plan is wrapped with the Plan. Effective December 31, 2014, LTD benefits were frozen to new claims, and only eligible employees who became disabled on or before December 31, 2014, continued to receive benefits after December 31, 2014. LTD claims are funded from the general assets of the Bank, with no participant contributions. Effective January 1, 2024 the MUFG Long Term Disability Benefit Plan transferred to another disability plan.

401(h) Account—Certain participants are covered under the MUFG Bank, Ltd. Retirement Plan (the “Retirement Plan”), which includes a medical benefit component in addition to pension benefits. The Retirement Plan funded a portion of the postretirement obligation for retirees, qualified dependents and spouses, and beneficiaries in accordance with Section 401(h) of the Internal Revenue Code (IRC). A separate subaccount was established and is maintained in the Retirement Plan trust for such contributions. In accordance with Section 401(h) of the IRC, the investments in the 401(h) account may not be used for, or diverted to, any purpose other than providing health benefits for retirees and their beneficiaries. The related obligation for health benefits is not included in the Retirement Plan’s accumulated plan benefits obligation but rather is reflected as an obligation in the financial statements of the Plan.

Termination—Although it has not expressed any intent to do so, the Bank has the right to terminate the Plan subject to the provisions of ERISA. In the event of termination, the Company will contribute the necessary amounts to fund all claims incurred prior to the date of termination.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting—The accompanying financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates—The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein; claims incurred but not reported; claims payable; and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties—401(h) assets are invested in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

The Plan's benefit obligations are reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimations and assumptions in the near term could materially affect the financial statements.

Claims Incurred but Not Reported—Plan obligations at December 31 for claims incurred but not reported are estimated by the Plan's actuary in accordance with accepted actuarial principles based on claims data provided by the Plan's third-party claims administrators. These amounts are paid by the Plan only if claims are submitted and approved for payment.

Claims Paid—Claim payments are recorded when paid by the third-party claims processor. Amounts due to claims processors that have been approved but not reimbursed by the Plan are recorded as payable to claims administrators in the accompanying statements of net assets available for benefits.

Investment Valuation and Income Recognition—401(h) investments are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Administrative Expenses—Direct health and welfare benefits administration expenses paid to third-party administrators and trustee fees are considered Plan expenses. Other administrative expenses, including audit and tax preparation fees, are paid by the Company on behalf of the Plan.

Postretirement Benefits—The postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed by terms of the Plan to employee service rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from current Plan participants. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired employees and their beneficiaries and dependents and (2) active employees and their beneficiaries and dependents after retirement from service with the Bank. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service rendered to the valuation date. The postretirement benefit obligation represents the amount that is to be funded by contributions from the Bank and existing Plan assets.

The actuarial present value of the expected postretirement benefit obligation is determined by the Plan’s actuary and is the amount that results from applying actuarial assumptions to historical claims cost data to estimate future annual incurred claims costs per participant; to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements, such as for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment; and to reflect the portion of those costs expected to be borne by Medicare, the retired participants, and other providers.

Postemployment Benefits—Plan obligations as of December 31, 2023 for future disability payments to participants entitled to legacy LTD benefits are estimated by the Plan’s actuary in accordance with accepted actuarial principles. Such estimated amounts are reported in the accompanying statements of Plan’s benefit obligations at present value. Effective January 1, 2024, the Plan transferred the LTD obligations to a separate disability plan.

Stop Loss—Premiums for stop loss insurance are included in premium payments in the accompanying statement of changes in net assets available for benefits. No stop loss refunds were received in 2024.

Refunds—Pharmacy rebates and performance guarantees are recorded when received. Rebates totaling \$5,676,133.92 have been netted with claims paid in the accompanying statement of changes in net assets available for benefits. Due to the change in medical claims administrator effective January 1, 2024, medical claim rebates received in 2024 of \$4,040,905 are reflected as a receivable as of December 31, 2023. There are no refunds receivable as of December 31, 2024.

Deposit With Third-Party Claims Processor—Effective January 1, 2024, a third-party claims processor requires an advance deposit from the Plan to be applied against future claims paid on behalf of plan participants. Such deposit is reported as a plan asset until the deposit is applied against paid claims.

Subsequent Events—Subsequent events were evaluated through October 15, 2025, the date the financial statements were available to be issued.

3. ACTUARIAL PRESENT VALUE OF BENEFIT OBLIGATIONS

The weighted-average health care cost trend rate assumption has a significant effect on the amounts reported in the accompanying financial statements. If the assumed rates increased by one percentage point in each year, the obligation would increase as of December 31, 2024 and 2023, by \$2,450,027 and \$3,812,556 respectively.

The foregoing actuarial assumptions are based upon the presumption that the Plan continues indefinitely. If the Plan were to be terminated, different actuarial assumptions and other factors would be applicable in determining the actuarial present value of postretirement and postemployment benefit obligations. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that certain changes in these estimates and assumptions could be material to the financial statements.

4. FEDERAL INCOME TAX STATUS

The Plan Administrator and the Plan's tax counsel believe that the Plan is designed and operated in compliance with the applicable requirements of the IRC. Accordingly, no provision for income taxes has been included in the financial statements.

5. 401(H) ACCOUNT

A portion of the Plan's obligations is funded through contributions to the Retirement Plan in accordance with IRC Section 401(h). In the financial statements of the Plan and the Retiree HRA Plan, the 401(h) account is allocated to each plan pro rata based on the plans' respective share of the combined benefit obligation as determined by the plans' actuary in their actuarial report.
