Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) Audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

Management has obtained certifications from ADP Retirement Trust Services LLC as of December 31, 2024 and for the period of May 1, 2024 to December 31, 2024, and Nationwide Trust Company, FSB as of and for the year ended December 31, 2023 and the period from January 1, 2024 to April 30, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- the information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period-of-time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) Audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

### NOTE 1 – DESCRIPTION OF PLAN

#### General

The Cub Crafters, Inc. Profit Sharing Plan (the Plan) was established for the benefit of the employees of Cub Crafters, Inc. (the Company). The Company acts as the Plan Sponsor and Trustee. Participants should refer to the Plan Document for a more complete description of the Plan.

The Plan is a defined contribution plan covering all employees of the Company who have six months of service or 500 hours of service, whichever comes first, and have attained age eighteen. Employees elect to participate in the salary deferral program. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### Contributions

Participants may defer 100% of eligible compensation to the Plan, either in pre-tax contributions or after-tax Roth contributions, to the allowable limit under the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also rollover funds from other qualified plans.

The Plan provides for a Company safe harbor match to those participants who have met the eligibility requirements. The safe harbor match is an amount equal to 100% of the first 4% of the participant's deferred salary contributions.

The Plan also provides for Company discretionary matching and profit-sharing contributions to those participants who have met eligibility requirements. There were no such contributions for the years ended December 31, 2024 and 2023, respectively.

#### Participant Accounts

Each participant's account is credited with the participant and sponsor contributions, account earnings, gains and/or losses, and their portion of Plan expenses. Employees direct their accounts to be invested in a combination of available funds.

Participants vest in elective contributions and safe harbor contributions immediately.

#### Notes Receivable from Participants

Participants are allowed to obtain loans from the Plan for 50% of their vested interest in the Plan up to a maximum of \$50,000. The loans are secured by the balance in the participant's account. The loans are repaid over a term not to exceed five years (15 years for qualified home loans). The interest rate approximates market at the time of the loan. Principal and interest is paid ratably through periodic payroll deductions.

### NOTE 1 – DESCRIPTION OF PLAN – CONTINUED

#### Forfeitures

Non-vested portions of participant accounts, if any, are available for Plan expenses or to reduce employer contributions. Forfeitures were not significant as of and for the years ending December 31, 2024 and 2023, respectively.

#### Benefits

Upon termination of service, participants may receive their account balance in the form of a lump sum distribution or roll over into another qualified plan. Participants may also receive a lump sum amount upon demonstration of a financial hardship, which amounts are available from all sources of their participant account. The Plan may elect to make a mandatory distribution or a direct rollover into an IRA selected by the Plan administrator for those terminated participants with vested balances of \$5,000 or less.

### NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Accounting

The Plan's financial statements are prepared on an accrual basis.

#### Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

Investments are stated at fair market value. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Notes Receivable from Participants

Notes receivable from participants are valued at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. Delinquent notes receivable from participants are recorded as distributions on the basis of the terms of the Plan agreement.

#### Payment of Benefits

Benefit payments are recorded when paid.

### NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES – CONTINUED

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in the net appreciation (depreciation) of the fair value of investments.

#### Fair Value Measurements

Accounting principles generally accepted in the United States of America (GAAP) establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under GAAP are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the investment entity has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full-term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

#### Subsequent Events

The Plan has evaluated all events occurring subsequent to December 31, 2024 and through October 15, 2025, which is the date that the financial statements were issued, and does not believe that any events occurring during this period require either recognition or disclosure in the accompanying financial statements.

Financial information relating to Plan investments at December 31, 2024, as well as investment income, realized and unrealized gains (losses) on investments and investment transactions, has been certified as complete and accurate by Nationwide Trust Company, FSB as of and for the year ended December 31, 2024 and for the period from January 1, 2024 to April 30, 2024. Therefore, in accordance with the request of the Plan administrator, and as allowed under 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, this information was not subject to auditing procedures generally accepted in the United States of America by the Plan's independent public accountants.

### **NOTE 5 – PLAN TAX STATUS**

The Plan operates on a volume submitter document, and obtained its latest opinion letter on December 31, 2018, which stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Plan administration believes there are no uncertain tax positions related to Plan activities.

### **NOTE 6 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds Nationwide, who is the custodian as defined by the Plan and therefore, these transactions qualify as party-in-interest transactions. Transactions related to the notes receivable from participants also qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in the net appreciation of the fair value of investments. During 2024 and 2023, the Company paid certain administrative and other operating expenses of the Plan.

### **NOTE 7 – AMOUNTS DUE TO TERMINATED PARTICIPANTS**

Plan assets due to participants who have terminated employment were \$849,131 and \$997,108 as of December 31, 2024 and 2023, respectively. These participants are no longer eligible to benefit from employer contributions pertaining to periods subsequent to termination.

### **NOTE 8 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the sponsor has the right to terminate the Plan subject to the provisions of ERISA.
