NOTE 1 - DESCRIPTION OF PLAN

The following description of the Trulite Glass & Aluminum Solutions, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document, copies of which are available from the plan administrator, for more complete description of the Plan's provisions.

General: This Plan is a defined contribution plan established in 1985, covering substantially all employees except for reclassified employees of Trulite Glass & Aluminum Solutions, LLC (the Company). Employees are eligible upon hire and may enter the Plan monthly with deferral elections taking effect on the first day of the following month. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Retirement Plan Committee is responsible for oversight of the Plan and for determining the appropriateness of the Plan's investment offerings and monitoring of investment performance.

The Plan was restated on July 1, 2022.

The Plan changed service providers and qualified institutions from Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company to Charles Schwab Trust Bank in December 2023. A majority of the Plan assets were liquidated by Principal on December 29, 2023, and were in transit to Schwab and held in a noninterest bearing cash account. These assets were allocated to participant accounts with Schwab in January 2024.

Contributions: Plan participants may make pre-tax and/or Roth contributions of up to 100% of eligible compensation, as defined in the Plan document, not to exceed a maximum of \$23,000 in 2024, plus up to an additional \$7,500 catch-up deferral for participants who have reached at least 50 years of age by the end of the year. Employees are automatically enrolled at a pre-tax 3% deferral rate upon becoming eligible to participate in the Plan and they may elect to change or discontinue deferrals at any time. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Company makes matching contributions in an amount equal to 50% of the first 3% of eligible compensation and 25% of the next 3% of eligible compensation that a participant contributes to the Plan. The Company may, at its discretion, make additional discretionary or qualified non-elective contributions to the Plan on an annual basis. There were no discretionary or qualified non-elective contributions for the year ending December 31, 2024.

Participant Accounts: Each participant's account is credited with the participant's contributions, rollovers, Company contributions, and earnings or losses on the investments in their account and is charged with certain transaction fees. Upon enrollment in the Plan, a participant may direct contributions to any of the investment options offered by the Plan. Participants may change their investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Retirement, Death and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death or disability.

Vesting: Participants are immediately vested in their contributions and Company qualified non-elective contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contributions is based on years of service. Participants are fully vested after the completion of one year of service.

NOTE 1 - DESCRIPTION OF PLAN (Continued)

Payment of Benefits: At the time of death, disability, termination of service, or retirement, the participant or their beneficiary may elect to receive payment of the vested interest in their account in a lump-sum distribution, installment payments, or annuity payments. The participant's contributions may also be withdrawn in certain hardship situations. After attaining the age of 59½, participants may also be eligible to make a withdrawal of all or part of their vested account. If a participant terminates employment and has an account balance less than \$7,000, the participant will automatically receive a lump-sum payment equal to the value of their account.

Notes Receivable from Participants: Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested balance of their account. A participant may have one note outstanding at a time. The notes are secured by the balance in the participant's account and bear a fixed rate of interest. During 2024, notes had fixed rates of interest ranging from 4.25% to 9.50% for the term of the note, not to exceed 5 years unless used to for the purchase of a participant's principal residence. Principal and interest are paid through payroll deductions.

Notes become due and payable immediately when a participant terminates employment with the Company.

Forfeitures: At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$12,840 and \$5,006, respectively. Forfeitures are used to pay the administrative expenses of the Plan or reduce future Company contributions. In 2024, \$15,666 of forfeitures were used to reduce Company contributions.

Administrative Expenses: Certain administrative expenses are permitted to be paid by the Plan in accordance with the Plan's provisions. Loan origination fees and certain transaction fees for withdrawals are charged directly to the respective participants' accounts. These expenses are paid to service providers of the Plan and therefore qualify as party-in-interest transactions. Certain expenses incidental to the administration of the Plan are paid by the Company. The Company does not expect reimbursement from the Plan for any expenses paid on behalf of the Plan.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are presented on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Contributions: Participant contributions are recognized when withheld. Employer matching contributions are recognized concurrently with participant contributions.

Valuation of Investments and Income Recognition: The Plan's investments are stated at fair value, except for the guaranteed interest account, which is stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

The net change in fair value and contract value of investments includes interest, dividends, realized and unrealized gains and losses on those investments. Interest income is recorded when received.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES (Continued)

Notes Receivable from Participants: Notes receivable from participants are carried at their outstanding balance. Interest income is recognized when received. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make note repayments and the plan administrator deems the participant note to be in default, the participant note balance is reduced and a benefit payment is recorded. Notes receivable from participants qualify as party-in-interest transactions.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Subsequent Events: Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 15, 2025, which is the date the financial statements were available to be issued.

NOTE 3 - CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank (the trustee of the Plan for the year ended December 31, 2024).

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at December 31, 2023 was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (the trustee of the Plan as of December 31, 2023).

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan’s own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective trust funds: The fair values of participation units held in collective trusts are based on the net asset values per unit as reported by the fund managers. The collective trusts provide for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

As of December 31, 2023, the Plan held a fully benefit-responsive investment contract that was reported at contract value, which is generally the amount a participant would receive if he or she would initiate a withdrawal or transfer from the contract under the provisions of the Plan. The contract value represents contributions made to the contract, plus earnings, less participant withdrawals and administrative expenses.

The Plan's fully benefit-responsive investment contract was with Principal Life Insurance Company ("Principal Life"; Issuer). Principal Life maintained the contributions in its general account. The Issuer guaranteed the Plan a return of principal and interest under the terms of the contract. The interest crediting rate was updated quarterly based upon contract provisions, and could not be less than 1.85%. Principal Life's general account was credited with earnings on the underlying investments and was charged for participant withdrawals and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

During the year ended December 31, 2024, the fully benefit-responsive investment contract with Principal was terminated.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, all participants would become fully vested in their account balances.

NOTE 7 – RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company.

Fees paid by the Plan to Charles Schwab Trust Bank for trustee services are considered party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.

NOTE 8 - INCOME TAX STATUS

The Plan is operating under a Non-Standardized Pre-Approved Profit Sharing Plan with CODA plan document created by Principal Life Insurance Company (Principal Life). The Internal Revenue Service has determined and informed Principal Life by a letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has not obtained an individual determination letter and has been amended since receiving the Principal Life opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

The Plan administrator evaluated the Plan's tax positions and concluded that there are no uncertain tax positions that require recognition or disclosure in the financial statements as of December 31, 2024 and 2023. The Plan is no longer subject to income tax examinations by tax authorities for years before 2021.

NOTE 9 – TRANSFER FROM OTHER PLAN

Subsequent to the Company's acquisition of American Insulated Glass, the American Insulated Glass 401(k) Plan (AIG Plan) was merged into the Plan effective December 31, 2024. The net assets of the AIG Plan of \$7,630,469 were transferred into the Plan and are reflected as in "transfer from other plan" on the statement of changes in net assets available for benefits for the year ended December 31, 2024.
