The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the statements of benefit obligations as of December 31, 2024 and 2023 and the related statement of changes in benefit obligations for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information

prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Merger

As discussed in Note 1 to the financial statements, effective December 31, 2024 (the Merger Date), the Plan merged out of existence. The assets and liabilities of the Plan were transferred into Dominion Energy Retiree Health & Welfare Plan as of the Merger Date. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter — Supplemental Schedule Required by ERISA

The supplemental schedule of reportable transactions for the year ended December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its

form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTES TO FINANCIAL STATEMENTS

AS OF DECEMBER 31, 2024 AND 2023 AND FOR THE YEAR ENDED DECEMBER 31, 2024

1. DESCRIPTION OF THE PLAN

The following description of the Dominion Energy Ohio Union Retiree Health & Welfare Plan (the Plan) is provided for general information purposes only. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

- a. **General**—The Plan is a defined benefit health and welfare plan that provides medical and life insurance benefits. In addition, for certain retirees who retired on or after January 1, 2016, the Plan is a defined contribution health and welfare plan for post-64 medical benefits. Certain former employees of the East Ohio Gas Company (the Company) who are union eligible employees and who retired or will retire in accordance with the retirement regulations, and their dependents, as defined in the Plan, are eligible for coverage under the Plan. Dominion Energy, Inc. (Dominion Energy) is the designated plan sponsor. The plan administrator is Dominion Energy Services, Inc. (DES), a subsidiary of Dominion Energy. The Bank of New York Mellon Trust Company, N.A. (Bank of New York Mellon) is trustee of the plan effective January 1, 2024. Prior to that date, the Northern Trust Company (Northern Trust) served as the trustee of the Plan. The Plan is subject to the provisions set forth in the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Effective July 1, 2022, the Plan was amended to allow employees eligible for coverage to defer commencement of retiree medical benefits when they separate from the Company. Any employee who defers can later commence the retiree medical benefits available under the then-applicable terms of Plan.

During 2024, Dominion Energy completed the sale of certain natural gas distribution utilities to Enbridge, Inc. Upon closing, the natural gas distribution utilities ceased to be participating employers in the Plan, which continues to be sponsored by Dominion Energy. All affected participants have been fully vested in their accrued benefits under the Plan upon the closing of the sale. Enbridge assumed a pro rata share of the Plan assets which reduced the Plan assets and actuarial present value of total plan obligations by \$28,696,662 and \$15,278,812, respectively.

Effective December 31, 2024, the Plan merged into Dominion Energy Retiree Health & Welfare Plan (the Dominion Energy Plan). As a result, net assets available for benefits and total benefit obligations of \$137,851,105 and \$66,259,818, respectively, were transferred into the Plan. This merger did not affect the participants' health and welfare benefits because the benefit provisions of the Plan were incorporated into the Dominion Energy Plan.

- b. **Benefits**—The Plan currently provides life, survivor life and comprehensive medical benefits for participants not yet eligible for Medicare and comprehensive medical benefits with a Medicare carve-out or a Medicare supplement for Medicare eligible participants. Retired employees may receive comprehensive medical coverage if the employee has ten years of pension service immediately preceding his or her retirement date on or after the attainment of age 55. Similarly, all employees, except those employees hired on or after January 1, 2007, with at least ten years of pension service at the time of retirement on or after the attainment of age 55 are eligible for life insurance after retirement. The only choice available to an individual, who retires after January 1, 2002 and prior to January 1, 2016 and lives in an area where a Medicare Health Maintenance

Organization (Medicare HMO) is available, is a Medicare HMO upon becoming Medicare eligible. Deductibles, lifetime maximums, out-of-pocket maximums and participant contributions, which are subject to change from time to time, vary based on age and retirement date. The Plan also includes prescription drug coverage and a maintenance drug program. The benefits of the Plan are self-insured, with the exception of Medicare HMO, and life and survivor life insurance which are fully-insured.

Eligible retirees who retired prior to January 1, 2002 can elect to participate in a Medicare HMO, if available in the area where the retiree resides. In addition, retirees can elect to receive medical coverage from selected Managed Care providers, if available in the area where they reside. Refer to the Plan document and collective bargaining agreements for additional information.

Effective January 1, 2016, Utility Workers Union of America (UWUA) Local G555 employees retiring on or after that date are eligible to elect medical coverage through a healthcare exchange for post-64 medical coverage. The Company provides these retirees and their covered spouses who enroll in coverage with an annual Health Reimbursement Account (HRA) stipend that varies based on service. Pre-65 coverage continues under the current provisions of the Plan. The amount allocated to a participant's HRA is set forth in the Plan document. HRA contributions can be used to offset an individual's premiums for medical (including Medicare Part B), prescription drug, dental or vision insurance and out-of-pocket eligible medical expenses, except prescription drugs. Any unused HRA balances are carried over to subsequent years, but are not funded until claims are incurred and presented to the HRA administrator for payment. The estimated obligation for the HRA feature is included in the postretirement benefit obligations. In addition, the Company will provide an annual HRA stipend to employees who retire between June 16, 2022 and June 15, 2027 and have not yet attained age 65. The stipend for these retirees varies based on age and continues until the attainment of age 65 or five years, whichever occurs first. As of December 31, 2023 interest-bearing cash of \$105,743 was held in an HRA cash account (HRA cash account).

In June 2018, the Plan's eligibility requirements were amended as a result of a new collective bargaining agreement between the Company and UWUA Local G555. UWUA Local G555 employees hired on or after January 1, 2019 are not eligible to participate in the Plan. In addition, the eligibility requirements changed from age 55 with ten years of service to age 58 with ten years of service, effective January 1, 2022.

- c. **Contributions**—The costs of the postretirement benefit obligation are shared by the Company and retiree participants. Contributions are made by the Company in amounts determined by DES to make payments when due. Contributions are made by the participants ranging from zero to a substantial portion of participants' benefit costs pursuant to the collective bargaining agreement between the Company and the union in effect at the time of the participant's retirement. Refer to the Plan document and collective bargaining agreements for additional information.
- d. **Funding Policy**—Medical claims are paid by retirees, the Company the Plan through a Voluntary Employees Beneficiary Association (VEBA) trust. Certain retirees contribute a portion of the cost of providing medical coverage for themselves and their dependents.

Life and survivor life benefits are funded through life insurance. The portion funded by insurance premiums is paid by retirees and the VEBA trust. Medicare HMO premiums are funded by retirees.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

- a. **Basis of Accounting**—The accompanying financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

- b. **Use of Estimates**—The preparation of financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and if any, claims payable and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
- c. **Risks and Uncertainties**—The Plan utilizes various investment instruments as more fully described in Note 3. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk and overall market volatility. Market volatility includes global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.
- d. **Claims Incurred But Not Reported**—The Plan’s liability for incurred but not reported claims is estimated using actuarial methods that utilize historical trend information. The actuarial methodology projects historical monthly incurred claims to the most recent period using an appropriate trend, adjustments for changes in participant count and any benefit design changes that occur during each successive year. Claims incurred but not reported are presented in the Statements of Benefit Obligations.
- e. **Payments for Benefits**—Life and survivor life insurance premiums, Medicare HMO premiums, participant claims and HRA health reimbursements paid by either retirees, the Company or the VEBA trust are recorded in the accompanying Statement of Changes in Net Assets Available for Benefits upon distribution. Claims and premium amounts billed by third party administrators which have not been paid, if any, by either the Company or the VEBA trust are recorded as claims and premiums payables in the accompanying Statements of Benefit Obligations.
- f. **Rebates**—Rebates due from the third-party administrators are recorded when earned. Any rebates due as of the financial statement date are reported as a receivable, with the offset being netted against claims paid. Pharmacy rebates totaling \$2,600,273 have been netted with claims paid in the accompanying Statement of Changes in Net Assets Available for Benefits.
- g. **Valuation of Investments**—All investments are at fair value. See Note 3 for further information on fair value measurements.

In the Statement of Changes in Net Assets Available for Benefits, the Plan presents the net appreciation in the fair value of its investments, which consists of the realized gains or losses on investments sold during the year and the unrealized appreciation (depreciation) of investments held at the reporting date.

- i. **Administrative Expenses**—Expenses incurred directly in the administration of the Plan are paid by the Plan. Investment-related expenses are included in net appreciation in fair value of investments. Administrative expenses also include payment of unrelated business income tax (UBIT), net of rebates.
- j. **Postretirement Benefits**—The postretirement benefit obligation at December 31, 2023 represents the actuarial present value of those estimated future benefits that are attributed by the terms of the Plan to employee service rendered through December 31, 2023 reduced by the actuarial present value of

contributions expected to be received in the future from current plan participants. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired employees and their beneficiaries and dependents; and (2) active employees and their beneficiaries and dependents after retirement from service with the Company. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributable to that employee's service rendered to the valuation date. The postretirement benefit obligation represents the amount that is to be funded by contributions from the plan sponsor and existing Plan assets.

The actuarial present value of the expected postretirement benefit obligation is determined by the Plan's independent actuary and is the amount that results from applying actuarial assumptions to historical claims cost data to estimate future annual incurred claims cost per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment, and to reflect the portion of those costs expected to be borne by Medicare, the retired participants and other providers.

The foregoing actuarial assumptions are based on the presumption that the Plan will continue. If the Plan were to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of postretirement benefit obligations. Due to uncertainties inherent in the estimations and assumptions process, it is reasonably possible that certain changes in these estimates and assumptions could be material to the financial statements.

The weighted-average health care cost-trend rate assumption has a significant effect on the amounts reported in the accompanying financial statements. If the assumed rate increased by one percentage point in each year, it would increase the obligation as of December 31, 2023 by \$6,343,000.

3. FAIR VALUE MEASUREMENTS

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability (exit price) in an orderly transaction between market participants at the measurement date. Fair values are based on assumptions that market participants would use when pricing an asset or liability, including assumptions about risk and the risks inherent in valuation techniques and the inputs to valuations. Fair value measurements assume that the transaction occurs in the principal market for the asset or liability (the market with the most

volume and activity for the asset or liability from the perspective of the reporting entity), or in the absence of a principal market, the most advantageous market for the asset or liability (the market in which the reporting entity would be able to maximize the amount received or minimize the amount paid). The Plan applies fair value measurements to the Plan's investments in accordance with the requirements described below.

Inputs and Assumptions

The Plan maximizes the use of observable inputs and minimizes the use of unobservable inputs when measuring the fair value of its investments. Fair value is based on quoted market prices, if available. In the absence of quoted market prices, the Plan seeks price information from external sources, including broker quotes. When evaluating pricing information provided by brokers, the Plan considers whether the broker is willing and able to trade at the quoted price, if the broker quotes are based on an active market or an inactive market and the extent to which brokers are utilizing a particular model if pricing is not readily available. If pricing information from external sources is not available, or if the Plan believes that observable pricing is not indicative of fair value, judgment is required to develop the estimates of fair value. In those cases, the Plan must estimate prices based on available historical and near-term future price information and certain statistical methods that reflect market assumptions.

The inputs and assumptions used in measuring fair value for investments include the following:

- Quoted securities prices and indices
- Securities trading information including volume and restrictions
- Maturity
- Interest rates
- Credit quality

The Plan regularly evaluates and validates the inputs used to estimate fair value by a number of methods, including review and verification of models, as well as various market price verification procedures such as the use of multiple broker quotes to support the market price of the various investments in which the Plan transacts.

The fair values of the Plan's investments are determined as follows:

- *Cash and Cash Equivalents*—Investment is held primarily in interest-bearing cash which is valued at cost plus accrued interest. Interest bearing cash is classified as Level 1. Cash and cash equivalents held in a variation margin account, are less liquid and therefore have been classified as Level 2.
- *Common Stocks*—Investments are valued at the closing price reported on the active market on which the individual securities are traded.
- *Registered Investment Company*—Investment is valued at the daily closing price as reported by the fund. This fund is required to publish its daily net asset value (NAV) and transact at that price. The fund held by the Plan is deemed to be actively traded.
- *Common/Collective Trust Funds*—Investments in common/collective trust funds are stated at the NAV as determined by the issuer of the common/collective trust funds and is based on the fair value of the underlying investments held by the fund less its liabilities. The NAV is used as a practical expedient to estimate fair value. The common/collective trust funds do not have any unfunded commitments, and do not have any applicable liquidation periods or defined terms/periods to be held. The majority of the

common/collective trust funds have limited withdrawal or redemption restrictions during the term of the investment.

- *Alternative Investments*—Investments in real estate funds and private equity funds are stated at fair value based on the NAV of the Plan’s proportionate share of the funds’ fair value as determined by reference to audited financial statements or NAV statements provided by the investment manager. The NAV is used as a practical expedient to estimate fair value.

In connection with alternative investments held by the Plan, the Plan (as a limited partner) makes capital commitments that are called over time as the general partner makes investments. Investment strategies of the alternative investments are real estate and private equity-based. The typical term of these investments is 10-13 years. The Plan has limited withdrawal or redemption rights during the term of the investment. As a general rule, a limited partner’s interest can be sold in the secondary markets subject to the approval of the general partner. The secondary market tends to be illiquid especially during periods of market stress. Funds returned to the Plan as income, profits and capital are distributed over the term of the investment.

Levels

The Plan utilizes the following fair value hierarchy, which prioritizes the inputs to valuation techniques used to measure fair value into three broad levels:

- *Level 1*—Quoted prices (unadjusted) in active markets for identical assets that the Plan has the ability to access at the measurement date. This primarily includes exchange-listed securities.
- *Level 2*—Inputs other than quoted prices included within Level 1 that are either directly or indirectly observable for the asset, including quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets in inactive markets, inputs other than quoted prices that are observable for the asset, and inputs that are derived from observable market data by correlation or other means. This primarily includes certain Treasury securities, certain common and preferred stock and corporate, state and municipal debt instruments.
- *Level 3*—Unobservable inputs for the asset, including situations where there is little, if any, market activity for the asset.

The fair value hierarchy gives the highest priority to quoted prices in active markets (Level 1) and the lowest priority to unobservable data (Level 3). In some cases, the inputs used to measure fair value might fall in different levels of the fair value hierarchy. In these cases, the lowest level input that is significant to a fair value measurement in its entirety determines the applicable level in the fair value hierarchy. Assessing the

significance of a particular input to the fair value measurement in its entirety requires judgment, considering factors specific to the asset.

5. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

During 2024 and 2023, the Plan invested in shares of common/collective trust funds administered by the trustees, as defined by the Plan, and therefore, related transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services are included as a reduction of the return earned on each common/collective trust fund in the net appreciation in fair value of investments.

The plan sponsor pays benefit payments and administrative expenses incurred on behalf of the Plan, the Plan reimburses the plan sponsor for the benefit payments and administrative expenses made for the Plan. The VEBA trust generally reimburses the Company in the subsequent month for benefit payments and administrative expenses paid by Company on behalf of the Plan. The Statement of Changes in Net Assets Available for Benefits, includes \$3,729,162 of benefit payments and administrative expenses reimbursed to the Company by the Plan. During 2024, the Plan paid \$26,139, to DES, the plan administrator, for costs associated with administration of the Plan.

6. FEDERAL INCOME TAX STATUS

The VEBA trust has obtained a determination letter from the IRS dated February 25, 1997, in which the IRS determined that the VEBA trust, at the time of the determination letter application, was designed in accordance with Section 501(c)(9) of the Internal Revenue Code (IRC) and therefore is exempt from federal income taxes under IRC Section 501(a). While some of the income from the VEBA trust is considered exempt function income and therefore is exempt from income taxes, certain investments of the VEBA trust do generate income, as defined in IRC Section 512, that is subject to UBIT at a maximum rate of 37%.

The Plan has been amended since the VEBA trust received the determination letter, however, the Company believes that the Plan and related trust, as amended, are currently designed and operated in compliance with the applicable requirements of the IRC and continue to be tax-exempt.
