Opinion

We have audited the accompanying financial statements of the San Francisco Police Officers' Association Legal Defense Fund (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits and of benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the years then ended, and the related notes to the financial statements.

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the San Francisco Police Officers' Association Legal Defense Fund (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

A. General

The Plan is a group pre-paid legal service plan that was established on January 1, 2009 by the San Francisco Police Officers' Association (the "Association") to provide benefits to eligible members of the Association. Substantially all active, dues paying members of the Association are eligible to participate. The plan administrator believes the Plan is designed and operated in compliance with the applicable requirements of the Internal Revenue Code (the "Code") and provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

B. Administration

The Association's officers serve as trustees to manage the operation and administration of the Plan. The trustees designated Wells Fargo Bank to hold Plan assets in a non-interest bearing cash account.

C. Contributions

Contributions to the Plan are paid through payroll deductions of participants at a rate determined by the Board of Trustees. The required contribution rate is subject to change as may be deemed necessary by the Board of Trustees. Since Plan inception, the rate is \$3 per member per payroll period. Contributions paid through member payroll deductions totaled \$137,192 and \$140,194 for the years ended December 31, 2024 and 2023, respectively.

The Association may make additional contributions as deemed necessary by the Board of Trustees to meet Plan obligations. For the years ended December 31, 2024 and 2023, the Association contributed \$170,050 and \$250,000, respectively, to the Plan.

D. Eligibility

Participants are entitled to benefits under the Plan for certain acts or omissions which occur while members are on duty in the employment of the San Francisco Police Department (the "SFPD") and which have been approved for payment by the Board of Trustees. Any active Association member employed by the SFPD is entitled to benefits. Former and retired members of the Association are not entitled to benefits except for claims incurred prior to termination of employment with the SFPD and prior to termination of Association membership.

E. Payment of Benefits

Benefits consist of legal representation in civil, criminal and departmental actions. Benefits are recorded when paid.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

C. Expenses

Expenses may be paid by the Association or the Plan, at the discretion of the Board of Trustees.

NOTE 3 - INCOME TAX STATUS

The Plan received an exemption letter from the Internal Revenue Service stating that the Plan satisfies the requirement of Section 501(c)(9) of the Internal Revenue Code and from the state of California under Revenue and Taxation Code Section 23071(i). The Association believes that the Plan is operated in accordance with, and qualifies under, the applicable requirements of the Code and related state statutes, and that the trust, which forms a part of the Plan, is exempt from federal income and state franchise taxes.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Association has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, after paying expenses, any and all monies may be used to continue paying benefits until such monies have been exhausted or transferred to another trust or non-profit entity which provides similar benefits, or used as directed by the Board of Trustees.

NOTE 5 - BENEFIT OBLIGATIONS

The Plan's benefit obligations include estimated legal benefits for incidents which occurred prior to the Plan year end and have been approved for benefit coverage by the Board of Trustees. Legal benefits incurred but not paid through the Plan year end and estimated future legal benefits through the closure of the cases are included in the benefit obligations. These amounts have been estimated based on management's knowledge of the cases and historical costs paid by the Plan for similar cases.
