Independent Auditor's Report

Opinion

We have audited the accompanying financial statements of the Columbus Police Sub-Relief Fund (the Fund), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Fund as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America (GAAP).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Fund Description

The following description of Columbus Police Sub-Relief Fund (the Fund) provides only general information. Participants should refer to the fund agreement for a more complete description of the Fund's provisions.

General

The Fund was incorporated on September 21, 1977 for the purpose of providing aid to the families of deceased police officers, primarily through the payment of a death benefit. Any active or retired sworn personnel employed or formerly employed by the Division of Police, City of Columbus, Ohio are eligible for membership in the Fund. The Fund is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions and Payment of Benefits

Participation is voluntary. All participants who are currently employed by the Division of Police, City of Columbus, Ohio are required to contribute a nominal monthly amount to the Fund, as determined by the Board of Trustees. A one-time death benefit is paid to the families of deceased fund members in an amount determined by the Board of Trustees (\$4,000 as of December 31, 2024 and 2023). As of December 31, 2024, the contribution requirement was nine dollars per month. Effective June 2023, the Plan was amended to increase the contribution requirement from five dollars per month to nine dollars per month.

Vesting

There is no vesting of any rights or interest in the Fund by fund participants, and the Fund may be altered, amended, changed or repealed by the Board of Trustees at any time.

Special Events and Donations

From time to time, the Fund generates additional revenue through annual fundraisers and donations. All revenues are deposited into the Fund and used for the payment of death benefits and administrative expenses of the Fund.

SECURE Act 2.0

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included SECURE Act 2.0. SECURE Act 2.0 contains over 90 new retirement provisions, with varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. Most of the significant provisions will become effective in 2024 and thereafter. There was no material impact on the Plan's 2024 or 2023 financial statements.

Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Fund are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Fund's investments are comprised of savings and money market accounts, certificates of deposit, an unallocated insurance contract and mutual funds. Savings and money market accounts are considered cash and cash equivalents. Certificates of deposits are valued at cost plus accrued interest earned. Interest income is recorded on the accrual basis.

The unallocated insurance contract is valued at contract value, which approximates fair value, and equals the accumulated cash contributions, interest credited and transfers, if any, less any withdrawals and transfers, if any.

Mutual funds are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Fund's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Fund participants are recorded in the year in which the contributions are withheld from compensation.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

All administrative expenses are paid directly by the Fund.

Cash and Cash Equivalents

Cash and cash equivalents include demand deposits held by banks and money market accounts. Cash and cash equivalents are maintained in four accounts at two financial institutions and, at times, balances may exceed federally insured limits.

Unallocated Insurance Contract

The Fund has a fixed index annuity contract (the Lifetime Income Plus Multiplier Flex account) with American General Life Insurance Company (AGL). The contract assets are comprised of cash and cash equivalents and mutual funds. The contract totaled \$488,729 and \$486,984 at December 31, 2024 and 2023, respectively.

The contract provides for an accumulation phase and an income phase. During the accumulation phase, the premiums received during an initial period are allocated among a fixed interest account and/or one or more index interest accounts, as provided in the contract. Interest is credited at an annual minimum declared rate of not less than 1.0% for fixed accounts, and is subject to variable interest rates for index interest accounts. During the income phase, a series of income payments of predetermined amounts will be made based on the Fund's election of several income payment options. The Fund may elect to begin receiving income payments at any time on or after September 14, 2025 (the 5th contract anniversary) and before the contract maturity date of August 11, 2063. As of December 31, 2024, and through the date the Fund's financial statements were available to be issued, no income payment option had been elected by the Fund.

The contract contains withdrawal provisions which allow for partial or full withdrawal of the funds held in the contract, subject to certain limitations. If the Fund chooses to terminate the insurance contract and request a full surrender of the funds, the contract provides a cash surrender value, which represents the contract value less any applicable withdrawal charges and premium taxes. At December 31, 2024 and 2023, the cash surrender value of the contract approximated \$404,000 and \$418,000, respectively. The Fund has elected to participate in a systematic withdrawal program under a lifetime income rider option, which allows for monthly automatic withdrawals ranging from \$1,417 to \$1,600 beginning in December 2020. The Fund received \$18,530 and \$17,937 in systematic monthly withdrawals during 2024 and 2023, respectively. Under the lifetime income rider, the Fund has the ability to continue receiving lifetime monthly income payments after the contract value is reduced to zero, provided that the income base under the contract (premium adjusted for withdrawals and income credits) is greater than zero.

Certificates of Deposit

The Fund invests in certificates of deposit with initial maturities greater than three months. These investments are readily convertible to cash, but may be subject to a penalty upon conversion. The certificates of deposit mature at various times through April 2026 and bear interest at rates ranging from 3.00% to 3.51%. Upon their respective maturity dates, the certificates of deposit are generally renewed under extended terms. Subsequent to year-end, one certificate of deposit was renewed to extend the term through April 2027. The new certificate of deposit bears interest at 3.82%.

Fair Value Measurements

GAAP established a fair value hierarchy that prioritizes the inputs to measure the fair value of the assets or liabilities being measured. Fair value is defined as the exchange value that would be received on the measurement date to sell an asset or to value the amount paid to transfer a liability in the principal or most advantageous market available to the entity in an orderly transaction between market participants. The three levels of the fair value hierarchy are as follows:

- Level 1 Inputs are unadjusted quoted market prices in active markets for identical assets or liabilities that the entity has the ability to access at the measurement date. Level 1 inputs provide the most reliable measure of fair value as of the measurement date.
- Level 2 Inputs are based on significant observable inputs, including unadjusted quoted market prices for similar assets and liabilities in active markets, unadjusted quoted prices for identical or similar assets or liabilities in markets that are not active, or inputs other than quoted prices that are observable for the asset or liability.
- Level 3 Inputs are significant unobservable inputs for the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the quoted net asset value of shares held by the Fund at year-end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Fund believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The mutual funds are considered Level 1 investments as of December 31, 2024 and 2023.

Tax Status

The Fund is exempt from federal income taxes under Section 501(c)(9) of the Internal Revenue Code. The Fund has obtained a favorable tax determination letter from the Internal Revenue Service, which stated that the Fund and related trust are designed in accordance with applicable sections of the Internal Revenue Code. No provision for income taxes has been included in the Fund's financial statements.

Tax Status (continued)

GAAP requires Fund management to evaluate tax positions taken by the Fund and recognize a tax liability (or asset) if the Fund has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Fund administrator has analyzed the tax positions taken by the Fund, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Fund is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Fund Termination

Although it has not expressed any intent to do so, the Fund has the right to discontinue its contributions at any time and to terminate the Fund subject to the provisions set forth in ERISA.

Benefit Obligations

Benefit obligations are calculated at \$4,000 per beneficiary claim and are calculated based on the approximate total number of employees currently enrolled in the Fund. As of December 31, 2024 and 2023, the total number of eligible participants in the Fund was 2,572 and 2,592, respectively.

Risks and Uncertainties

The Fund invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the accompanying 2024 statement of net assets available for benefits.

Concentrations

At December 31, 2024, approximately 23% of total plan investments were held in two mutual funds. At December 31, 2023, approximately 10% of total plan investments were held in one mutual fund.

Subsequent Events – Date of Management's Evaluation

The Fund has evaluated subsequent events through the date of the Independent Auditor's Report, the date on which the financial statements were available to be issued.
