Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter — Supplemental Schedule Required by ERISA**

**1. Description of Plan:**

---

The following description of the Lake Area Discovery Center 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General:**

The Plan, established on January 1, 2017, is a defined contribution plan covering substantially all employees of Lake Area Discovery Center (the Organization) who are age 18 or older and have one month of service. Employees may become participants for pre-tax and Roth deferrals, effective the first quarterly entry date following their date of eligibility. Plan entry dates are January 1, April 1, July 1 and October 1. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Subsequent to December 31, 2024, the plan was restated at which time the eligibility requirements decreased to 0 months of service with monthly entry dates and compensation maximums up to 90% for pre-tax deferrals and 50% for Roth.

**Contributions:**

Each year, participants may contribute pre-tax and after-tax annual compensation up to certain IRS limitations, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

The Plan allows for discretionary matching contributions, as well as, discretionary profit-sharing contributions on behalf of all eligible employees. During the years ended December 31, 2024 and 2023, no discretionary matching contribution or profit sharing contributions were made.

**Participant accounts:**

Each participant's account is credited with the participant's contributions and Organization's matching contributions, as well as Plan earnings. Only those participants who are eligible employees of the Organization as of the last day of the Plan year will receive an allocation of the profit sharing contribution. Investments are participant directed. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant's earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. Description of Plan (continued):

Vesting:

Participants are vested immediately in their contributions plus actual earnings thereon. Participants' interest in their employer-derived contributions, including the Organization's match and profit sharing, is based on years of service.

The following table represents the rate at which the Organization's match and profit sharing contributions vest:

Upon termination of employment, any non-vested portion of employer-derived contributions is forfeited.

Loans from participants:

The Plan does not allow loans to participants.

Payment of benefits:

On termination of service, a participant may elect to receive a lump sum or partial payments in an amount equal to the value of the participant's vested interest in his or her account.

The Plan makes involuntary distributions of terminated employees' whose Plan balances are \$5,000 or less.

Forfeitures:

Forfeitures are used to reduce either employer matching or profit sharing contributions. There were no forfeitures used or available as of and for the years ended December 31, 2024 and 2023.

Use of estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Investment valuation and income recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See note 4 for discussion of fair value measurements.

### 2. Summary of significant accounting policies:

#### Investment valuation and income recognition (continued):

Investments are reported at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See note 4 for discussion of fair value measurements.

#### Refund of excess contributions payable:

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed \$6,965 and \$7,524 of 2024 and 2023 excess contributions to the applicable participant subsequent to the 2024 and 2023 Plan year end, respectively.

#### Benefits paid to participants:

Benefits paid to participants are recorded when paid.

#### Administrative expenses:

Certain administrative expenses of the Plan are paid by the Plan Sponsor and excluded from these financial statements. In 2024 and 2023, investment related expenses are included in net appreciation of fair value of investments, and plan administrative fees were paid by the Plan to the trustee and recordkeeper.

#### Concentrations:

At December 31, 2024 and 2023, approximately 35% and 39% of investments were held in two mutual funds, respectively.

#### Subsequent events:

All subsequent events have been evaluated through October 15, 2025, the date the financial statements were available for issuance.

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to certain investments held as of December 31, 2024 and 2023, as well as, certain investment income for the years ended December 31, 2024 and 2023, as shown below, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, a qualified institution.

**4. Fair value measurements:**

---

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements*, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Money Market fund:* Valued at the daily closing price as reported by the fund sponsor from an actively traded exchange.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Party-in-interest transactions:

As defined by ERISA, a party-in-interest includes any fiduciary of the Plan, any party rendering services to the Plan, the employer and certain others. The Plan utilizes service providers as described in Notes 2 and 3. Such parties are parties-in-interest under ERISA.

6. Plan termination:

Although it has not expressed any intent to do so, the employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

7. Tax status:

The Plan was restated for regulatory changes effective May 1, 2022. The Plan has not been amended or restated following this restatement through December 31, 2024. The Plan document provider obtained an opinion letter dated October 6, 2020, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC).

**7. Tax status (continued):**

---

Subsequent to year end, the Plan sponsor transferred the Plan's assets to a new custodian, and will have a new recordkeeper and third-party administrator. In connection with this transfer, the Plan Sponsor adopted a new plan document provided by the recordkeeper. The plan document provider obtained an IRS opinion letter dated June 30, 2020, indicating that the plan document, as designed, satisfies the requirements of Section 403(b) of the Internal Revenue Code.

The Plan Administrator believes the Plan used by the Plan Sponsor is designed and operating in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. Plan management evaluated the Plan's tax positions and concluded the Plan had taken no uncertain tax positions that require adjustment to the financial statements to comply with the provisions of this guidance. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**8. Risks and uncertainties:**

---

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
