**NOTE 1 – PLAN DESCRIPTION**

The following description of the Sutter North Medical Group, Inc. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Summary Plan Description or Plan Document for a more complete description of the Plan's provisions.

General: Sutter North Medical Group, Inc. established the Plan effective June 1, 1993. The Plan is a 401(k) defined contribution plan established for the benefit of and covering all eligible employees of Sutter North Medical Group, Inc. (the "Sponsor", the "Company"), excluding those covered by a collective bargaining agreement or employed by an outside medical practice. The Sponsor is responsible for the administration and management of the Plan. All investments in the Plan are participant-directed. Fidelity Management Trust Company (Fidelity) serves as the trustee for the Plan as of December 31, 2024 and 2023, in accordance with an agreement. The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code ("IRC") and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Eligibility: Under the Plan, generally all employees of the Sponsor and its subsidiaries are eligible to participate in the Plan upon attainment of 21 years of age and upon completion of one year or 1,000 hours of service. Once eligibility requirements have been met, entry into the Plan occurs on the first day of the first and seventh month of the calendar year. Employees who are not eligible to participate in the plan include employees who are a resident of Puerto Rico, covered by a collective bargaining agreement (unless allowed under the terms of the collective bargaining agreement), leased employees, nonresident aliens, reclassified employees, and employees who are employed by outside medical practices.

Vesting: Participants are immediately vested in their voluntary contributions and employer contributions.

Participant Contributions: Participants may contribute between 1% to 80% of eligible compensation as defined by the Plan, subject to certain IRC limitations. Participants may elect their deferrals to either be pre-tax deferrals or Roth deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

Employer Contributions: The Company may, at its discretion, make matching and profit-sharing contributions to the Plan on behalf of eligible participants based on classification as defined by the Plan. The Company elected to make a profit-sharing contribution of \$3,158,650 for the 2024 plan year, equal to a percentage of eligible compensation determined by employment status and income level as defined in the plan document. The Company made no matching contributions for the year ended December 31, 2024. Contributions made by the Company are subject to certain IRC limitations.

Participant Accounts and Investment Options: Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions, allocation of the Sponsor's matching and profit-sharing contributions, allocations of Plan earnings, and charged with withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings or account balance, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan. Participants may change their investment options at any time directly through Fidelity.

Notes Receivable from Participants: Participants may borrow up to 50% of their vested accounts in the form of a note with a minimum amount of \$1,000 and a maximum amount of \$50,000. Notes are secured by the balance in the participant's account and bear interest at prevailing market rates at the time the funds are borrowed. The term of the notes cannot exceed five years; however, the plan administrator may permit a longer repayment term if the note is for the purchase of a primary residence. At December 31, 2024, the interest rate on outstanding notes was between 4.25% and 9.50%. Principal and interest are paid ratably through payroll deductions and as of December 31, 2024, the notes receivable outstanding are due in various amount through March 2029. A participant may only have one note outstanding at a time.

Payment of Benefits: Upon termination of service due to death, disability, retirement, or other reasons, each participant can receive their vested account balance in one lump-sum payment, or in certain cases, the participant can receive installment payments. If a participant's vested balance is \$1,000 or less, the participant will receive a single distribution of their entire vested account balance. The Plan provides for the automatic rollover of vested participant balances above \$1,000, but less than \$5,000 into an individual retirement account if the participant does not elect to have the distribution paid directly to an eligible retirement plan in a direct rollover or to receive the distributions directly. Hardship withdrawals are also allowed, subject to the provisions specified in the Plan agreement. Active participants may also take distributions from the Plan upon attainment of age 59 ½.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Loan origination fees associated with notes receivable from participants are paid by the participants and are reflected in the financial statements as part of the notes receivable from participants balance. Investment management fees are charged to the Plan as a reduction of investment return and included in the net appreciation (depreciation) report by the Plan on the statement of changes in net assets available for benefits.

Plan Termination: Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Subsequent Events: Plan management evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received by the Plan to sell an asset or paid by the Plan to transfer a liability (exit price) in an orderly transaction between market participants at the measurement date in the Plan's principal or most advantageous market for the asset or liability. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes net unrealized market appreciation (depreciation) of investments and net realized gains and losses on the sale of investments during the period.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by participants' account balances. If a participant ceases to make note repayments and the Plan Administrator deems the participant note to be in default, the participant note balance is reduced and a benefit payment is recorded.

Risks and Uncertainties: The Plan holds various investment instruments. Investments are exposed to various risks, such as interest rate, credit, overall market volatility, global pandemic, and international conflicts. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in participants' account balances and amounts reported in the financial statements.

Payment of Benefits: Benefits are recorded when paid.

**NOTE 3 – CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).

**NOTE 4 – FAIR VALUE MEASUREMENTS**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3:* Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective Trust Funds: The fair values of participation units held in a stable value collective investment trust are based on the net asset values per unit (NAV) as reported by the fund managers. The fair values of participation units held in collective investment trusts are based on the NAV as reported by the fund managers. The NAV is used as a practical expedient to measure fair value. The stable value collective investment and collective investment trusts provide for daily redemptions by the Plan at reported NAV, with no advance notice requirement.

Changes in Fair Value: To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may retire the transfer of investments from one fair value level to another. For the year ended December 31, 2024, there were no transfers in or out of level 3.

**NOTE 5 – FEDERAL INCOME TAX STATUS**

The Internal Revenue Service (IRS) issued an opinion letter dated June 30, 2020 indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Fidelity is the trustee of the Plan and, therefore, the Plan's payment of trustee fees, record keeping fees and investment management fees to Fidelity qualifies as a party-in-interest transaction. In addition, certain Plan investments consist of shares of mutual funds and collective trust funds managed by Fidelity or an affiliate of Fidelity. Accordingly, these investments constitute party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company.
