## **Independent Auditors' Report**

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed the audits of the financial statements of Apex Service Partners LLC 401(k) Plan (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors’ Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. ## Notes to Financial Statements

December 31, 2024 and 2023

### (1) **Description of the Plan**

The following description of the Apex Service Partners LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

#### (a) **General**

The Plan is a single-employer defined contribution plan covering all employees of Apex Service Partners LLC (the “Company” or “Plan Sponsor”), and a controlled group of employers as defined by the Plan, with the exception of union employees and certain nonresident aliens, who are age 21 or older and have completed 2 months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan was amended and restated effective January 1, 2021.

Effective January 1, 2024, the Plan was amended and restated. Employees who are age 18 or older and have completed 2 months of service are eligible to participate in the Plan, except for union employees and certain nonresident aliens. Additionally, periods of service with any entity the Company acquires will be counted as long as employment at the acquired entity exists at the time of the acquisition.

The Plan operates under agreements with ADP, LLC (“ADP”) and Reliance Trust Company (“RTC”) to act as recordkeeper and trustee of the Plan, respectively. RTC holds the Plan’s investments and executes the Plan’s investment transactions.

#### (b) **Contributions**

Participants may contribute up to 90% of eligible compensation to their accounts up to the maximum allowed under Internal Revenue Code section 402(g), including Roth deferrals. The Plan also provides for “catch-up” contributions subject to Internal Revenue Service limitations. Participants may also contribute amounts representing distributions from other qualified plans.

Effective January 1, 2024, the Company provides employer matching contributions to eligible employees of the Plan equal to 50% of elective deferrals not in excess of 8% of eligible compensation. The Company has ceased making safe harbor contributions to the Plan.

The Company may also elect to make a discretionary profit sharing contribution to participants employed by the Company on the last day of the year who have completed 1,000 hours of service during the year. No such profit sharing contributions were made for the year ended December 31, 2024.

#### (c) **Participant Accounts**

Each participant’s account is credited with the participant’s contributions, rollover contributions from other qualified retirement plans, allocations of the Company’s safe harbor matching and profit sharing contributions and plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**(1) Description of the Plan - Continued**

**(d) Vesting**

Participants are immediately vested in their contributions and the Company's safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's discretionary profit sharing contributions is based on a six year graded vesting schedule. Participants become vested in accordance with the following schedule:

Participants are vested in their employer share of matching contributions based on their periods of service with the Company in accordance with the following schedule.

Effective January 1, 2024, employees acquired by the Company on or after January 1, 2024 will be vested in the above schedules based on acquisition date.

Participants will vest 100% upon attainment of age 65, or in the event of death or disability while employed by the Company.

**(e) Investment Options**

Upon enrollment in the Plan, a participant may direct their contributions and the employer contributions in any of the available funds as offered by the trustee. During 2024 and 2023, the Plan offered registered investment companies and a common collective trust.

### Notes to Financial Statements - Continued

#### (1) **Description of the Plan - Continued**

##### (f) **Administrative Expenses**

The administrative expenses of the Plan are shared by the Plan and the Company. Certain expenses of the Plan are paid by the Company and are not included in the statement of changes in net assets available for benefits.

##### (g) **Payment of Benefits**

In the event of termination of employment with the Company, attainment of normal retirement age, death or disability, a participant shall be entitled to benefits equal in value to the participant's vested interest in their account. Benefit payments are recorded when paid.

The Plan also provides for in-service distributions for participants who have attained age 59 ½ and for participants who have an immediate and heavy financial need.

##### (h) **Participant Loans**

Participants may borrow from their account balance, subject to limitations. Loan amounts must be at least \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. Principal and interest are paid ratably through payroll deductions. All loans shall be repaid within five years, unless the loan is for the purchase of a primary residence, in which case the loan term shall not exceed thirty years.

Related fees are recorded as administrative expenses and are expensed when they are incurred.

##### (i) **Forfeitures**

Forfeitures from the Plan may first be used to pay plan expenses then may be used to reduce future employer contributions. Forfeitures available were approximately \$594,000 and \$91,000 at December 31, 2024 and 2023, respectively. For the year ended December 31, 2024, the Company used approximately \$41,000 of forfeited non-vested account balances to offset employer contributions.

#### (2) **Summary of Significant Accounting Policies**

##### (a) **Basis of Presentation**

The accompanying financial statements have been prepared on the accrual basis of accounting and present the net assets available for benefits and changes in net assets available for benefits in accordance with accounting principles generally accepted in the United States of America.

#### (2) Summary of Significant Accounting Policies - Continued

##### (b) Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

##### (c) Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

##### (d) Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Shares of registered investment companies are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year end.

The Invesco Stable Asset Fund (the "Fund") is a common collective trust which seeks stability of principal and high current income. The Fund invests primarily in stable value products, including guaranteed investment contracts ("GICs") and synthetic GICs issued by major insurance companies and money market instruments and is valued by State Street Bank and Trust. Participants may purchase units of the Fund daily based on the established unit value of \$1.00. Participants have a proportionate undivided interest in all assets of the Fund, and hold units of the Fund. Net investment income is distributed to participants monthly and is reinvested to purchase additional units. The principal value per unit of the Fund is determined at the end of each day by dividing net assets of the Fund by the number of outstanding units. The investment does not qualify as a fully benefit-responsive investment.

Generally, contributions to and withdrawals from the Fund are converted to units by dividing the amounts of such transactions by the unit values as last determined, and the participants' accounts are charged or credited with the number of units properly attributable to each participant.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

##### (e) Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

#### (3) **Information Prepared and Certified by RTC**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, RTC, the Plan's trustee, has certified that the following data included in the accompanying financial statements and supplemental schedules is complete and accurate:

- Investments, at fair value
- Notes receivable from participants
- Total investment income
- The Schedule of Assets (Held at End of Year)

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in these financial statements and supplemental schedule.

#### (4) **Fair Value Measurements**

Accounting Standards Codification ("ASC") Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- (a) Quoted prices for similar assets or liabilities in active markets;
- (b) Quoted prices for identical or similar assets or liabilities in inactive markets;
- (c) Inputs other than quoted prices that are observable for the asset or liability;
- (d) Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

**(4) Fair Value Measurements - Continued**

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

*Registered Investment Companies:* shares of registered investment companies held by the Plan are valued based on quoted market prices in active markets, which represent the net asset value of the units or shares held by the Plan at year end and are classified as Level 1 investments.

*Common Collective Trust:* valued at the net asset value of shares held by the Plan at year end as determined by Invesco Trust Company.

The above methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values.

(5) **Plan Termination**

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

(6) **Transactions with Parties-in-Interest**

During the year ended December 31, 2024, the Plan paid approximately \$499,000 to ADP for recordkeeping services provided to the Plan. Notes receivable from participants are managed by ADP as of December 31, 2024. These transactions qualify as party-in-interest transactions, as defined in Section 3(14) of ERISA, however they are expressly exempted from the prohibited transaction rules.

(7) **Risks and Uncertainties**

The Plan provides for various investment options in any combination of investment securities offered by the Plan. Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(8) **Income Tax Status**

The Plan has adopted a pre-approved plan document sponsored by ADP, which received its latest opinion letter from the Internal Revenue Service dated October 6, 2020, which stated that the pre-approved plan document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The pre-approved plan document has since been amended; however, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
