Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Preqin, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The information in the accompanying financial statements related to assets held by and certified to by qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter—Supplemental Schedules Required by ERISA

The supplemental schedules, Schedule H, line 4a—schedule of delinquent participant contributions for the year ended December 31, 2024, and Schedule H, line 4i—schedule of assets (held at end of year) as of December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to the Financial Statements

Note 1. Description of the Plan

The following description of the Preqin, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all eligible employees of Preqin, Inc. (the Company or Plan Sponsor) and Colmore, Inc., a company owned by the Plan Sponsor. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Reliance Trust Company (Reliance) serves as the trustee and custodian for the Plan. ADP Retirement Services (ADP) serves as the recordkeeper for the Plan.

Contributions: Participants may contribute up to a maximum of 90% of pretax annual compensation, as defined in the Plan, and allocate this contribution to certain investments administered by the trustee. A participant's maximum pretax annual contribution was limited to \$23,000 in 2024. Employees who are age 50 or over may make a catch-up contribution of up to \$7,500 in 2024. These limitations are adjusted annually as provided in Internal Revenue Code (IRC) Section 415(d).

The employer safe harbor matching contribution is equal to 100% of the participant's elective deferrals not to exceed 10% of the participant's compensation. Employer matching contributions and employer profit sharing contributions are discretionary. During 2024, no discretionary employer matching contributions or employer profit-sharing contributions were made to the Plan.

Eligibility: An employee is eligible to participate in the Plan when hired. Participants become eligible for the employer safe harbor matching contributions upon 1,000 hours of service. Participants become eligible for the employer profit sharing contribution after one year of service.

Vesting and forfeitures: A participant is fully vested at all times in his or her own contributions to the Plan and the employer matching contributions. Participants vest in the employer profit sharing contributions as follows:

Years of Service	Vested Percentage
1	50%
2	100%

At December 31, 2024 and 2023, forfeited nonvested accounts were \$21 and \$11, respectively. Forfeitures may be used first to reduce expenses related to the administration of the Plan and then to reduce certain employer contributions. During 2024, forfeitures of \$408 were used to reduce employer's matching contributions and no forfeitures were used to pay administrative expenses.

Note 1. Description of the Plan (Continued)

Participant accounts: Each participant's account is credited with the participant's contribution and allocations of: (a) the Company's contribution, (b) Plan earnings, and (c) charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants' investment options: Participants must direct their salary deferral contributions to selected investments as made available and determined by the Plan Administrator. Participants may change their investment options at any time throughout the year via direct phone access or website access to ADP.

Payment of benefits: Benefit payments begin at a participant's election after the participant ceases to be an employee due to disability, retirement or other termination of employment or death. Participants may also receive hardship withdrawals and in-service distributions in other circumstances, as defined in the Plan agreement. Participants may elect to receive benefits from several options available, as set forth in the Plan document.

An employee's membership in the Plan shall terminate on the date of death, the date of retirement or the date employment is terminated because of disability or other reasons.

Participant notes receivable: Participants may borrow from their account up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan terms may not be greater than five years or 30 years for loans taken to purchase a primary residence. Notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates at the time the loan is approved. Principal and interest are paid ratably, generally through payroll deductions. Processing fees are charged against participant accounts.

Note 2. Summary of Significant Accounting Policies

The Plan's significant accounting policies are as follows:

Basis of accounting: The accompanying financial statements of the Plan have been prepared on the accrual method of accounting.

Investment valuation and income recognition: The Plan's investment assets are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative costs: Certain Plan expenses are deducted from participants' accounts or investment income, and the remainder of the Plan expenses are paid by the Company.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Note 2. Summary of Significant Accounting Policies (Continued)

Contributions: Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Notes receivable from participants: Participant loans are classified as notes receivable from participants, which are segregated from Plan investments and measured at their unpaid principal balance plus any accrued but unpaid interest. Any default in repayment to the Plan will result in the treating of the balance due for the loans as a taxable distribution from the Plan. The Plan records an allowance for loans not expected to be collected which have been recorded as distributions per the Plan's Form 5500. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Form 5500 presents notes receivable from participants as an investment.

Payment of benefits: Benefits are recorded when paid.

Note 3. Exempt Party-in-Interest Transactions

Most administrative expenses of the Plan are paid by the Plan Sponsor, and personnel and facilities of the Plan Sponsor have been used by the Plan at no additional charge to the Plan. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

Notes receivable from participants represents loans made to plan participants and are therefore considered party-in-interest transactions. These loans are secured by the participants' account balances and bear interest at rates specified in the plan.

Note 4. Information Certified by Reliance Trust Company (Trustee)

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and supplemental schedules, that was prepared or derived from information provided by the trustee and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the trustee that the information provided to the Plan Administrator by the trustee related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and the supplemental schedules related to the following assets at December 31:

Note 5. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standard Codification (ASC) Topic 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There were no significant transfers between Levels 1, 2 and 3 during the years ended December 31, 2024 and 2023.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Common collective trust (CCT): The net asset value (NAV) of a CCT is based on the market value of its underlying investments. The CCT NAV is not a publicly quoted price in an active market and NAV is used as a practical expedient to estimate the fair value.

Mutual funds (registered investment companies): Fair value is based on unadjusted quoted prices in active markets. Mutual funds are valued at the NAV of shares held by the Plan at year-end. These investments are classified as Level 1 investments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes that its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan Administrator does not believe that any events, which would limit the Plan's ability to transact at contract value with the participants, are probable of occurring.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 7. Tax Status

The Plan Sponsor has adopted a nonstandardized preapproved plan sponsored by ADP. ADP received an opinion letter from the Internal Revenue Service (the IRS), dated October 6, 2020, which states that the Plan document satisfies the applicable provisions of the IRC. The Plan itself has not received, nor is it required to receive, a determination letter from the IRS. The Plan has been most recently amended effective January 1, 2023; however, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

The Plan Sponsor's management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustments to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements as of December 31, 2024 and 2023, and for the year ended December 31, 2024.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9. Employer Receivable

During the years ended December 31, 2021, 2022 and 2023, the Plan Sponsor failed to timely deposit employer match true-up contributions into the Plan. In 2023, the Plan recorded an employer receivable of \$423,426 for employer match true-up contributions and lost earnings on late deposits for plan years 2021, 2022 and 2023. The employer contribution receivable was received by the Plan during 2024 and was made from the Plan Sponsor's assets and not from the assets of the Plan. The Plan recorded an employer contribution receivable of \$167,922 as of December 31, 2024.

Note 10. Prohibited Transactions

During 2023, the Plan Sponsor inadvertently failed to deposit \$19,413 of participant contributions within the required time frame as stated by the DOL regulation. The Plan Sponsor intends to deposit lost earnings to correct this failure during 2025. The Plan Sponsor filed Form 5330 and paid applicable excise tax to the IRS. The correction and excise taxes were made from the Plan Sponsor's assets and not from the assets of the Plan.

In October 2025, the Administrative Committee of the BlackRock Retirement Savings Plan approved the merger of the Plan into the BlackRock Retirement Savings Plan effective December 1, 2025.
