### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the financial statements of Wilbert Funeral Services, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). ### 1. Description of Plan

The following description of the Wilbert Funeral Services, Inc. 401(k) Plan, (provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

#### a. General

The Plan is a defined contribution plan available to all employees of Wilbert Funeral Services, Inc., (the "Company"), who are not in an excluded class and have completed three months of service. Effective January 1, 2023, an employee may enter the plan on the first day of the month following the date the employee satisfies the eligibility requirements. Previously, an employee could enter the plan on the first day of January, April, July, and October of each year coinciding with or next following the date the employee satisfied the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

As of September 19, 2024, the Company had intent to merge with Marmon Employees Retirement Plan effective January 1, 2025. Effective December 31, 2024, the plan had a transfer out of all of the assets in the amount of \$48,325,480.

#### b. Contributions

Each year, participants may contribute up to 75% percent of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Company makes safe harbor nonelective employer contributions which were contributed at 100% of the first 3% percent of eligible participant compensation contributed to the Plan and 50% of the next 2% of eligible participant compensation contributed to the Plan. All safe harbor contributions are immediately vested. Contributions are subject to certain IRS limitations.

#### c. Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit-sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. **Description of Plan (Continued)**

d. **Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contributions, plus actual earnings thereon, is based on years of continuous service. A participant becomes 100 percent vested after five years of service.

e. **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at 1 percent above the prime rate, as defined. Principal and interest are paid ratably through monthly payroll deductions.

f. **Payment of Benefits**

Upon termination of continuous employment, death, disability, or attainment of age 59½, participants are entitled to their vested interests of their account balances. Benefits are payable in a lump sum. Upon evidence, to the satisfaction of the plan administrator, of an immediate and heavy financial need, amounts contributed may be withdrawn for a hardship purpose. For participants with account balances greater than \$5,000, the participant must consent to the distribution before it will be made. Benefits are recorded when paid.

g. **Forfeited Accounts**

At December 31, 2023, forfeited non-vested accounts totaled \$82,366. These accounts will be used to pay administrative expenses or reduce future employer contributions. During the year ended December 31, 2024, \$55,290 was used to pay Plan administrative expenses. The forfeiture account balance was transferred into the new plan in December 2024 as part of the plan merger. Therefore, there is no balance in the forfeiture account as of December 31, 2024.

h. **Administrative Expenses**

The Plan sponsor bears substantially all administrative costs of the plan, including the costs of officers and employees who perform certain administrative functions. Administrative expenses that are paid by the Plan consist of fees charged by the Plan's trustee.

### 2. Summary of Significant Policies

The following are the significant policies followed by the Plan:

#### a. Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

#### b. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Accordingly, actual results may differ from those estimates.

#### c. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### d. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Since the notes receivable from participants are secured, management has determined that there is minimal risk and therefore no allowance for credit losses is recorded.

#### e. Payments of Benefits

Benefits are recorded when paid.

#### f. Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation of fair value of investments.

#### g. Income Taxes

The Plan's income tax filings are subject to examination by various tax authorities. The Plan's open examination periods are 2021 and forward.

#### h. Subsequent Events

Subsequent events have been evaluated up to October 15, 2025, the date these financial statements were available to be issued.

### 3. Fair Value of Financial Instruments

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1), and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy within is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies, as of December 31, 2024.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Money market fund:* Valued based on amortized cost which approximates fair value.

*Collective investment trust:* Valued at the net asset value (NAV) of the units of the collective trust held by the Plan. The net asset value is used as a practical expedient to estimate fair value, the value at which participants ordinarily transact.

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the financial statements of Wilbert Funeral Services, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). ### 1. Description of Plan

The following description of the Wilbert Funeral Services, Inc. 401(k) Plan, (provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

#### a. General

The Plan is a defined contribution plan available to all employees of Wilbert Funeral Services, Inc., (the "Company"), who are not in an excluded class and have completed three months of service. Effective January 1, 2023, an employee may enter the plan on the first day of the month following the date the employee satisfies the eligibility requirements. Previously, an employee could enter the plan on the first day of January, April, July, and October of each year coinciding with or next following the date the employee satisfied the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

As of September 19, 2024, the Company had intent to merge with Marmon Employees Retirement Plan effective January 1, 2025. Effective December 31, 2024, the plan had a transfer out of all of the assets in the amount of \$48,325,480.

#### b. Contributions

Each year, participants may contribute up to 75% percent of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Company makes safe harbor nonelective employer contributions which were contributed at 100% of the first 3% percent of eligible participant compensation contributed to the Plan and 50% of the next 2% of eligible participant compensation contributed to the Plan. All safe harbor contributions are immediately vested. Contributions are subject to certain IRS limitations.

#### c. Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit-sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. **Description of Plan (Continued)**

d. **Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contributions, plus actual earnings thereon, is based on years of continuous service. A participant becomes 100 percent vested after five years of service.

e. **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at 1 percent above the prime rate, as defined. Principal and interest are paid ratably through monthly payroll deductions.

f. **Payment of Benefits**

Upon termination of continuous employment, death, disability, or attainment of age 59½, participants are entitled to their vested interests of their account balances. Benefits are payable in a lump sum. Upon evidence, to the satisfaction of the plan administrator, of an immediate and heavy financial need, amounts contributed may be withdrawn for a hardship purpose. For participants with account balances greater than \$5,000, the participant must consent to the distribution before it will be made. Benefits are recorded when paid.

g. **Forfeited Accounts**

At December 31, 2023, forfeited non-vested accounts totaled \$82,366. These accounts will be used to pay administrative expenses or reduce future employer contributions. During the year ended December 31, 2024, \$55,290 was used to pay Plan administrative expenses. The forfeiture account balance was transferred into the new plan in December 2024 as part of the plan merger. Therefore, there is no balance in the forfeiture account as of December 31, 2024.

h. **Administrative Expenses**

The Plan sponsor bears substantially all administrative costs of the plan, including the costs of officers and employees who perform certain administrative functions. Administrative expenses that are paid by the Plan consist of fees charged by the Plan's trustee.

### 2. Summary of Significant Policies

The following are the significant policies followed by the Plan:

#### a. Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

#### b. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Accordingly, actual results may differ from those estimates.

#### c. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### d. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Since the notes receivable from participants are secured, management has determined that there is minimal risk and therefore no allowance for credit losses is recorded.

#### e. Payments of Benefits

Benefits are recorded when paid.

#### f. Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation of fair value of investments.

#### g. Income Taxes

The Plan's income tax filings are subject to examination by various tax authorities. The Plan's open examination periods are 2021 and forward.

#### h. Subsequent Events

Subsequent events have been evaluated up to October 15, 2025, the date these financial statements were available to be issued.

### 3. Fair Value of Financial Instruments

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1), and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy within is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies, as of December 31, 2024.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Money market fund:* Valued based on amortized cost which approximates fair value.

*Collective investment trust:* Valued at the net asset value (NAV) of the units of the collective trust held by the Plan. The net asset value is used as a practical expedient to estimate fair value, the value at which participants ordinarily transact.

4. **Financial Data Certified by the Trustee (Continued)**

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

5. **Plan Termination**

The Company has the right under the Plan and with the approval of the Board of Directors to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination participants will become 100% vested in their accounts.

6. **Tax Status**

The IRS has determined and informed the Plan sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRS). Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

7. **Risks and Uncertainties**

The Plan invests in various investment instruments. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

8. **Exempt Party-In-Interest Transactions**

Some Plan investments are managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee as defined by the Plan; therefore, these transactions qualify as exempt party-in-interest transactions.
