Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

Management, having determined it is permissible in the circumstances, has elected to have the audits of the plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor ("DOL")'s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and September 30, 2023, as of and for the period ended December 31, 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's elections of ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the plan's ability to continue as a going concern for one year after the date that the financial statements were available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audits of the Financial Statements

Accordingly, the objective of the ERISA Section 103(a)(3)(C) audits is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings and certain internal control related matters that we identified during the audits.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of accounting - The PCI Nitrogen LLC Hourly Savings Plan ("the plan") follows the accrual method of accounting wherein additions and deductions are reflected in the period earned or incurred.

Accounting estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Subsequent events - The financial statements include management's evaluation of the events and transactions occurring subsequent to December 31, 2024 through October 7, 2025, which is the date the financial statements were available to be issued.

Risks and uncertainties - The plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Key parties of the plan - PCI Nitrogen, LLC is the plan sponsor, employer and the plan administrator. ADP, LLC is the third party administrator, recordkeeper and tax counsel that performs various compliance tests. Reliance Trust Company is the plan trustee that holds custody of plan assets and maintains participant investment records. Creative Planning, LLC is the plan's investment advisor.

Investments - The plan sponsor determines the investments available to plan participants. The participants allocate their contributions and transfer existing balances among the available investment options. The net appreciation (depreciation) in the fair value of investments bought, sold and held during the year / period are reflected in the statements of changes in net assets available for benefits. Participants should refer to the investment account summaries and prospectuses for more information.

Fair value measurements - GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows.

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

Following is a description of the valuation methodologies used for investments measured at fair value.

Mutual funds - Valued at the daily quoted market prices as reported by the funds. The funds held by the plan are registered with the U.S. Securities and Exchange Commission, are required to publish their daily net asset value and are deemed to be actively traded.

Common/collective trust - Valued at the NAV based on the units of the common/collective trust. The common/collective trust investment is a direct filing entity. The NAV, as certified by Reliance Trust Company, is used as a practical expedient to estimate fair value and is generally based on the fair value of the underlying investments held by the common/collective trust less its liabilities. This practical expedient would not be used if it is determined to be probable that the common/collective trust will sell the investment for an amount different from the reported NAV.

2. DESCRIPTION OF PLAN

The following description of the plan provides only general information. Participants should refer to the plan documents for a more complete description of the plan's provisions.

December 31, 2024 and 2023 and September 30, 2023

General - The plan was adopted effective October 1, 1998 as a defined contribution plan with a 401(k) salary deferral arrangement. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments. Effective October 1, 2023, the plan changed its plan year-end from September 30th to December 31st.

Eligibility - Employees covered under the collective bargaining agreement between the employer and the United Steel, Paper and Forestry, Rubber, Manufacturing, Energy, Allied Industrial and Service Workers International Union Local 13-1 are eligible once they have completed three months of service and have reached age eighteen. An employee can enter the plan immediately following completion of eligibility requirements.

Contributions - Contributions are recorded in the year in which the eligible compensation is paid. Contributions to the plan can be made in the following ways:

- a. Participants may contribute a percentage of their compensation subject to certain limitations (elective deferral contributions). The plan also permits Roth elective deferral contributions. Newly eligible employees are automatically enrolled in the plan and have 4% of compensation withheld as deferral contributions. Effective April 1, 2024, newly eligible employees' automatic enrollment was increased from 4% to 6%. Such participants have the option to increase, decrease or stop the deferral by completing the necessary documentation.
- b. Rollover contributions are accepted by the plan from other qualified plans. There were no such contributions for the year ended December 31, 2024 or for the period ended December 31, 2023.
- c. Prior to April 1, 2024, employer matching contributions were equal to 75% of the first 4% of the employee compensation contributed to the plan as elective deferral contributions. Effective April 1, 2024, employer matching contributions are equal to 100% of the first 3% of the employee compensation contributed to the plan as elective deferrals and 50% of the next 3% of the employee compensation contributed to the plan as elective deferrals. The employer matching contributions are funded coinciding with each payroll with an annual true-up contribution.
- d. Additional employer nonelective contributions may be made at the employer's discretion. Prior to April 1, 2024, participants who worked less than ten years received an employer nonelective contribution equal to 2.5% of eligible compensation, participants who worked between ten and twenty years received employer nonelective contributions equal to 4% of eligible compensation and participants who worked twenty years or more received employer nonelective contributions equal to 5% of eligible compensation.

Effective April 1, 2024, participants who work less than five years receive an employer nonelective contribution equal to 2.5% of eligible compensation, participants who work five to ten years receive an employer nonelective contribution equal to 3% of eligible compensation, participants who work ten to fifteen years receive an employer nonelective contribution equal to 4% of eligible compensation, participants who work fifteen to twenty years receive an employer nonelective contribution equal to 4.5% of eligible compensation, and participants who work twenty years or more receive an employer nonelective contribution equal to 5% of eligible compensation.

The employer nonelective contributions are funded coinciding with each payroll.

Participant accounts - Earnings, including the fair value appreciation (depreciation), are allocated to participant accounts on a daily basis based upon the performance of the investment options selected. Each participant's account is credited with the participant's elective deferral and rollover contributions and an allocation of the employer's contributions. Participants are allowed to change their investment options on a daily basis and change their deferral percentage each pay period.

Vesting - Participants are always 100% vested in their elective deferral contributions, employer matching contributions, employer nonelective contributions made after January 1, 2022, rollover contributions, and related earnings. Participants vest in employer nonelective contributions made prior to January 1, 2022 upon completing two years of service at which time they are 25% vested. The participants then vest at the rate of 25% for each year thereafter, with full vesting upon completion of 5 years of service. Upon death, disability or attainment of normal retirement age while employed, participants become 100% vested.

Payment of benefits - Benefits are recorded when paid. Benefit payments may commence upon termination of employment, death, disability or normal retirement age. Distributions may be made in the form of a single lump sum or installments. In-service withdrawals can commence upon attaining the age of 59 ½ or as a result of a participant's disability. In addition, hardship withdrawals are permitted under certain circumstances.

Administrative expenses - Certain administrative expenses of the plan are paid by the plan sponsor and are not included in these financial statements. Certain other fees are paid by the plan using plan assets and recorded as administrative expenses in the accompanying financial statements. Administrative expenses paid by the plan consist of participant directed charges for distribution and loan processing and nonparticipant directed charges for plan administration. Nonparticipant directed charges are allocated to the participants on an account value basis.

Forfeitures - Forfeited nonvested accounts are used to pay plan expenses. There were no forfeitures used in 2024 or for the period ended December 31, 2023. Unapplied forfeitures were \$65,000 and \$57,000 as of December 31, 2024 and 2023. Unapplied forfeitures were \$54,000 as of September 30, 2023.

Notes receivable from participants - Participants can take out loans against their accounts with the approval of the plan administrator. The minimum loan amount is \$1,000 and the maximum amount is the lesser of one-half of the participant's vested account balance, or \$50,000. Participants may not have more than two loans outstanding at any given time. The repayment term generally cannot exceed 5 years except when the loan is for the purchase of a principal residence. As of December 31, 2024, the notes receivable from participants had repayment schedules through December 2029 with interest rates ranging from 4.25% to 9.50%. The notes receivable from participants are valued at their unpaid principal balances plus any accrued but unpaid interest, which approximates fair value.

3. PARTY-IN-INTEREST TRANSACTIONS

Any transactions involving the plan, plan sponsor, record keeper (ADP, LLC), investment advisor (Creative Planning, LLC), and plan trustee (Reliance Trust Company) qualify as party-in-interest transactions. Direct administration fees paid to ADP, LLC by the plan were \$21,000 in 2024 and \$5,000 for the period ended December 31, 2023. ADP, LLC acts as the billing and collection agent for certain fees which are remitted to Creative Planning, LLC pursuant to a service agreement. Reliance Trust Company does not charge the plan directly for any services provided. ADP, LLC compensates the trustee directly for services rendered.

Notes receivable from participant transactions also qualify as party-in-interest transactions.

All of the above party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

4. TERMINATION OF PLAN

Although it has not expressed any intent to do so, the plan sponsor has the right to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions and related earnings.

5. INCOME TAX STATUS

The plan is operating under an ADP, LLC Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA Plan which received a favorable opinion letter on October 6, 2020. The letter provided by the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan administrator has not obtained a separate Internal Revenue Service opinion or determination letter for the plan. However, the plan administrator and tax counsel believe that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and, therefore, believes the plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize tax liabilities (or assets) for any uncertain tax positions taken by the plan that more likely than not would not be sustained upon examination by the

applicable authorities. Plan management analyzed the requirements for accounting for such uncertain tax positions taken and determined the plan was not required to recognize any tax liabilities (or assets) related to uncertain tax positions taken as of December 31, 2024 and 2023 and September 30, 2023. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress.

6. INFORMATION CERTIFIED BY TRUSTEE

Management has obtained certifications from Reliance Trust Company, a qualified institution under the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, that state the following information with respect to assets held for investment of the plan is complete and accurate.

- a. Investments held and the fair values of such and notes receivable from participants as of December 31, 2024 and 2023 and September 30, 2023;
- b. Dividends from investments and net appreciation (depreciation) in fair value of investments and interest income on notes receivable from participants for the year ended December 31, 2024 and the period ended December 31, 2023; and
- c. Purchases and sales of investments for the year ended December 31, 2024 and the period ended December 31, 2023; and
- d. Contributions to, investment income (loss) credited to, benefits paid from, transfers and transfers between investment accounts for the year ended December 31, 2024 and the period ended December 31, 2023.

7. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

As discussed in Note 1, the financial statements are prepared under the accrual method of accounting wherein additions and deductions are reflected in the period earned or incurred. The plan's Form 5500 was prepared under the cash basis method of accounting. As a result, the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023 and September 30, 2023 and the related statements of changes in net assets available for benefits for the year ended December 31, 2024 and for the period ended December 31, 2023 differed from the Form 5500s.
