These additional procedures included comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with US GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Tri-Arc Food Systems, Inc. (the Company) 401(k) Plan (the Plan) is provided for general information only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time employees of the Company who have performed at least one year of service (as defined by the Plan document) and are age 21 or older. The Plan was established effective January 1, 1988 and adopted a prototype plan in 2008. The effective date of the most recent amendment of the Plan was May 1, 2021. It is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Participant Contributions

Annual contributions to the Plan consist of:

Participant tax-deferred contributions up to 100% of total compensation, not to exceed a maximum of \$23,000 for the year ended December 31, 2024, as prescribed by the Internal Revenue Code (the Code). In accordance with the Code, participants 50 years of age and older may also make additional catch-up contributions of up to \$7,500 for the year ended December 31, 2024, for a maximum contribution of \$30,500.

Company matching contributions are discretionary. The Company matching contribution was \$0.30 for every \$1.00 of the employee salary deferral contribution up to 6% of their compensation for the Plan year ended December 31, 2024.

Participant Accounts

Each participant's account is credited, or charged, as applicable, with the participant's contribution, the Company's contribution, if any, an allocation of investment earnings and losses, and an allocation of certain expenses. Allocations of investment earnings or losses are based on participant's account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company contribution portion of the participant's accounts is based upon the number of years of continuous service according to the following schedule:

Payment of Benefits

Upon termination of service due to death, disability, termination or retirement, the vested interest of the account balance is payable to the participant (or beneficiary, if participant is deceased). Participants may also receive a distribution upon attaining age 59½, or for financial hardship. The form of payment available includes installments, single lump-sum payments or a direct rollover distribution into an eligible retirement plan.

Forfeitures

Forfeited balances of terminated participants' nonvested accounts are used to reduce future Company contributions. Forfeited non-vested amounts of \$11,186 were applied to the Company's contributions in 2024. Forfeitures totaled \$75 and \$11,553 as of December 31, 2024 and 2023, respectively.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (US GAAP).

Investments and Income Recognition

The Plan's investments are held by the Trustee. The Plan's investments are stated at fair value (see Note 3 for additional information). Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The net appreciation, or depreciation, in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded at the ex-dividend date and interest income is recorded on the accrual basis.

Use of Estimates

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Administrative expenses, including recordkeeping fees, investment advisory fees, and fees for participant withdrawals, are generally paid out of the Plan assets; however, the Company may elect to pay expenses. In 2024, audit fees and investment advisory fees were paid by the Company.

Contribution Refunds Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Code are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the excess contributions for the 2024 and 2023 Plan years on March 6, 2025 and March 12, 2024 in the amounts of \$99,154 and \$114,544, respectively, to the applicable participants.

NOTE 3 - FAIR VALUE MEASUREMENTS

The Plan follows a framework for measuring and disclosing the fair value of its assets, as established by Accounting Standards Codification (ASC) 820, *Fair Value Measurement*. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from, or corroborated by, observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full-term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level of assets or liabilities within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds

The Plan's mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust

The Morley Stable Value Fund is a stable value collective trust valued at the NAV of units held. The NAV is used as a practical expedient to estimate fair value and is based on the fair value of the underlying assets less liabilities.

Withdrawals initiated by the Company will normally be provided at contract value as soon as practicable following written notice to the collective trust's trustee. The Plan must provide 12-months' notice to exit the collective trust investment in its entirety. There are no unfunded commitments for this investment.

NOTE 5 - PLAN TERMINATION

The Company has the right, at any time, to terminate the Plan, subject to the provisions of ERISA, by delivering to the Trustee written notice of such termination. Upon termination, all amounts credited to the affected participants' accounts shall become 100% vested and will not thereafter be subject to forfeiture, and all unallocated amounts shall be allocated to the accounts of all participants in accordance with the plan provisions.

The Company has no intention to terminate the Plan at this time.

NOTE 6 - INCOME TAX STATUS

The Company adopted a prototype non-standardized profit-sharing arrangement, which received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, which stated that the form of the prototype plan is designed in accordance with applicable sections of the Code. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS

Ascensus served as the trustee and the recordkeeper for the Plan during the Plan year.

Ascensus provides certain administrative services to the Plan and receives revenue from mutual fund and collective trust service providers for services Ascensus provides to the funds. This revenue is used to offset certain amounts owed to Ascensus for their administrative services to the Plan.

If the revenue received from such mutual fund or collective trust service providers exceeds the amount owed, Ascensus will remit the excess to the Plan on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2024, there were no excess amounts. The Plan or Company may make a payment to Ascensus for administrative expenses not covered by revenue sharing.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan's investment strategies include investments that are exposed to varying degrees of risk, such as interest rates, credit, and overall market volatility risks. Due to the level of risks associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.
