**NOTE 1 - DESCRIPTION OF PLAN**

The following description of The Hyster-Yale Materials Handling, Inc. Profit Sharing Retirement Plan (f/k/a Hyster-Yale Group, Inc. Profit Sharing Retirement Plan) (the "Plan") provides only general information. Reference should be made to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The Plan benefits eligible employees, as defined, of Hyster-Yale Materials Handling, Inc. (f/k/a Hyster-Yale Group, Inc.) (the "Company").

Effective January 1, 2024, Hyster-Yale Group, Inc. was renamed to Hyster-Yale Materials Handling, Inc. and the Plan was renamed to The Hyster-Yale Materials Handling, Inc. Profit Sharing Retirement Plan.

Plan Administration: The investments of the Plan are held in a trust by Vanguard Fiduciary Trust Company (the "Trustee"). The Trustee performs investment management and recordkeeping responsibilities for the Plan.

Contributions: Substantially all full-time salaried and hourly employees of the Company are eligible to participate in the Plan.

Each participating employee may elect to contribute from 1% to 25% of compensation to the Plan on a before-tax basis, subject to the limitations of the Internal Revenue Code ("IRC"). For employees hired on or after January 1, 2018 the Plan provides (i) automatic enrollment of eligible employees in the Plan with a 6% pre-tax deferral (3% for new employees hired prior to January 1, 2018, but on or after July 12, 2004) and (ii) an annual 1% increase in the amount of a participant's deferral percentage, unless, in either case the employee elects to waive these procedures. The Plan allows participants who have attained age 50 by the end of the Plan year to make catch-up contributions in accordance with IRC Section 414(v). Effective January 1, 2015, participants are able to make Roth after-tax contributions to the Plan. However, participants are no longer able to elect regular after-tax contributions to the Plan as of such date. Total employee contributions, however, may not exceed 25% of eligible compensation.

For participants who are employees of the Company, the amount of matching contributions is equal to 50% of the participants' first 6% of before-tax or Roth contributions, up to a maximum of 3% of the employee's compensation.

Additionally, for all eligible employees, the Plan provides a profit sharing component whereby the employer makes a minimum profit sharing contribution to eligible participant accounts based on the participant's age and compensation and an additional profit sharing contribution based upon the attainment by the employer of certain predefined financial targets.

An additional profit sharing contribution of \$23,433,739 was made by the Company to the Plan for the 2024 plan year. The contribution was made under an age-weighted, integrated formula as warranted by the Company's operating profit percentage.

Participants may direct their contributions and any related earnings into investment options in 1% increments. Participants may change their investment elections daily.

Participants are also permitted to contribute rollover amounts representing distributions from other qualified retirement plans.

Vesting: Participants are immediately vested in the portion of their account that is attributable to their contributions and rollover contributions. Employees hired prior to October 1, 2002, are fully vested at all times in their contributions, employer qualified non-elective contributions, if any, and employer-matching contributions. Profit sharing contributions for all employees and employer-matching contributions for those employees hired after October 1, 2002, vest at the rate of 20% per year over a five-year period.

Participants who reach normal retirement age, die, become disabled, or die during qualified military service while employed are fully vested in their entire account.

Benefits: Benefits equal to the vested value of the participant's account are payable upon retirement, termination, permanent disability or death. Partial or full withdrawals of the participant's account balance are also available under certain circumstances as described in the Plan. Participants may elect the form of payment including lump-sum payment or installment payments over a certain period not extending beyond the life expectancy of the participant or the joint life expectancy of the participant and spouse, if applicable.

Under the Plan, a participant who is an employee may at any time withdraw their regular after-tax contributions and rollover contributions plus earnings on those contributions. Additionally, a participant who is an employee and who has attained age 59-1/2 may withdraw before-tax contributions, Roth after-tax contributions and vested matching contributions and earnings on those contributions. Before-tax contributions and earnings on these contributions made prior to January 1, 1989, may be withdrawn by a currently employed participant only in the case of an IRS-approved hardship. Other withdrawal provisions apply to certain participants, as required by law.

Forfeitures: Forfeitures of terminated participants' non-vested profit sharing and matching accounts are used to reduce future employer contributions and pay Plan administrative expenses. Forfeitures totaling \$700,000 were used to reduce employer contributions during the year ended December 31, 2024. At December 31, 2024 and 2023, forfeitures of \$813,856 and \$689,100, respectively, were available to reduce future contributions.

Notes Receivable from Participants: A participant may borrow up to the lesser of \$50,000 or 50% of his or her vested account balance (excluding profit sharing contributions) with a minimum note amount of \$1,000. Notes are repayable through payroll deductions. The repayment period is generally up to five years. However, if the note is for the purchase of a primary residence, the repayment period is up to ten years. The notes are secured by the participant's account and bear interest at a rate determined by the Hyster-Yale Materials Handling, Inc. Administrative Committee (the "Administrative Committee") based on prevailing market rates and is fixed over the life of the note.

Participant Accounts: Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and (b) Plan earnings (losses). Allocations are based on participant's earnings or account balances, as defined. Each participant account is charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants will become 100% vested in their account balances and the Plan's net assets would be distributed according to each participant's account balance.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates that affect the amounts reported in the financial statements, accompanying notes and supplemental schedules. Actual results could differ from those estimates.

Risks and Uncertainties: The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, liquidity and credit risks. Market risks include risks associated with ongoing global events. Due to the level of risk associated with certain investment securities and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Notes Receivable from Participants: Notes receivable from participants are recorded at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participant's balance.

Payment of Benefits: Benefits are recorded when paid.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

Fair value is defined as the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs for the asset or liability. Level 3 inputs include the Plan's own assumptions about the assumptions that market participants would use in pricing the asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following describes the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

*Mutual Funds:* The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

*Collective Trusts:* The fair values of participation units held in collective trust investments are based on the net asset value per unit as reported by fund managers. The funds provide for daily redemptions by the Plan at reported net asset value per share with no advance notice requirements. There are no unfunded commitments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 3 - CERTIFIED INFORMATION**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held as of December 31, 2024 and 2023, net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Vanguard Fiduciary Trust Company (the Trustee of the Plan).

**NOTE 4 - PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain investments of the Plan at December 31, 2024 and 2023 are mutual funds managed by Vanguard Group, Inc. The Plan also invests in a collective trust fund managed by the Trustee. The Trustee is a wholly owned subsidiary of Vanguard Group, Inc. therefore, these investments and investment transactions qualify as party-in-interest transactions. The Plan also had notes receivable from participants at December 31, 2024 and 2023 which constitute party-in-interest transactions. The Plan paid fees to the Vanguard Group, Inc. totaling \$494,639. However, these investments and transactions are not considered prohibited transactions.

**NOTE 5 - INCOME TAX STATUS**

The Plan has received a determination letter from the Internal Revenue Service ("IRS") dated January 9, 2017, stating that the Plan is qualified under Section 401(a) of the IRC and therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. Although the Plan has been amended since receiving the determination letter, Plan management believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC and therefore they believe the Plan is qualified and the related trust is tax-exempt.

U.S. generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to federal income tax examinations for years prior to 2021.

**NOTE 6 - SUBSEQUENT EVENTS**

Plan management has evaluated subsequent events for recognition and disclosure through October 15, 2025, which is the date the financial statements were available to be issued.
