### **Opinion**

**NOTE 1 - DESCRIPTION OF THE PLAN**

The Cascade Pension Trust 401(k) Plan (the "Plan") is a multi-employer defined contribution pension plan established by collective bargaining agreements between the International Brotherhood of Electrical Workers Local Union Nos. 280, 659, and 932 and the Oregon Pacific-Cascade Chapter of the National Electrical Contractors Association. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

THE PLAN DOCUMENTS INCLUDE DETAILED RULES FOR EACH SITUATION. PARTICIPANTS SHOULD REFER TO THE PLAN AGREEMENT AND ANY AMENDMENTS REGARDING SPECIFIC PROVISIONS OF THE PLAN.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**B. Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**C. Contributions**

Participants may elect to defer up to 100% of their eligible compensation subject to applicable Internal Revenue Code ("Code") limits. Participants of age 50 or older may make additional catch-up contributions of up to \$7,500 annually in 2024 and 2023.

Participants are allowed to make rollover contributions of amounts received from other tax-qualified retirement plans subject to approval of the plan administrator. Such contributions are deposited in the appropriate investment funds in accordance with the participant's investments.

**D. Employer Payroll Compliance Program**

Remittance reports were accepted as submitted, without examination or verification of employers' payroll records. The system of internal control provides for examination of employers' records under a separate payroll compliance program.

**E. Notes Receivable from Participants**

The Plan allows participants to borrow the lesser of 50% of his or her vested account balance or \$50,000. The minimum loan is \$1,000. All loans shall be payable in 60 months or less. The loans are secured by the balance in the participant's account and shall bear a rate of interest equal to the prime rate plus 1% on the date the loan is made. Notes receivable from participants at December 31, 2024, carry interest rates ranging between 4.25% and 9.50%.

**F. Payment of Benefits**

Benefits are recorded when paid.

**G. Vesting**

Participants are immediately vested at 100% for all contributions, rollovers and earnings.

**H. Participant Accounts**

Each participant's account is credited with the participant's contributions, rollover contributions, and Plan earnings. Plan assets are invested based solely on instructions received from participants.

Deceased participants or beneficiary's unclaimed participant accounts are removed from the participant accounts and either moved to an individual retirement account, if the amount is greater than \$1,000 but less than \$5,000, or held in a forfeiture account until the participant account is claimed. There were no forfeitures in 2024 and 2023.

**I. Reclassification**

Certain December 31, 2023 account balances have been reclassified to conform to the December 31, 2024 financial statement presentation.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

Accounting standards establish a fair value hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market.

Level 1 – Inputs are quoted prices in active markets.

Level 2 – Inputs are based on quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

Level 3 – Inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

**NOTE 3 - FAIR VALUE MEASUREMENTS (Continued)**

Level 2 investments consist of a pooled separate account is determined daily by adjusting the prior day's unit value by the increase or decrease in value of the underlying mutual funds less a management fee.

Unrealized appreciation or depreciation in the fair value of investments is reported as net unrealized appreciation of investments. Investment expenses are reported on the accrual basis.

**NOTE 4 - INCOME TAX STATUS**

No provision for federal income tax is made. The Plan obtained its latest determination letter on May 20, 2015, in which the Internal Revenue Service ("IRS") stated that the Plan, as then designed, was in compliance with the applicable requirements of the Code. The Plan administrator and legal counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 5 - PLAN TERMINATION**

Although the Board of Trustees has not expressed any intent to do so, the Board of Trustees has the right to terminate the Plan at any time subject to the provisions of ERISA.

**NOTE 6 - RISKS AND UNCERTAINTIES**

Plan investments are exposed to various risks such as interest rate, market fluctuations and credit risks. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the financial statements.

**NOTE 7 - RELATED PARTY TRANSACTIONS**

Certain Plan investments are managed by the custodian; therefore, these transactions qualify as party-in-interest transactions.

**NOTE 8 - DELINQUENT PARTICIPANT CONTRIBUTIONS**

During the year ended December 31, 2024, the Plan failed to remit \$18,299 of participant contributions within 15 business days after the month in which they were withheld as required by the Department of Labor. Failure to remit or untimely remittance of participant contributions constitutes a prohibited transaction under Department of Labor regulations. The Plan has fully restored lost earnings to the accounts of all affected participants from the loss date to the recovery date.
