## Independent Auditors' Report

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

In accordance with accounting principles generally accepted in the United States of America, the Plan has changed its basis of accounting from the ongoing basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditors' Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on these financial statements.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control-related matters that we identified during the audit.

#### **Other Matter - Supplemental Schedule Required by ERISA**

The supplemental schedule of assets (held at end of year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**(1) Description of the Plan**

The following description of the Foursight Capital, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan’s provisions, which are available from the Plan administrator.

- A. **General** – The Plan, which commenced on January 1, 2013, is a defined contribution plan covering all eligible employees of Foursight Capital, LLC (the “Company” or “Plan sponsor”), as defined in the Plan document. The Plan is designed to qualify under Sections 401(a) and 401(k) of the Internal Revenue Code (the “IRC”), as amended, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Retirement Committee is responsible for oversight of the Plan. The Retirement Committee determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

In March 2024, Plan participants were notified that the Plan would be terminated as a result of the Plan sponsor being acquired by another company. Participants employed with the Plan Sponsor as of the March 20, 2024 (the “Termination Date”), were given the option of rolling over their funds into the OneMain 401(k) Plan. Those participants that did not choose this option or were not employed by the Plan Sponsor as of the termination date were given the option of rolling over their funds into an Individual Retirement Account or receiving a distribution of available funds. Plan management distributed all Plan assets to the participant selected distribution option in an orderly manner prior to the end of 2024. For additional information see Note 3, Plan Termination

- B. **Contributions** – Full-time eligible employees were able to participate in the Plan upon reaching age 18 and completing three months of service. Part-time employees who completed 1,000 hours of service in the Plan year were also eligible to participate in the Plan. The Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 6% of eligible compensation. Participants were able to elect to contribute up to 100% of their annual eligible earnings on a pre-tax basis, subject to the maximum amount allowable by the Internal Revenue Service (“IRS”) (\$23,000 for participants to age 50 and \$30,500 for participants over 50 years of age for the year ended December 31, 2024). Participants were also able to make ROTH contributions on a post-tax basis and were able to contribute amounts representing distributions from other tax qualified retirement plans. Participants were also able to make in-plan ROTH rollover contributions and employee after tax contributions. Effective January 1, 2023, those automatically enrolled in the Plan were able to automatically have the deferral percentage increased by 1% each year on the participant’s anniversary of entrance into the Plan. Auto escalation of the deferrals ceased if a participant elected to change their deferral amount or the deferral percentage reached 10% of the participant’s eligible compensation.

Safe harbor employer matching QACA contributions were made annually by the Company if the employee had participated in the Plan during the year. The amount was contributed each pay period based on a match of 100% of a participant’s deferrals that did not exceed 2% of their eligible compensation and 50% of a participant’s elective deferrals that did not exceed 6% of their eligible compensation. A true-up contribution was made at year-end based upon the employees’ annual deferrals. Discretionary additional employer matching contributions were able to be made each pay period on employee deferrals and catch up deferrals by the Company if the employee participated in the Plan during that pay period and was considered a full-time employee or achieved 1,000 hours of service during the year. For the year ended December 31, 2024, there were no discretionary additional employer matching contributions. Each year, the Company was able to make a discretionary nonelective contribution to the Plan. Participants’ share of any discretionary nonelective

contributions was determined based on the method described in the Plan documents. For the year ended December 31, 2024, there were no discretionary nonelective contributions made to the Plan.

- C. **Participant accounts** – Each participant's account was credited with the participant's contributions, safe harbor QACA employer matching contributions, discretionary matching contributions, and an allocation of the Company's discretionary non-elective contributions (if any) and the Plan's earnings or losses, which included administrative expenses. Allocations were based on the participant's earnings or account balances, as defined in the Plan. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.
- D. **Vesting** – Effective January 1, 2019, and associated with the adoption of the QACA Amendment, the Plan was amended to provide for two-year cliff vesting. All participants hired prior to January 1, 2018 were considered 100% vested in all contributions regardless of years of service. Those participants hired between January 1, 2018 and January 1, 2019, were subject to a six-year graded vesting schedule.

Participants were immediately vested in their voluntary contributions, earnings thereon, and rollover contributions. Participants vested in the employer safe harbor QACA and discretionary additional employer matching contributions as follows:

Participants also became 100% vested when the participant reached normal retirement age (65), incurred a disability as defined by the Plan, or upon death.

All Plan participants that were actively employed with the Plan Sponsor on the Termination Date became 100% vested in the employer safe harbor QACA and discretionary additional employer matching contributions.

- E. **Investment options** – Upon enrollment in the Plan, a participant was able to direct contributions in any of the available investment options offered by the Plan, including collective investment trusts, mutual funds, and a guaranteed interest account. Unless limited by restrictions imposed by individual investment options and subject to redemption fees, participants were able to change their investment options on a daily basis.
- F. **Notes receivable from participants** – Participants were able to borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance with terms from 1 year up to 5 years. The notes were secured by the balance in the participant's account and bore interest at rates which were commensurate with local prevailing rates as determined by the Plan Administrator. As of December 31, 2024, there were no outstanding notes receivable due to the Plan termination. Principal and interest were paid ratably through bi-weekly payroll deductions and loan payoffs were able to be made directly by the participant without penalty.

- G. **Payment of benefits** – Participants were able to receive the vested interest of their Plan account through a distribution of benefits upon retirement, death, termination of employment, or a qualifying withdrawal. Benefit payments were made in a lump-sum distribution, installment payments or rollover contributions to another plan. Participants that terminated employment with a balance between \$1,000 and \$7,000 were able to have their account balance rolled by the Plan into an Individual Retirement Account upon termination. Participants who terminated with an account balance of less than \$1,000 were able to receive an automatic lump sum distribution.
- H. **Forfeited accounts** – As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0 and \$7,391, respectively. Forfeited non-vested accounts were used to offset future employer matching contributions or administrative expenses. During the year ended December 31, 2024, the majority of forfeited non-vested accounts were used to pay administrative expenses and residual amounts were used to offset employer contributions.

**(2) Summary of significant accounting policies**

**Basis of accounting** – The financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”). Due to the Plan Termination, as described in Note 3, the Plan has adopted the liquidation basis of accounting for the year ended December 31, 2024. The liquidation basis of accounting requires the Plan to accrue all additional expenses incurred related to the Plan Termination.

**Use of estimates** – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

**Investment valuation and income recognition** – Investments are reported at fair value, except for the guaranteed interest account, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Retirement Committee determines the Plan’s valuation policies utilizing information provided by the Custodian. See Note 5 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold, as well as held during the year.

**Contributions** – Contributions from Plan participants were recorded in the year in which the employee contributions were withheld from compensation. Employer contributions were recorded in the year in which the associated participant compensation is earned.

**Notes receivable from participants** – Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees were charged to the participant’s account as administrative expenses and were expensed when they were incurred.

**Payment of benefits** – Benefits were recorded when paid.

**(2) Summary of significant accounting policies**

**Administrative expenses** – Certain expenses of the Plan are paid by the Company and are not included in the statement of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants were charged directly to the participant’s account and were included in administrative expenses. Fees related to investment advisory and recordkeeping services are included in administrative expenses on the statement of changes in net assets available for benefits. Investment management related expenses are included in net appreciation in fair value of investments.

**(3) Plan termination**

As of March 20, 2024, the Plan Sponsor discontinued making contributions to the Plan. This action resulted in the Plan termination being considered imminent for accounting purposes. Subsequent to this date, all active employees of the Plan Sponsor that were making contributions to the Plan began making contributing to the OneMain 401(k) Plan. All Plan participants were given the option of rolling over their funds into the OneMain 401(k) Plan. Those participants that were employed by the Plan sponsor on the Termination Date but did not choose to roll their funds in to the new plan or participants that were not employed by the Plan Sponsor as of the termination date were given the option of rolling over their funds into an Individual Retirement Account or receiving a distribution of available funds. From the Termination Date through the end of the year, Plan management distributed all Plan assets to the participant selected distribution option in an orderly manner. As of December 31, 2024, all Plan assets had been distributed and all Plan liabilities had been settled by the Plan or transferred to the Plan Sponsor.

**(4) Information prepared and certified by the Custodians**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Annuity Insurance Company of America have certified the following data included in the accompanying financial statements and schedule of assets (held at end of year) with regards to the Plan’s guaranteed interest accounts and Empower Trust Company, LLC has certified the following data accompanying financial statements and supplemental schedule of assets (held at year end of year) with regards to the Plan’s collective investment trusts, mutual funds, and notes receivable from participants is complete and accurate with respect to investments as of December 31, 2024 and for the year ended December 31, 2024:

- Investments
- Notes receivable from participants
- Interest income on notes receivable from participants
- Interest and dividend income
- Net appreciation in fair value of investments
- Schedule of assets (held at end of year)

The Plan’s independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule of assets (held at end of year).

**(5) Fair value measurements**

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31 2024 and 2023.

*Collective investment trusts:* Valued daily at the Net Asset Value ("NAV") of units of the collective investment trusts. The NAV, as provided by the Custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investment held by the account less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) were able to occur daily. Were the Plan to initiate a full redemption of the collective investment trust, the investment advisor reserves the right to temporarily delay withdrawal from the account in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Mutual funds:* Valued at the daily closing price as reported by the funds. The funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

As of December 31, 2024, no investments were held by the Plan.

**(6) Guaranteed interest account**

The Plan has a fully benefit-responsive guaranteed interest contract with Empower Annuity Insurance Company of America ("EAICA") through a group annuity contract. EAICA maintains the contributions in a general account. Contract value, as reported to the Plan by EAICA, represents contributions made under the account, plus earnings, less participant withdrawals, and administrative expenses. The guaranteed interest contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula established by the contract issuer but may not be less than 0% annually. The crediting interest rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the contract issuer to terminate the agreement prior to the scheduled maturity date.

The contract meets the fully benefit-responsive investment contract criteria and therefore, is reported at contract value. Contract value is the relevant measurement attribute for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the Plan. Contract value, as reported by the Plan by Empower Insurance, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants were able to ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The average interest crediting rate as of the Termination Date was 1.53%.

The Plan's ability to receive amounts due are dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic or regulatory developments.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendment to the Plan document (including complete or partial termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. Unless distribution otherwise elected by individual participants, in connection with the Plan Termination, the asset was transferred to the OneMain 401(k) Plan, or an individual retirement account. No events occurred that limited the ability of the Plan to transact at contract value with the contract issuers and that limited the ability of the Plan to transact at contract value with the participants.

**(7) Party-in-interest transactions**

Certain investments of the Plan are managed by the Plan's Custodians. Therefore, these transactions are considered party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in investments, as they are paid through revenue sharing rather than a direct payment. As described in Note 2, certain other administrative expenses are paid from Plan assets directly to the Recordkeeper and other parties-in-interest and qualify as exempt party-in interest transactions. Administrative expenses paid from Plan assets directly to parties-in-interest totaled \$47,894 for the year ended December 31, 2024.

**(8) Tax status**

The Company has adopted a pre-approved plan document that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**(9) Risks and uncertainties**

The Plan invested in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
