### Note 1 - Plan Description

The following description of Inspire11 401(K) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all employees of Inspire11 LLC (the "Company") who are age 18 or older except for leased employees, nonresident alien employees, and union employees. Employees are permitted to enter the Plan on the first day of the pay period after or coincident with the date eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

The Plan provides for employee salary deferral contributions subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants who have attained age 50 may make catch-up contributions in addition to their regular deferral contributions. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

Effective January 1, 2023, the Company amended the Plan to change its safe harbor matching contributions to a flexible discretionary match. For the years ended December 31, 2024 and 2023, the Plan provides for employer flexible discretionary matching contributions of 100 percent of the participant's contribution, not to exceed 3 percent of the employee's deferred compensation, plus 50 percent of the participant's contribution between 3 and 5 percent.

The Company may make additional discretionary contributions. Participants who are employed on the last day of the plan year, regardless of the months of service completed during the plan year, will be eligible to receive an allocation of the Company's additional discretionary contribution. There was no additional discretionary contribution in 2024.

Certain participant contributions in 2023 were paid after the time frame required by the Department of Labor. The Company remitted these contributions in 2023 and the related lost interest during 2024.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

#### **Participant Notes Receivable**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of 50 percent of their account balances, not to exceed \$50,000. Notes receivable are collateralized by the participant's account balance and bear interest at a market rate. Principal and interest are paid ratably through direct participant payments.

#### **Benefit Payments**

On termination of service due to death, disability, retirement, or other reasons, a participant (or the participant's beneficiary in the case of death) may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

After age 59½, a participant may make withdrawals of 401(k) contributions, employer contributions, and/or rollover contributions and related investment earnings, which are subject to income tax to the participant at ordinary rates.

**Note 1 - Plan Description (Continued)**

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan agreement.

***Vesting***

Participants' contributions and the employer additional discretionary contributions and related earnings are fully vested at all times and are not subject to forfeiture for any reason.

Effective January 1, 2023, vesting in the Company's employer flexible discretionary matching contribution portion of participant accounts, plus actual earnings thereon, is based on years of service according to the following schedule. All participants eligible for employer flexible discretionary matching contributions prior to January 1, 2023 remain 100 percent vested in all employer contributions.

***Termination***

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances. The Company determined that it terminated the Plan effective September 30, 2025.

**Note 2 - Summary of Significant Accounting Policies**

***Investment Valuation and Income Recognition***

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

***Benefit Payments***

Benefits are recorded when paid.

***Administrative Expenses***

Various administrative costs are paid by the Company.

## Note 2 - Summary of Significant Accounting Policies (Continued)

### *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

### *Risks and Uncertainties*

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

### *Subsequent Events*

On September 30, 2025, the Company was acquired by Insight Enterprises, Inc. Concurrent with the acquisition, the Inspire11 401(K) Plan was terminated effective September 30, 2025. As part of the termination process, participants will elect to either roll over their account balances into the Insight Enterprises, Inc. 401(K) Plan or receive a cash distribution. Liquidation was deemed imminent during 2025, when the termination was approved, and, as a result, the Plan will adopt the liquidation basis of accounting in 2025.

The financial statements and related disclosures include evaluation of events up through and including October 13, 2025, which is the date the financial statements were available to be issued.

## Note 3 - Certified Information

Benefit Trust Company (the "Custodian") holds the Plan's investments and executes all related transactions. The investment balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Custodian.

## Note 4 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value. Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Fair values determined by Level 2 inputs use other inputs that are observable either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

### Note 4 - Fair Value Measurements (Continued)

In instances whereby inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The Plan measures mutual funds at fair value on a recurring basis at quoted prices reported in active markets. The fair value of mutual funds is based primarily on Level 1 inputs as described above.

### Note 5 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

### Note 1 - Plan Description

The following description of Inspire11 401(K) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all employees of Inspire11 LLC (the "Company") who are age 18 or older except for leased employees, nonresident alien employees, and union employees. Employees are permitted to enter the Plan on the first day of the pay period after or coincident with the date eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

The Plan provides for employee salary deferral contributions subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants who have attained age 50 may make catch-up contributions in addition to their regular deferral contributions. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

Effective January 1, 2023, the Company amended the Plan to change its safe harbor matching contributions to a flexible discretionary match. For the years ended December 31, 2024 and 2023, the Plan provides for employer flexible discretionary matching contributions of 100 percent of the participant's contribution, not to exceed 3 percent of the employee's deferred compensation, plus 50 percent of the participant's contribution between 3 and 5 percent.

The Company may make additional discretionary contributions. Participants who are employed on the last day of the plan year, regardless of the months of service completed during the plan year, will be eligible to receive an allocation of the Company's additional discretionary contribution. There was no additional discretionary contribution in 2024.

Certain participant contributions in 2023 were paid after the time frame required by the Department of Labor. The Company remitted these contributions in 2023 and the related lost interest during 2024.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

#### **Participant Notes Receivable**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of 50 percent of their account balances, not to exceed \$50,000. Notes receivable are collateralized by the participant's account balance and bear interest at a market rate. Principal and interest are paid ratably through direct participant payments.

#### **Benefit Payments**

On termination of service due to death, disability, retirement, or other reasons, a participant (or the participant's beneficiary in the case of death) may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

After age 59½, a participant may make withdrawals of 401(k) contributions, employer contributions, and/or rollover contributions and related investment earnings, which are subject to income tax to the participant at ordinary rates.

**Note 1 - Plan Description (Continued)**

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan agreement.

***Vesting***

Participants' contributions and the employer additional discretionary contributions and related earnings are fully vested at all times and are not subject to forfeiture for any reason.

Effective January 1, 2023, vesting in the Company's employer flexible discretionary matching contribution portion of participant accounts, plus actual earnings thereon, is based on years of service according to the following schedule. All participants eligible for employer flexible discretionary matching contributions prior to January 1, 2023 remain 100 percent vested in all employer contributions.

***Termination***

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances. The Company determined that it terminated the Plan effective September 30, 2025.

**Note 2 - Summary of Significant Accounting Policies**

***Investment Valuation and Income Recognition***

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

***Benefit Payments***

Benefits are recorded when paid.

***Administrative Expenses***

Various administrative costs are paid by the Company.

## Note 2 - Summary of Significant Accounting Policies (Continued)

### *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

### *Risks and Uncertainties*

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

### *Subsequent Events*

On September 30, 2025, the Company was acquired by Insight Enterprises, Inc. Concurrent with the acquisition, the Inspire11 401(K) Plan was terminated effective September 30, 2025. As part of the termination process, participants will elect to either roll over their account balances into the Insight Enterprises, Inc. 401(K) Plan or receive a cash distribution. Liquidation was deemed imminent during 2025, when the termination was approved, and, as a result, the Plan will adopt the liquidation basis of accounting in 2025.

The financial statements and related disclosures include evaluation of events up through and including October 13, 2025, which is the date the financial statements were available to be issued.

## Note 3 - Certified Information

Benefit Trust Company (the "Custodian") holds the Plan's investments and executes all related transactions. The investment balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Custodian.

## Note 4 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value. Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Fair values determined by Level 2 inputs use other inputs that are observable either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

### Note 4 - Fair Value Measurements (Continued)

In instances whereby inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The Plan measures mutual funds at fair value on a recurring basis at quoted prices reported in active markets. The fair value of mutual funds is based primarily on Level 1 inputs as described above.

### Note 5 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

### Note 6 - Reconciliation of the Financial Statements to Form 5500
