### Note 1: Description of Plan

The following description of the Fox Valley Fire & Safety Co. Employee Stock Ownership Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan is an employee stock ownership plan (ESOP) covering all full-time employees of Fox Valley Fire & Safety Company, Inc. (the "Company") who are age 18 or older. Employees must complete one year of service and at least 1,000 hours, as defined in the Plan document, to be eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan owns 100% of the Company's outstanding shares of common stock.

#### Contributions

The Company may make annual discretionary contributions to the Plan, subject to Board approval and compliance with Internal Revenue Code. Contributions may be made in cash or Company Stock, with cash contributions required to meet any maturing ESOP loan obligations. Stock contributions are valued at fair market value as determined by an independent appraiser. Contributions are due by the end of the fiscal year and must be paid no later than the Company's federal income tax filing deadline, including extensions. For the year ended December 31, 2024, there were discretionary contributions of \$3,399,961. Contributions are subject to certain IRS limitations.

#### Participant Accounts

Each participant's account is credited as of the last day of each Plan year with an allocation of shares of the Company common stock released by the Trustee from the unallocated account, if applicable, and forfeitures of terminated participants' non-vested accounts. Only those participants who are eligible employees of the Company as of the last day of the Plan year will receive an allocation. Allocations are based on a participant's eligible compensation, relative to total eligible compensation.

#### Vesting

Vesting in the Company's common stock plus actual earnings (losses) thereon is based on years of continuous service. Participants vest at a rate of 20% per year beginning with the second year of service. Participants become fully vested after six years of service. Participants are considered to have completed one year of service for purpose of vesting upon the completion of 1,000 hours of service at any time during 12 consecutive months.

#### Forfeitures

Forfeited nonvested accounts will be allocated based upon the relation of the participant's compensation to total compensation for the Plan year. At December 31, 2024 and 2023, the balance in the forfeiture account was \$0. Forfeitures of terminated nonvested shares allocated to remaining participants at December 31, 2024 and 2023, totaled shares of 9 and 32, respectively.

### Note 1: Description of Plan (Continued)

#### Payment of Benefits

No distributions from the Plan will be made until a participant retires, becomes disabled, dies (in which case, payment shall be made to his or her beneficiary or, if none, their legal representatives), or otherwise terminates employment with the Company. Distributions in the case of participants who die, become disabled, or retire shall be made in the form of Company common stock, subject to the requirement that the Company common stock be sold to the Company or back to the Plan at fair value. Participants who terminate their employment from the Company for any other reason shall receive a cash distribution. The Company or the Trustee have the option to pay the purchase price of the Company common stock in a lump sum or in equal installments with reasonable interest over a period not to exceed five years.

#### Suspense Account for Unallocated Shares

The Plan maintains a suspense account intended to allocate all shares of Company Stock that the Trustee acquires with the proceeds of an ESOP Loan. These unallocated shares shall be released from the suspense account at the time as allowed in the Plan documents and then shall be allocated to Participants' Company Stock Accounts.

The Plan did include unallocated shares unrelated to an exempt loan or to forfeitures in the suspense account which is described in the provision of the Plan document. For the Plan year ended December 31, 2024, there were 951 shares removed from this suspense account and retired by the Plan Sponsor. None of these shares were allocated to participant accounts during the year ended December 31, 2024.

#### Voting Rights

Each participant is entitled to exercise voting rights attributable to the shares allocated to their account and is notified by the Trustee prior to the time that such rights are to be exercised. The Trustee is not permitted to vote any allocated shares for which instructions have not been given by a participant. The Trustee was required, however, to vote any unallocated shares on behalf of the collective best interest of Plan participants and beneficiaries.

#### Put Option

Under Internal Revenue Service (IRS) income tax regulations, the Company common stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its common stock distributed to participants for which there is no market. The put price is representative of the fair value of the common stock. The Company can pay for the purchase over a period of five years with interest. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

#### Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments which are more diversified.

#### **Diversification** (Continued)

Participants who are at least age 55, with at least 10 years of participation in the Plan, may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25 percent of the number of post-1986 shares allocated to their account, less any shares previously diversified. In the sixth year, the percentage changes to 50 percent. Participants who elect to diversify receive a cash distribution.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### **Use of Estimates**

The preparation of the accompanying financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Management's estimate of the common stock price is based on a valuation performed by a third party analyst. Actual results may differ from these estimates.

#### **Cash Equivalents**

The Plan considers all highly liquid investments with original maturities of three months or less, including money market fund investments, to be cash equivalents.

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Company stock is valued annually by an independent appraiser. The Company stock value provided by the independent appraiser is the stock's fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Payment of Benefits**

Benefits are recorded when paid.

### Note 2: Summary of Significant Accounting Policies (Continued)

#### SECURE Act 2.0

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Management has evaluated those provisions and determined there is no material impact on the Plan.

#### Subsequent Events

The Plan has evaluated subsequent events through October 15, 2025, which is the date the financial statements were available to be issued.

### Note 4: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Fox Valley Fire & Safety Co. common stock:* Value based upon an independent appraisal. This appraisal was based upon a combination of the market and income valuation techniques consistent with prior years. The appraiser took into account historical and projected cash flow and net income, return on assets, return on equity, market comparables and estimated fair value of company assets and liabilities.

### Note 4: Fair Value Measurements (Continued)

The valuation process involves Plan management's selection of an independent appraiser. Plan management accumulates the data for the appraiser from historical and projected financial information of the Company. The appraiser prepares a preliminary report which Plan management reviews in detail, discusses and approves.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables set forth by level, within the fair value hierarchy, the Plan's investment assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement:

### **Note 5: Related-Party Transactions and Party-in-Interest Transactions**

The Plan's assets, which consist principally of Fox Valley Fire & Safety Co.'s common stock, are held by the Trustee of the Plan. Company contributions are held and managed by the Trustee, which invests cash, receives interest and dividends, and makes distributions to participants.

Certain administrative functions are performed by officers or employees of the Company or its subsidiaries. No such officer or employee receives compensation from the Plan. Administrative expenses for the Plan are paid directly by the Company.

### **Note 6: Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Plan contributions. Additionally, the Employee Benefits Administration Committee shall direct the Trustee to pay all liabilities and expenses of the trust fund and to sell unallocated shares of financed common stock to the extent it determines such sale to be necessary in order to repay the loan, if any.

### **Note 7: Tax Status**

The IRS has determined and informed the Plan by a letter dated February 19, 2015, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax years in progress.

The Company discovered errors with the administration of the ESOP that violate the IRC and is in the process of drafting proposed corrections to these errors that it intends to submit to the IRS under its voluntary correction program (VCP) in order to have the IRS review and approve the proposed corrections, obtain a compliance statement from the IRS, and maintain the tax-exempt qualified status of the ESOP. On December 31, 2024, the Company submitted the VCP filing and is currently awaiting response from the IRS.

### **Note 8: Risks and Uncertainties**

The Plan invests in Fox Valley Fire & Safety Co.'s common stock. The Company's common stock is exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with the Company's common stock, it is at least reasonably possible that changes in values of the Company's common stock will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
