## **Independent Auditors' Report**

To the Board of Directors of Innovations for Poverty Action  
as Sponsor of Innovations for Poverty Action 401(k) Profit Sharing Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed the audits of the financial statements of Innovations for Poverty Action 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

**NOTE 1 – DESCRIPTION OF PLAN**

The following description of the Innovations for Poverty Action 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

- A. **General** — The Plan is a defined contribution plan established to provide retirement benefits for eligible employees of Innovations for Poverty Action (the “Company”) who have completed at least three months of service and have reached the age of 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan document was restated at January 1, 2022.

A Plan amendment was executed on June 12, 2023 which was effective on September 1, 2023. The Plan permits Roth elective deferrals and new loans.

- B. **Eligibility** — All employees, except non-resident aliens and residents of Puerto Rico are eligible to participate in the Plan. Participants are eligible to participate in the Plan upon reaching the age of 21 and completing three months of service.

- C. **Contributions** — From January 1, 2019 through October 31, 2019, participants could contribute between 1% and 90% of compensation, as defined in the Plan. As of November 1, 2019, participants may contribute between 1% and 50% of compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect otherwise. Automatically enrolled participants have their deferral rate set at 1% of eligible compensation, and their contributions are invested in a designated fund until changed by the participant. The Company contributes 100% of the first 1% of compensation that a participant contributes to the Plan, and 50% of the next 4% of compensation that a participant contributes to the Plan. In addition, the Company may make additional nonelective contributions at the discretion of the Board of Directors. The Company did not make any additional nonelective contributions for the years ended December 31, 2024 and 2023. All contributions are subject to certain limitations imposed by the Plan and the Internal Revenue Code (the “Code”).

- D. **Participant Accounts** — Each participant’s account is credited with the participant’s contributions and Company contributions, and allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations of Company contributions, investment income and administrative expenses are based on participants’ compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested accounts.

- E. **Investment Options** — Participants may direct their contributions into any of the funds offered by the Plan, which are held at Reliance Trust Company (“Reliance” and the “Investment Custodian”). These funds include a variety of investment options with various objectives and degrees of financial risk.

- F. **Vesting** — Participants are immediately vested in their deferral, rollover, matching and profit-sharing contributions, including the earnings on those amounts. Participants are 100% vested in employer nonelective contributions upon entering the Plan.

- G. **Payment of Benefits** — Upon retirement, disability, death or termination of employment, the participant shall become entitled to the total value of his or her vested account. Distributions will be paid in a lump sum or in installments over a number of years, based upon election of the participant or as defined in the Plan or the Code.

H. **Notes Receivable from Participants** — Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at a commercially reasonable rate as determined for similar types of loans by other lenders. At December 31, 2024, the interest rate was at 10.50% with a maturity through 2026. Only one outstanding loan is permitted at any one time, per participant. All loans are considered a direct investment of the participant, and payments of principal and interest are credited to the participant's account. Principal and interest is paid ratably through bi-weekly payroll deductions. A loan that is considered in default is reported as a deemed distribution, which is a taxable event for the participant.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

A. **Basis of Accounting** — The financial statements of the Plan are prepared under the accrual basis of accounting. The Plan adheres to accounting principles generally accepted in the United States of America ("U.S. GAAP").

B. **Use of Estimates** — The preparation of financial statements in conformity with U.S. GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

C. **Investment Valuation and Income Recognition** — Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

D. **Payment of Benefits** — Benefits are recorded when paid.

E. **Plan Expenses** — Certain expenses of maintaining the Plan are paid directly by the Company. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

F. **Notes Receivable from Participants** — Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024. If a participant ceases to make loan repayments and the Plan sponsor deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

G. **Regulatory Compliance Affecting Retirement Plans** — The Setting Every Community Up for Retirement Enhancement Act of 2019 (SECURE 1.0 Act) became law on December 20, 2019. The SECURE Act made major changes to the Required Minimum Distribution ("RMD") rules, increasing the age from 70 ½ to 72 to participants over 72 after January 1, 2020. Plans were required to be formally amended for certain other changes if adopted on or before the last day of the 2023 plan year.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

The SECURE Act 2.0 (SECURE 2.0) was signed into law in December 2022, delivering dozens of new retirement-related provisions. These changes build on the original SECURE Act of 2019, which altered the rules around how employees can save and withdraw money from their retirement accounts. SECURE 2.0 further increased the age of RMDs, increased the catch-up contributions for older workers and required automatic enrollment for new plans. The SECURE 2.0 Act increased the age at which individuals must begin taking RMDs to 73 from 72, beginning January 1, 2023, as well as other increases starting in 2030. The SECURE 2.0 Act increases the limit for catch-up contributions for individuals ages 60 to 63, effective for taxable years beginning after December 31, 2024.

In addition, the SECURE 1.0 Act and further by the SECURE 2.0 Act lowered the eligibility requirements to enable part-time workers to participate in 401(k) plans. These rules for long-term, part-time workers are expanded to apply to ERISA 403(b) plans, as well. The SECURE 2.0 Act changes the eligibility requirements under 401(k) so that it is easier for part-time employees to participate in them. The enacted law, the SECURE 1.0 Act, allows plans to limit eligibility for participation of part-time employees who reach the later of: (1) age 21 or completion of one 12-month period in which the employee worked at least 1,000 hours (pre-SECURE 1.0 Act rule); or (2) three consecutive years of service with 500 or more hours in each year. Under the SECURE 2.0 Act, a plan must allow a part-time employee to participate if the employee has either satisfied the above rule #1, or if the employee has completed two consecutive 12-month periods in which the employee worked at least 500 hours in each one of the two periods and reached age 21 by the end of the second 12-month period.

**NOTE 3 – INVESTMENTS – INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE AS COMPLETE AND ACCURATE**

As noted in the independent auditors' report, the Plan sponsor has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") *Rules and Regulations for Reporting and Disclosure* under ERISA. Accordingly, as permitted under such election, the following information and information included in the supplemental schedule were certified as complete and accurate by the Plan's trustee, Reliance, and were not subjected to any auditing procedures performed by the independent auditors except for comparing such information to information included in the Plan's financial statements.

The Plan's trustee has certified to the completeness and accuracy of the investments included in the financial statements as of December 31, 2024 and 2023, and investment activity included in the financial statements for the years then ended, as summarized below:

**NOTE 4 – FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board Accounting Standards Codification (“FASB ASC”) 820, “Fair Value Measurement,” provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the assets or liabilities; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Assets valued using the Net Asset Value (“NAV”) practical expedient are not required to be reported within the hierarchy.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual Funds:**

Mutual funds are valued using Level 1 inputs, which consist of the quoted price of shares held by the Plan at year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Common Collective Trusts:**

The funds may hold investments in units of other funds within the trust or similar funds for which other unrelated entities are trustee. The trustee or an unrelated trustee estimates the fair value of investments in collective funds that have calculated NAV per unit in accordance with the specialized accounting guidance for investment companies. Accordingly, as a practical expedient, investments in other such funds are valued at their NAV as reported by the investee funds. The funds have the ability to redeem their investments in collective funds at NAV.

**NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS**

Plan investments as of December 31, 2024 and 2023 are held by Reliance Trust Company, the Trustee of the Plan. Fees are paid by Plan participants. Fees paid by Plan participants to ADP for investment management services and recordkeeping amounted to \$24,660 and \$19,591 for the years ended December 31, 2024 and 2023, respectively, and are reflected in administrative expenses in the statements of changes in net assets available for benefits.

**NOTE 6 – INCOME TAX STATUS**

The Plan has adopted a non-standardized prototype plan that received a favorable opinion letter from the Internal Revenue Service (“IRS”) dated October 6, 2020, that it was in compliance with the applicable requirements of the Code. The Plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Code. Therefore, the Plan administrator believes the Plan was qualified and the related trust was tax exempt as of the financial statement date.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**NOTE 8 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participant’s account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 9 – EXCESS CONTRIBUTIONS**

During the year ended December 31, 2023, certain 2022 participant contributions were deemed to be excess contributions under the Code. Such contributions and the related investment earnings thereon were refunded to Plan participants in 2023 in the amount of \$2,968.

**NOTE 10 – PROHIBITED TRANSACTIONS**

In 2023, the Sponsor withheld deductions from one ineligible participant salary for \$250. A portion of the contributions plus interest of \$192 was refunded to the participant in December 2023. The remaining amount of the contributions plus interest of \$62 was refunded in January 2024.

**NOTE 11 – SUBSEQUENT EVENTS**

Management has evaluated, for potential recognition and disclosure, events subsequent to the statement of net assets available for benefits date through October 3, 2025, the date the financial statements were available to be issued.
