### Report on the Audit of the Financial Statements

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of MDRS Holdings, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 

**NOTE 1 DESCRIPTION OF PLAN**

The following description of the MDRS Holdings, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement, as well as any amendments, for a more complete description of the Plan's provisions.

**General**

The Plan was established on January 1, 2001, in accordance with Section 401(k) of the Internal Revenue Code (IRC). Effective January 1, 2022, the Plan name was changed from Measurement Driven Rehabilitation Systems, Inc. & Affiliates 401k Profit Sharing Plan to MDRS Holdings, Inc. 401(k) Profit Sharing Plan (the Plan). It is a multiple employer defined contribution plan covering substantially all employees of Measurement Driven Rehabilitation Systems, Inc. and Measurement Driven Rehabilitation Services Management (collectively the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The purpose of the Plan is to provide retirement benefits for substantially all employees who are age 21 or older. The service requirement to enter the Plan and received employer contributions was to have completed six months of service with the Company until April 1, 2024, when the Plan was amended to reduce the service requirement to two months. The Plan's administrators determine the appropriateness of the Plan's investments and monitor investment performance.

**Contributions**

The Plan includes a salary deferral arrangement allowed under Section 401(k) of the IRC. Participants may elect to contribute up to 100% of eligible pretax or post-tax compensation, which is not to exceed the limits of the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. In accordance with the Plan document, the Company can make discretionary matching contributions to the Plan. In 2023, the Company elected to match 10% of participant deferrals. For the Plan year ended December 31, 2024, the Company's discretionary matching contributions totaled \$109,536. The Plan also allows the Company to make discretionary nonelective contributions to eligible employees. No discretionary nonelective contribution was elected in 2024.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and (b) Plan earnings or losses and charged with an allocation of administrative expenses. Allocations are based on participant contributions, participant earnings, investment elections, and/or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from 1 to 5 years, or up to 15 years for the purchase of a principal residence. The notes are secured by the balance in the participant's account and bear interest at a rate of the published Wall Street Journal prime rate plus 1%. Principal and interest are paid ratably through payroll deductions.

**Benefit Payments**

Upon termination of service due to death, disability, or retirement, a participant may elect to receive the value of the vested interest in their account in the form of a lump sum distribution or installments. The Plan allows for in-service distributions if a participant reaches age 59½ and hardship distributions subject to Plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan administrator will authorize the benefit payment without the participant's consent. If the balance of the terminated participant's account is between \$1,000 and \$7,000, the Plan Sponsor may authorize that the benefit payment be rolled into an individual retirement account in the participant's name.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary matching and profit sharing contributions plus actual earnings thereon is based on years of service according to the following schedule:

Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death, or permanent disability.

**Forfeitures**

The unvested portion of a terminated participant's account will be forfeited and used to reduce future Company contributions or to pay Plan expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$6,996 and \$11,859, respectively. During the year ended December 31, 2024, \$9,829 of forfeitures were used to reduce employer contributions or pay Plan expenses.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America. References to the ASC hereafter refer to the Accounting Standards Codification established by the Financial Accounting Standards Board (FASB) as the source of authoritative accounting principles generally accepted in the United States of America.

**Plan Fees and Administrative Expenses**

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee received compensation from the Plan. A majority of administrative expenses incurred by the Plan are absorbed by the Company. Investment management fees and operating expenses charged to the Plan for investments in the various funds are deducted from income earned on a daily basis and are reflected as a component of earnings (losses) on investments.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for a discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

**Payment of Benefits**

Benefits are recorded when paid.

**Cash and Cash Equivalents**

Cash and cash equivalents include cash held by the custodian and all highly liquid investments with a maturity of three months or less at the time of purchase.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

**NOTE 3 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 4 INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN**

Certain information disclosed in the accompanying financial statements and supplemental schedules, including noninterest bearing cash and investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividend income for the year ended December 31, 2024 was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Mid Atlantic Trust Company, the custodian of the Plan.

**NOTE 5 PLAN TERMINATION**

The Company has the right to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, all participants would become fully vested in their accounts. In 2025, the Plan Sponsor was sold, and on February 27, 2025, a resolution to terminate was adopted. The Plan is expected to fully liquidate before December 31, 2025.

**NOTE 6 TAX STATUS**

The Company adopted a Volume Submitter Profit Sharing Plan, which received a favorable opinion letter from the IRS, which stated that the Plan, as then designed, was in accordance with applicable sections of the IRC. The Plan has since been amended and restated. The Plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 FAIR VALUE MEASUREMENT**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2*– Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the assets or liabilities; or
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

**NOTE 7 FAIR VALUE MEASUREMENT (CONTINUED)**

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Level 1 Fair Value Measurements:* The fair value of the Plan's investments in mutual funds is based on quoted net asset values of the shares held by the Plan at year-end.



**NOTE 1 DESCRIPTION OF PLAN**

The following description of the MDRS Holdings, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement, as well as any amendments, for a more complete description of the Plan's provisions.

**General**

The Plan was established on January 1, 2001, in accordance with Section 401(k) of the Internal Revenue Code (IRC). Effective January 1, 2022, the Plan name was changed from Measurement Driven Rehabilitation Systems, Inc. & Affiliates 401k Profit Sharing Plan to MDRS Holdings, Inc. 401(k) Profit Sharing Plan (the Plan). It is a multiple employer defined contribution plan covering substantially all employees of Measurement Driven Rehabilitation Systems, Inc. and Measurement Driven Rehabilitation Services Management (collectively the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The purpose of the Plan is to provide retirement benefits for substantially all employees who are age 21 or older. The service requirement to enter the Plan and received employer contributions was to have completed six months of service with the Company until April 1, 2024, when the Plan was amended to reduce the service requirement to two months. The Plan's administrators determine the appropriateness of the Plan's investments and monitor investment performance.

**Contributions**

The Plan includes a salary deferral arrangement allowed under Section 401(k) of the IRC. Participants may elect to contribute up to 100% of eligible pretax or post-tax compensation, which is not to exceed the limits of the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. In accordance with the Plan document, the Company can make discretionary matching contributions to the Plan. In 2023, the Company elected to match 10% of participant deferrals. For the Plan year ended December 31, 2024, the Company's discretionary matching contributions totaled \$109,536. The Plan also allows the Company to make discretionary nonelective contributions to eligible employees. No discretionary nonelective contribution was elected in 2024.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and (b) Plan earnings or losses and charged with an allocation of administrative expenses. Allocations are based on participant contributions, participant earnings, investment elections, and/or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from 1 to 5 years, or up to 15 years for the purchase of a principal residence. The notes are secured by the balance in the participant's account and bear interest at a rate of the published Wall Street Journal prime rate plus 1%. Principal and interest are paid ratably through payroll deductions.

**Benefit Payments**

Upon termination of service due to death, disability, or retirement, a participant may elect to receive the value of the vested interest in their account in the form of a lump sum distribution or installments. The Plan allows for in-service distributions if a participant reaches age 59½ and hardship distributions subject to Plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan administrator will authorize the benefit payment without the participant's consent. If the balance of the terminated participant's account is between \$1,000 and \$7,000, the Plan Sponsor may authorize that the benefit payment be rolled into an individual retirement account in the participant's name.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary matching and profit sharing contributions plus actual earnings thereon is based on years of service according to the following schedule:

Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death, or permanent disability.

**Forfeitures**

The unvested portion of a terminated participant's account will be forfeited and used to reduce future Company contributions or to pay Plan expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$6,996 and \$11,859, respectively. During the year ended December 31, 2024, \$9,829 of forfeitures were used to reduce employer contributions or pay Plan expenses.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America. References to the ASC hereafter refer to the Accounting Standards Codification established by the Financial Accounting Standards Board (FASB) as the source of authoritative accounting principles generally accepted in the United States of America.

**Plan Fees and Administrative Expenses**

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee received compensation from the Plan. A majority of administrative expenses incurred by the Plan are absorbed by the Company. Investment management fees and operating expenses charged to the Plan for investments in the various funds are deducted from income earned on a daily basis and are reflected as a component of earnings (losses) on investments.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for a discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

**Payment of Benefits**

Benefits are recorded when paid.

**Cash and Cash Equivalents**

Cash and cash equivalents include cash held by the custodian and all highly liquid investments with a maturity of three months or less at the time of purchase.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

**NOTE 3 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 4 INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN**

Certain information disclosed in the accompanying financial statements and supplemental schedules, including noninterest bearing cash and investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividend income for the year ended December 31, 2024 was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Mid Atlantic Trust Company, the custodian of the Plan.

**NOTE 5 PLAN TERMINATION**

The Company has the right to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, all participants would become fully vested in their accounts. In 2025, the Plan Sponsor was sold, and on February 27, 2025, a resolution to terminate was adopted. The Plan is expected to fully liquidate before December 31, 2025.

**NOTE 6 TAX STATUS**

The Company adopted a Volume Submitter Profit Sharing Plan, which received a favorable opinion letter from the IRS, which stated that the Plan, as then designed, was in accordance with applicable sections of the IRC. The Plan has since been amended and restated. The Plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 FAIR VALUE MEASUREMENT**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2*– Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the assets or liabilities; or
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

**NOTE 7 FAIR VALUE MEASUREMENT (CONTINUED)**

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Level 1 Fair Value Measurements:* The fair value of the Plan's investments in mutual funds is based on quoted net asset values of the shares held by the Plan at year-end.

**NOTE 8 NET ASSET VALUE PER SHARE**

The Plan's common collective trust is stated at NAV at December 31, 2024 and 2023. Units held in the common collective trust are valued using the NAV practical expedient of the common collective trust as reported by the account managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the trust, minus its liabilities, and then divided by the number of units outstanding.

**NOTE 9 PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Mid Atlantic Trust Company, the qualified institution of the Plan; therefore, the investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net depreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 10 SUBSEQUENT EVENTS**

The Company has evaluated subsequent events through October 13, 2025, which is the date the accompanying financial statements were available to be issued.

On March 3, 2025, the Plan Sponsor was sold, leading to the termination of the Plan effective February 27, 2025.
