Opinion

We have audited the accompanying financial statements of Associated Banc-Corp Group Health Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and plan benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and changes in plan benefit obligations for the years then ended, and the related notes to the financial statements.

(1) Description of Plan

The following brief description of the Associated Banc-Corp Group Health Plan (the "Plan") is provided for general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

Background

The Plan provides certain health and dental benefits, as defined, for substantially all employees of Associated Banc-Corp (the "Corporation") and subsidiaries who are regularly scheduled to work at least 20 or more hours per week beginning on the date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Employer contributions are determined by the Corporation based on information provided by the third-party administrators (United HealthCare and Delta Dental) and Associated Trust Company, N.A. (the "Trustee") and are remitted to the Trustee monthly. Participants' contributions are based upon single or family coverage. Consolidated Omnibus Budget Reconciliation Act (COBRA) participants submit payments on a monthly basis for the total cost of continuation coverage.

Plan Termination

While the Corporation has not expressed any intent to terminate the Plan, it is free to do so at any time, subject to the provisions set forth in ERISA. In the event of termination, the remaining assets available for benefits will be used to provide benefits under the Plan through the date prior to the termination date. Excess funds shall be applied for the exclusive benefit of participants as directed by the Plan's management.

(2) Summary of Significant Accounting Policies

The following is a summary of significant accounting policies consistently followed by the Plan in the preparation of the financial statements.

Basis of Presentation

The financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets, liabilities, plan benefit obligations and changes therein, claims incurred but not reported, and claims payable at the date of the financial statements. Changes in the economic environment, financial markets, and any other parameters used in determining these estimates and assumptions could cause actual results to differ.

Valuation of Investments and Income Recognition

Investment securities are reported at fair value. The Plan's sole investment security is the Goldman Sachs Government Money Market Institutional Fund and is valued using net asset value (NAV) as a practical expedient in estimating fair value. Plan assets are held in trust with the Trustee. Purchases

and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

All administrative expenses, including Delta Dental administrative expenses, tax, and other expenses attributable to the Plan are paid by the Plan with the exception of audit, trust, and United HealthCare administrative expenses, which are paid by the Corporation and excluded from these financial statements.

Pharmacy Rebates

Rebates due from the third-party administrators are recorded when earned. Rebates due as of the financial statement date have been reported as a receivable, with the offset being netted against claims paid.

Reinsurance

The Plan maintained stop-loss insurance relating to medical and prescription claims in the amount of \$400,000 for both 2024 and 2023, per individual specific deductible. In both 2024 and 2023, reinsurance premiums were \$1.5 million.

Risks that have been reinsured under the stop-loss agreement are treated as though they were not risks for which the Plan is liable, and consequently, no obligation has been provided for such contingencies. In 2024 and 2023, the stop loss reimbursement amounts were \$1.8 million and \$1.3 million respectively, which reduce benefits paid to participants.

Benefit Obligations

Benefit obligations represent the liability for all claims incurred including claims incurred but not reported at the end of the year. Benefit obligations at December 31, 2024 and 2023 are based on a review of actual claims paid subsequent to December 31, 2024 and 2023, respectively, to determine total claims incurred prior to each year-end. Due to uncertainties inherent in estimating benefit obligations, it is at least reasonably possible that changes in these estimates in the near term will be material to the financial statements.

(3) Risks and Uncertainties

The Plan invests in various investment securities. The Plan's investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the financial statements of the Plan.

The Voluntary Employees' Benefit Association trust, which funds certain benefits of the Plan, received an exemption letter from the Internal Revenue Service dated October 6, 2006, stating that the Trust is tax-exempt under the provisions of Section 501(c)9 of the Internal Revenue Code (IRC). As a result of the Plan's funding policy, from time to time the Trust may be subject to income taxes related to unrelated business taxable income which is included within administrative expenses.

In addition, the Plan and the Trust are required to operate in conformity with the IRC to maintain the tax exempt status of the Trust. The Plan's management believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related Trust is tax-exempt.

(6) Fair Value Measurements

Fair value represents the estimated price at which an orderly transaction to sell an asset or to transfer a liability would take place between market participants at the measurement date under current market conditions (i.e., an exit price concept).

Money Market Fund: At December 31, 2024, and 2023 the Plan's only investment was the Goldman Sachs Government Money Market Institutional Fund, whose investments are in short-term debt securities designed to maximize current income with liquidity and capital preservation. This investment is measured at fair value using the NAV per share (or its equivalent) practical expedient and therefore has not been classified in the fair value hierarchy.

(7) Subsequent Events

The Plan's management has evaluated the effects on the Plan financial statements of subsequent events for potential recognition or disclosure through October 6, 2025, the date the financial statements were available to be issued. During this period, there have been no material events that would require recognition in the financial statements or disclosures to the financial statements.
