Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Smith Industrial Service, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Smith Industrial Service, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

Basis for Opinion

NOTES TO FINANCIAL STATEMENTS

NOTE 1 - DESCRIPTION OF THE PLAN

The following brief description of the Smith Industrial Service, Inc. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) plan covering substantially all full-time employees of Smith Industrial Service, Inc. (the Company) who have completed six months of service and are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Smith Industrial Service, Inc. is the Plan Administrator.

Contributions and Funding

The Plan provides for the following five methods of funding for each participant's account:

i) Elective Contributions

Eligible employees may contribute up to 100 percent of their pre-tax annual compensation, as defined by the Plan, not to exceed the maximum allowed by law. Additionally, those participants who have attained age 50 before the close of the Plan year shall be eligible to make catch-up contributions in amounts subject to the limitations as specified by law.

ii) Employer Safe Harbor Contributions

Effective January 1, 2023, the Plan was amended to adopt a safe harbor matching contribution. Under this provision, the Company contributes a safe harbor matching contribution equal to 100 percent of the deferrals that participants contribute to the Plan, up to three percent of participants' eligible compensation, as defined by the Plan. Additionally, the Company matches 50 percent of the deferrals that participants contribute to the plan that are between three and five percent of participants' eligible compensation.

iii) Employer Matching Contributions

The Company may elect to contribute additional employer matching contributions at a rate to be determined at the discretion of the Company. No additional employer matching contributions were made during the years ended December 31, 2024 and December 31, 2023.

NOTE 1 - DESCRIPTION OF THE PLAN (continued)

iv) Profit Sharing Contributions

Each year, the Company may elect to contribute a profit sharing contribution. In the event that the Company elects to make a profit sharing contribution, the contribution will be allocated among all eligible employees, whether or not they are contributing to the Plan. During the years ended December 31, 2024 and 2023, profit sharing contributions totaling \$12,487 and \$0, respectively, to the Plan.

v) Rollover Contributions

Employees may transfer amounts to the Plan which were distributed from another tax-qualified retirement plan (rollover).

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions, if applicable, and allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions, any rollover contributions, and employer safe harbor matching contributions. Vesting in the Company's additional matching and discretionary profit-sharing portion of their accounts, plus actual earnings thereon, is based on years of credited service, as defined by the Plan. A participant is 100 percent vested after six years of credited service. A participant will always be 100 percent vested if employed on or after meeting the normal retirement age of 65, becoming disabled, or upon death.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their entire vested interest in the Plan. Loan terms cannot exceed five years, unless they qualify as a home loan, as defined in the Plan documents. The loans are secured by the balance in the participant's account and are treated as participant directed investments which bear interest at a reasonable rate commensurate with the prevailing interest rate charged on similar loans under like circumstances by persons in the business of lending money. Interest rates were 4.25% - 10.50% for the years ended December 31, 2024 and 2023. Principal and interest are paid ratably through regular payroll deductions.

NOTE 1 - DESCRIPTION OF THE PLAN (continued)

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. The normal retirement age is 65. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account. Benefits are recorded when paid.

Forfeited Accounts

Forfeitures of terminated or withdrawing participants' non-vested employer contributions are first used to pay Plan expenses, and then used to reduce future employer contributions, if applicable. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$8,020 and \$10,182, respectively. During the years ended December 31, 2024 and 2023, forfeitures of \$16,627 and \$15,608, respectively, were used to pay administrative expenses and forfeitures of \$11,026 and \$0, respectively, were used to fund employer contributions.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Subsequent Events

Management has evaluated subsequent events through October 15, 2025, the date at which the financial statements were available to be issued, and noted no material events requiring disclosure.

NOTE 3 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities that the Plan has the ability to access.

NOTE 3 - FAIR VALUE MEASUREMENTS (continued)

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 4 - CERTIFIED INVESTMENT INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Newport Trust Company (Newport) and Ascensus Trust Company (Ascensus). Newport served as the Plan's trustee as of December 31, 2023, and from January 1, 2024, through November 13, 2024. Ascensus served as the trustee from November 14, 2024, through December 31, 2024. This information has not been audited by the Plan's independent auditors. The information certified by Newport or Ascensus is summarized below.

NOTE 5 - INCOME TAX STATUS

The Company has adopted a non-standardized pre-approved money purchase/profit sharing plan. The Internal Revenue Service has determined and informed the Company by a letter dated November 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (the Code). The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

The Plan's management is aware of certain operational, plan document, or demographic issues that, if not properly corrected, could be treated by the IRS as qualification failures. Management is taking steps to correct these issues. If necessary, the tax qualification issues will be resolved directly with the IRS. Accordingly, management believes that the Plan will retain its tax-qualified status.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested and non-forfeitable in their accounts. Plan assets will be allocated to provide benefits to participants based on their individual account balances.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan was serviced Newport Trust Company as its trustee and custodian, and Newport Group, Inc. as its record-keeper until November 13, 2024. Effective November 14, 2024, the Plan is serviced by Ascensus Trust Company as its trustee and custodian, and an affiliate of Ascensus Trust Company as its record-keeper. The Plan is serviced by Mitchell, McLeod, Pugh & Williams, Inc. as its investment advisor. During 2024 and 2023, the Plan made direct payments to these parties totaling \$59,506 and \$49,540, respectively. These transactions qualify as party-in-interest transactions. Certain fees incurred by the Plan for investment management and custodian services are paid through revenue sharing, rather than direct payment, and are included in net appreciation in fair value of investments.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

NOTE 9 - DELINQUENT CONTRIBUTIONS

During 2023, the Company failed to remit employee deferrals and loan repayments aggregating \$222,808 to the Plan within the timeframe required by the Department of Labor. The employee deferrals and loan repayments have been remitted to the Plan. During 2025, The Company computed lost earnings on these deposits and made a contribution for lost earnings to the Plan.

During 2022, the Company failed to remit employee deferrals and loan repayments aggregating \$118,005 to the Plan within the timeframe required by the Department of Labor. The employee deferrals and loan repayments have been remitted to the Plan. During 2025, The Company computed lost earnings on these deposits and made a contribution for lost earnings to the Plan.
