### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Hearthsides Food Solutions 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

#### Note 1. Plan Description

The following description of the Hearthside Food Solutions 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering eligible nonunion employees of Hearthside Food Solutions, LLC and Interbake Foods, LLC (the Company), as defined in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The plan was amended and restated effective April 1, 2022.

**Plan name change:** Effective March 31, 2025, the name of the Plan changed to Maker's Pride 401(k) Plan.

**Eligibility:** Employees are eligible to participate in the Plan upon completion of three months of service. There is no age requirement to participate in the Plan. The Plan includes an auto enrollment provision whereby all newly eligible employees whose hire date is on or after January 1, 2015, are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated investment fund until changed by the participant. Automatically enrolled participants may elect to increase or decrease percentages or discontinue deferrals as defined in the Plan.

On December 29, 2021, Hearthside Food Solutions, LLC acquired Interbake Foods, LLC (Interbake). The eligibility conditions and entry dates did not apply to employees who were employees of Interbake as of December 29, 2021, and such employees entered the Plan effective as of the first day of their first payroll period beginning on or after January 1, 2022.

**Contributions:** Contributions to the Plan include: (i) salary reduction contributions authorized by participants, (ii) contributions made by the Company, and (iii) participant rollovers from another plan. Each year, participants may contribute up to 100% of their pretax annual compensation, subject to certain Internal Revenue Code (IRC) limitations, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan also allows participants to make Roth contributions to the Plan on an after-tax basis and allows rollovers of designated Roth contributions into the Plan.

The Plan provides for safe-harbor nonelective Company contributions equal to 3% of a participant's compensation. Participants must be employed for three months in order to receive the safe-harbor nonelective Company contributions. Effective January 1, 2024, safe-harbor nonelective Company contributions were suspended through a plan amendment. Effective January 1, 2025, safe-harbor nonelective Company contributions were enabled through a plan amendment.

Participants may direct the investment of all their contributions among one or more funds offered in the Plan. Changes in allocation of future contributions and transfers among funds of presently invested contributions are permitted pursuant to the Plan provisions.

**Participant accounts:** Each participant's account is credited with the participant's contributions and safe-harbor nonelective Company contributions as well as allocations of: (1) any discretionary profit sharing Company contributions and (2) Plan earnings or losses. Participant accounts are charged withdrawals and an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Note 1. Plan Description (Continued)

**Vesting:** Participants are immediately 100% vested in their contributions and the safe-harbor nonelective Company contributions plus actual earnings thereon.

**Forfeited accounts:** The Company applies all forfeitures to reduce nonelective employer contributions and plan expenses. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$36,796 and \$35,858, respectively. During the year ended December 31, 2024, no significant amount of forfeitures were used to reduce nonelective employer contributions and plan expenses.

**Notes receivable from participants:** Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participants' account. Interest rates are based on the prime rate plus 2% on the first day of the month the loan originated. Principal and interest are paid ratably through payroll deductions over a term not exceeding five years, or longer for loans used for purchase of a primary residence.

**Payment of benefits:** Upon termination of service due to death, disability, retirement, separation from service or attainment of age 59½, a participant may elect to receive the value of their vested interest in his or her account as a lump-sum amount, or may elect to receive their benefits in the form of installments. Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan.

#### Note 2. Summary of Significant Accounting Policies

**Basis of accounting:** The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The financial statements of the Plan are prepared under the accrual method of accounting. Adjustments to the cash basis trust reports include contributions withheld by the employee before year-end, but not remitted into the Plan until after year-end and employer contributions owed to the participants but not remitted until after year-end.

**Contributions:** Contributions from Plan participants and the related matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administrative committee determines the Plan's valuation policies utilizing information provided by the investment advisors and the trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Payment of benefits:** Benefit payments are recorded when paid. There were no amounts allocated to accounts of persons who have elected to withdraw from the Plan but have not yet been paid at December 31, 2024 and 2023.

**Administrative expenses:** Certain expenses of maintaining the Plan are paid directly by the Plan and are included as administrative expenses in the statement of changes in net assets available for benefits. Any expenses paid by the Company on behalf of the Plan are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are reflected as a reduction of return for such investments and are not separately reported.

The Plan has a revenue-sharing agreement whereby certain investment managers return a portion of the investment fees to Great-West Trust Company, LLC to offset the Plan's administrative expenses. Future Plan expenses can be paid from any excess remaining revenue-sharing amounts. For the year ended December 31, 2024, no investment fees used to offset Plan expenses. The Plan held no undistributed administrative revenues at December 31, 2024 and 2023.

**Use of estimates:** The preparation of the financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Note 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full-term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

**Shares of registered investment companies (mutual funds):** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The shares of mutual funds held by the Plan are deemed to be actively traded.

**Common/collective trust and stable value funds:** Valued based on the NAV of units of the common/collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. The stable value funds are common collective trust funds comprised primarily of fully benefit responsive investment contracts that are valued at the NAV of units of the collective trust. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

#### **Note 5. Federal Income Tax Status**

The Plan has adopted a non-standardized form of a pre-approved plan provided by Great-West Trust Company, LLC. The Plan was restated effective April 1, 2022. The pre-approved plan provider has received an opinion letter from the Internal Revenue Service dated June 30, 2020. The Plan Administrator believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Management has evaluated the Plan's tax positions and concluded that the Plan has maintained its tax-exempt status and has taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

#### **Note 7. Plan Transfers**

As permitted by the Plan, participant accounts may be transferred from or to the Plan from the Hearthside Food Solutions Union 401(k) Plan (an affiliated union plan sponsored by the Company) based on changes in job status. The balance of these transfers, if any, is included in transfers from or transfers to other qualified plans on the statement of changes in net assets available for benefits.

#### **Note 8. Exempt Party-in-Interest Transactions**

Fees paid by the Plan for investment management services provided by Empower were included as a reduction of the return earned on investments, and administrative revenue received by the Plan through the Plan's revenue-sharing agreement with Empower was used to offset the Plan's administrative expenses. These transactions qualify as party-in-interest transactions. The Company pays certain Plan expenses on behalf of the Plan and also provides certain administrative services at no cost to the Plan.

#### **Note 9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.


