Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Bechtel Medical and Dental Plan for Employees (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits and of plan benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in plan benefit obligations for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Notes to Financial Statements

1. Plan Description:

General:

The Bechtel Medical and Dental Plan for Employees (Plan) is sponsored by Bechtel Global Corporation (the Plan Sponsor) to provide medical, vision and dental benefits to eligible salaried U.S. employees, U.S. International Assignee employees and Canadian International Assignee employees. The Plan also provides medical, vision and dental benefits to eligible dependents as defined by the Plan and to Consolidated Omnibus Budget Reconciliation Act (COBRA) beneficiaries. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

CIGNA is the nonprescription drug benefits provider. The self-insured plans include several group health plans including PPOs, one of which is integrated with a Health Reimbursement Arrangement (HRA) and one that is a high-deductible health plan (HDHP). There are also insured HMO contracts that are fully responsible for the benefits provided to its members. Vision coverage is fully insured under a VSP contract and VSP is fully responsible for benefits provided to its members. The dental portion of the plan is self-insured under an administrative services agreement with CIGNA. Additional details of the Plan can be found in the Summary Plan Description and subsequent updates.

The Bechtel VEBA Trust (Master Trust) acts as a vehicle for the collection of contributions and the payment of insurance premiums or benefits for the Plan and the Bechtel Retiree Medical Plan (collectively, the Plans). Under the provisions of the Trust for the Plans, all contributions to the Trust for the Plans are used solely for the benefit of the Plans' participants. The excess of funds collected over funds needed to pay current premiums or benefits and plan expenses is invested in various mutual funds and long-term investments. When benefits and expenses exceed funds collected, the Plan Sponsor pays the shortfall.

Master Trust:

The assets of the Plans in the Trust are pooled in a Master Trust held by The Northern Trust Company (Trustee). At December 31, 2024 and 2023, the Plan's interest in the net assets of the Master Trust was approximately 90% and 93%, respectively. Investment income, net of administration expenses relating to the Master Trust, is allocated to the Plan based upon the Plan's interest in the net assets of the Master Trust every quarter. Administration fees of \$6,520 were paid to the Trustee in 2024 of which \$5,877 was attributable to the Plan.

Notes to Financial Statements

1. Plan Description, continued:

Contributions:

Contributions for medical and dental coverage are made by employees and the Plan Sponsor. Contributions for “VSP Basic” vision coverage are made by the Plan Sponsor. Contributions for “VSP Plus” coverage are made by employees and the Plan Sponsor. Contributions for medical and/or vision and/or dental coverage for COBRA beneficiaries are made by the COBRA beneficiaries. Contribution amounts vary based on the type of coverage selected and if dependents are covered. The Plan Sponsor’s current policy is to fund the current cost of medical, vision and dental benefits on a pay-as-you-go basis.

Plan Amendment and Termination:

The Plan Sponsor has the right under the Plan to amend or terminate the Plan at any time, subject to the provisions set forth in ERISA, provided that such amendment or termination does not cause the assets of the Plan to be used for any purpose other than the payment of benefits to Plan participants and their dependents and beneficiaries.

Investment Management:

The Chief Financial Officer of Bechtel Group, Inc. (Investment Manager) has all power over and responsibility for the investments of the Trust. The Trustee has complied with proper written directions of the Investment Manager concerning the investments of the Trust.

Administration:

The Plan Administrator, who is appointed by the Plan Sponsor, is responsible for the collection of contributions or other monies due the Plan and for the deposit of such funds in the Trust. The Trustee receives and disburses or otherwise manages funds in its fiduciary capacity subject to the limitations regarding investment decisions and contributions collection responsibilities. Administrative expenses paid by the Trust on behalf of the Plan relate to contract claims administration costs incurred with the self-insured plans and other general and administrative expenses.

2. Summary of Significant Accounting Policies:

Basis of Accounting:

The accompanying financial statements are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP). Plan Sponsor contributions are recognized in amounts designated by the Plan Sponsor and participant contributions are recognized as premiums are withheld from participant earnings, or as estimated and deposited, whichever is earlier. Benefits are recognized when paid by the Trust. Benefits to participants are recognized as benefit obligations when incurred. Pharmacy rebates and other refunds of \$13,175,735 have been netted with claims paid in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

2. Summary of Significant Accounting Policies, continued:

Use of Estimates:

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of income and expenses during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties:

Benefit obligations are prepared based on certain assumptions pertaining to healthcare costs, historical payments and claim statistics, which are subject to change. Due to uncertainties inherent in the estimation and assumption process, it is at least reasonably possible that changes in the near term would materially affect the financial statements. The Plan through investment in the Trust also holds investments. Investments are exposed to various risks, such as interest rate, market fluctuations, and credit risks, as well as the risks associated with global events. Due to the risk associated with certain investments, it is at least reasonably possible that changes in market values, interest rates, or other factors in the near term would materially affect the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Subsequent Events:

The Plan management has evaluated subsequent events through October 14, 2025, which is the date the financial statements were available to be issued.

Fair Value of Investments of the Master Trust:

The fair value of the investments of the Master Trust reflects the amounts that would be received to sell an asset in an orderly transaction between market participants at the balance sheet date.

The investments of the Master Trust are stated at fair value which incorporates quoted market prices where available in an active market (level 1), are correlated with quoted prices of securities with similar characteristics (level 2) or determined using significant unobservable inputs (level 3). Investments consist of mutual funds, which are valued at the quoted market prices on a national exchange of shares held by the Plan at year-end.

Employee Contribution Receivables:

Amount due from Bechtel Corporation is related to Employee Contributions for the last payroll of the year 2023.

2. Summary of Significant Accounting Policies, continued:

Due From Provider:

At December 31, 2024, the amount due from provider is related to the pending settlement of funds received to a check refund.

Accounts Payable - Stale Dated Checks:

At December 31, 2024, and 2023, stale dated checks related to medical providers payable to various States the following year.

Accrued Tax Preparation Fees:

At December 31, 2024, and 2023, accrual of tax preparation fees paid subsequently the following year.

Net Appreciation (Depreciation) in Fair Value of Investments:

The net appreciation (depreciation) in the fair value of the investments of the Master Trust, which consists of the realized gains or losses and the unrealized appreciation or depreciation on those investments, is included in the Plan's interest in investment gain (loss) of the Master Trust presented in the Statement of Changes in Net Assets Available for Benefits.

Income Recognition:

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

Rebates:

Rebates are recorded when received as a reduction to the cost of claims.

3. Party-In-Interest Transactions:

Administrative expenses of \$46,194 were paid by the Trust on behalf of the Plan to the Plan Sponsor in 2024.

Certain investments of the Master Trust are managed by an affiliate of the Trustee of the Plan. Any purchases and sales of these funds are performed in the open market at fair value. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA. The Plan also pays administrative fees to other third party administrators.

6. Claims Payable and Claims Incurred but Not Reported:

Plan obligations at December 31, 2024 and 2023 for claims incurred by participants but not paid or reported at that date are estimated by the Plan's actuary in accordance with generally accepted actuarial principles. The actuarial computations are based on historical payment and claim statistics. Estimated amounts reported in the accompanying Statements of Plan Benefit Obligations are subject to change over time and these changes could have a material impact on the Plan's financial statements. Adjustments to claims liabilities are reflected in the Statement of Changes in Plan Benefit Obligations in the periods they become known.

7. Tax Status:

The Trust is a qualified organization under Section 501(c)(9) of the Internal Revenue Code (IRC) and is, therefore, considered to be exempt from income tax under provisions of Section 501(a), subject to limitations imposed by Sections 419A and 512 which allow certain funds to be set aside tax free but may cause the earnings on funds set aside for postretirement medical benefits to be taxed.

The Trust has obtained favorable tax exemption letters from the Internal Revenue Service (IRS) dated June 18, 1971 and the California Franchise Tax Board dated September 5, 1972, and the Plan Sponsor believes that the Trust continues to qualify and operate as a tax exempt organization subject to the limitations indicated above. The Plan has been amended since receiving the exemption letters. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023 there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021 for federal purposes and prior to 2020 for California purposes.

Management has determined that it is reasonable to believe that a portion of its earnings on the funds set aside for medical benefits be classified as unrelated business taxable income and subject to tax under Section 419A and 512. However, this event did not change its status as a tax-exempt organization under Section 501(c)(9) of the IRC. Additionally, it did not trigger any reserve of uncertain position that more likely than not would be sustained upon examination by the IRS for the tax year-ended December 31, 2024. The Trust has paid unrelated business income tax and has allocated those amounts for the year ended December 31, 2024 which are not significant to the Plan.
