## INDEPENDENT AUDITOR'S REPORT

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Keyser Enterprises 1LP 401(k) Profit Sharing Plan and Trust’s ability to continue as a going concern for one year after the date the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan’s transactions that are presented and disclosed in the financial statements are in conformity with the plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor’s Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor’s report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Accordingly, no such opinion is expressed.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Keyser Enterprises 1LP 401(k) Profit Sharing Plan and Trust's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audits.

## **Other Matters**

### ***Supplemental Schedule Required by ERISA***

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## NOTES TO THE FINANCIAL STATEMENTS

### (1) Plan Description

The following description of Keyser Enterprises 1LP 401(k) Profit Sharing Plan and Trust (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

#### *General Information*

The Plan, which was established March 1, 2019 and subsequently amended, is a defined contribution and 401(k) plan covering substantially all employees of Keyser Enterprises 1LP (the “Company”) who meet the eligibility provisions of the Plan. The Plan is subject to provisions of ERISA.

#### *Contributions*

Each year, participants may contribute up to 92% of their eligible compensation, as defined in the Plan, not to exceed the maximum amount allowed by law. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Plan includes a provision for a matching contribution of 100% of deferrals up to 3% of the participants’ eligible compensation and 50% of the next 3%. Additional profit sharing amounts may be contributed at the option of the Company’s Board of Directors. Participants direct the investment of the contributions into various investment options offered by the Plan.

#### *Eligible Participants*

Employees are eligible to participate in the Plan after 2 months of service and are at least 18 years of age.

#### *Participant Accounts*

Each participant’s account is credited with (a) the participant’s contributions, (b) the Company’s contributions, (c) Plan earnings and appreciation, and (d) the participant’s share of forfeited accounts of former employees. Each participant’s account is charged with (a) any withdrawals or distributions, (b) Plan losses and depreciation, and (c) an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### *Vesting*

Participants are immediately vested in their elective deferrals, rollover and transfer contributions, plus or minus actual earnings or losses thereon.

For employer contributions to the Plan, participants will vest as follows:

### (1) Plan Description (Continued)

Participants are also fully vested in employer contributions upon retirement due to disability, death, or the termination of the Plan.

Participants are considered to have completed one year of service for every 12 months of employment.

#### *Forfeited Plan Assets*

If a participant forfeits any unvested balances in his/her account, the forfeited assets may be used to pay plan expenses, to reduce employer contributions, or be allocated to current participants as a profit sharing contribution. For the years ended December 31, 2024 and 2023, no forfeitures were utilized to pay plan expenses or reduce employer contributions.

#### *Notes Receivable from Participants*

Subject to provisions under the Plan, participants may borrow from the Plan an amount which does not exceed the lesser of \$50,000 or 50% of the present value of the participant's vested benefit under the Plan. Notes receivable, which are secured by the balance in the participant's account, bear interest at a rate similar to local commercial bank rates and have terms which range from 12 to 60 months, unless the loan was made for the participant to acquire his/her principal residence. In this case, the term is for a period that ranges from 12 to 120 months. Principal and interest are paid ratably through payroll deductions or paid directly by the participants at their discretion.

#### *Retirement and Terminations*

In the case of normal retirement or retirement due to permanent disability, participants will receive the value of their vested plan benefits, in accordance with the provisions of the Plan, either in a lump-sum distribution, in installments payable over a period which does not exceed the life expectancy of the participant, or in the form of an annuity.

In the event that a participant dies before retirement, the beneficiary will receive the value of the participant's vested benefits in either a lump-sum distribution or in the form of an annuity.

In the case of termination of an employee, the participant may request early payment of the vested benefit by submitting a written request to the plan administrator. The portion of the terminated participant's account balance that is not vested is forfeited and remains in the Plan to pay plan expenses.

#### *In-Service Distributions*

The Plan allows for in-service distributions upon the attainment of age 59 ½ and only from funds in which the participant is 100% vested. The Plan also allows for qualified reservist distributions from their elective deferrals.

#### *Hardship Withdrawals*

The Plan allows for hardship withdrawals, as defined in the Plan, that are limited to the amount needed to meet the financial need. These withdrawals may not be recontributed to the Plan and may be subject to income tax and penalties.

### (1) Plan Description (Continued)

#### *Administration*

All assets of the Plan are held and managed by Mid Atlantic Trust Company (“MATC”).

### (2) Summary of Significant Accounting Policies

#### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual method of accounting.

#### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### *Investment Valuation and Income Recognition*

The Plan’s investments are stated at fair value. The fair value of the Plan’s other financial instruments approximate their carrying amounts, either because the expected collection or payment period is relatively short or because the terms are similar to market trends. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

#### *Investment Risk*

Participants in the Plan assume all adverse investment risk connected with any decrease in value of plan assets, and such assets are the sole source of payments under the Plan.

#### *Cash and Cash Equivalents*

The Plan considers all highly liquid debt instruments purchased with a maturity of three months or less to be cash equivalents.

#### *Notes Receivable from Participants*

Notes receivable from participants will be measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based on the terms of the Plan document.

#### *Payment of Benefits*

Benefits are recorded when paid.

#### *Administrative Expenses*

It is the policy of the Plan that certain administrative expenses pertaining to the Plan be paid by the Company.

#### *Subsequent Events*

The Plan evaluates events and transactions occurring subsequent to the date of the financial statements for matters requiring recognition or disclosure in the financial statements. The accompanying financial statements consider events through the date of the independent auditor's report, which is the date the financial statements were available to be issued.

### (3) Transactions with Parties-In-Interest

The Plan is administered by the Company. Owners of the Company serve as the Plan's trustees and administrators. The Company pays certain administrative expenses related to the Plan. All investment funds are managed by MATC. Paychex, Inc. is the third-party administrator for the Plan.

### (4) Fair Value Measurements

Under the Fair Value Measurements and Disclosures topic of the Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC"), a guideline is provided for measuring fair value under generally accepted accounting principles. The topic establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs include quoted prices in active markets for similar assets, quoted prices in inactive markets for similar assets, or inputs that are observable or can be corroborated by observable market data or other means for substantially the full term of the asset; and Level 3 inputs have the lowest priority and are based on prices or valuation techniques that are unobservable and not corroborated by market data. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. The Plan uses Level 2 inputs when an active market comparable is not available and Level 3 inputs were only used when Level 1 or Level 2 inputs were not available.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### *Level 1 Fair Value Measurements*

The fair values of the cash/money market funds are based on quoted net asset values of the shares held by the Plan at year-end. The fair values of the registered investment companies are based on quoted market prices.

### (5) Certification

The Plan administrator has elected the method of compliance permitted by ERISA Section 103(a)(3)(C). As permitted under such election, the Plan administrator has obtained certifications from MATC that the investments and their related income as reported in the accompanying financial statements are complete and accurate.

### (6) Plan Termination Policies

Although it has not expressed intent to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions set forth in ERISA. In the event of termination of the Plan, the right of all participants to benefits would become 100% vested and nonforfeitable. The amount of the account balance due each participant would be distributed in accordance with the payment provisions of the Plan.

### **(8) Internal Revenue Service Status**

The Internal Revenue Service has determined and informed Paychex, Inc. by a letter dated August 31, 2020, that their prototype non-standardized profit sharing plan, which was adopted by the Plan on March 1, 2019 and subsequently amended, is designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). The plan administrator and management believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

The Plan accounts for any uncertain tax positions in accordance with the Income Taxes topic of the FASB ASC. The topic prescribes a recognition threshold and measurement process for financial statement recognition of uncertain tax positions taken or expected to be taken in an annual return/report of an employee benefit plan. In evaluating the Plan’s tax position, interpretations and tax planning strategies are considered. The Plan believes its tax exempt status is appropriate based on current facts and circumstances.

### **(9) Risks and Uncertainties**

The Plan invests in various securities. The underlying investments may include corporate debt instruments and corporate stocks. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

### **(10) Subsequent Event**

Effective April 4, 2025, the plan was restated, and all funds were transferred to Human Interest. There were no other substantial changes to the provisions of the plan.
