The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Notes to Financial Statements

Note 1. Plan Description

The following description of NANA Regional Corporation, Inc. Compensation Deferral Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a "Multiple Employer" defined contribution plan established to provide retirement benefits for employees of NANA Regional Corporation, Inc. (NRC or the Company or the Plan Sponsor) and participating companies. The Plan includes companies that are both within and outside the NRC control group; currently NANA North LLC (NNO) (fka Sivu LLC), NANA Management Services, LLC (NMS), NANA Worley LLC (NW), Kuna Engineering (Kuna) and NANA Construction, LLC (NC), Atautchikun, LLC (ATA) and Qavvik Air, LLC (QAV) and it also provides retirement benefits for employees of Aqqaluk Trust (Aqqaluk), an unrelated entity. In general, all employees are eligible to participate in the Plan except for employees covered under a collective-bargaining agreement and leased employees. Eligible employee classes, service and entry dates, and employer contributions vary by the participating company and are specified on joinder agreements to the Plan. Contributions to the Plan are on a voluntary basis. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Participants may elect to make compensation deferral contributions in an amount not to exceed 99% of the participant's pretax eligible compensation earned during the year, as defined by the plan document. Participant contributions are limited to \$23,000 for the year ended December 31, 2024. Participants age 50 or older are able to make catch-up contributions of \$7,500 for the year ended December 31, 2024. Participants may also contribute amounts representing rollover distributions from other qualified defined benefit or defined contribution plans.

The Plan includes an auto-enrollment provision whereby all newly eligible participants are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

The Plan Sponsor may designate by resolution of the board of each participating company, a discretionary matching contribution for eligible participants of NRC, NNO, NMS, NW, Kuna, NC, ATA, and QAV. The Plan Sponsor may designate by resolution of the board of each participating company, a non-elective or profit-sharing contribution for eligible participants of NRC, NNO, NMS, NC, NW, Kuna, ATA, QAV and Aqqaluk. There were no profit-sharing contributions for the year ended December 31, 2024. There were no non-elective contributions for eligible participants of NMS, NC, NW, Kuna, ATA, QAV and Aqqaluk for the year ended December 31, 2024.

NRC and NNO adopted resolutions effective January 1, 2013, and the Plan was amended, effective June 1, 2023, to add ATA as a participating employer to provide a non-elective employer contribution of 3% of eligible compensation to the Plan for every eligible employee; to provide for an employer match of a fixed 3% of compensation on employee deferrals, structured as 50% of the first 6% of compensation that an employee defers; and to allow for an additional annual discretionary employer contribution to all participants based on company profitability. Employees who are eligible to participate in the NRC non-qualified deferred compensation plan shall not be eligible for employer contributions in the defined contribution plan.

The other participating companies may make discretionary employer matching contributions. For the year ended December 31, 2024, NMS, NW, Kuna, NC, and QAV made a discretionary matching contribution equal to 50% of the first 6% of compensation.

Contributions are subject to certain Internal Revenue Code (IRC) limitations.

Notes to Financial Statements

Note 1. Plan Description (Continued)

Investment options: Upon enrollment in the Plan, a participant may direct all contributions to selected investments as made available and determined by the Benefits Governance Committee. Participants may change their investment options daily.

Participant accounts: Each participant's account is credited with the participant's and employer's matching and non-elective contributions, and allocations of any profit-sharing contributions and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant compensation, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting: All participants are 100% vested in all contribution types immediately upon entry into the Plan.

Payment of benefits: The Plan permits withdrawals when a participant terminates employment, reaches retirement age, or becomes disabled or deceased. Upon termination of employment, benefit distributions are automatically made to participants with account balances of \$1,000 or less, in a single lump-sum. If a participant account balance is \$5,000 or less, the Plan Administrator will send a notice giving more information and describing distribution options. If the participant does not respond within the time period described in the notice, and the distribution amount remains unclaimed, the Plan Administrator may automatically roll the distribution to a default IRA account. If a participant's account balance exceeds \$5,000, he or she may elect to leave the balance in the account, or receive an amount equal to the value of the vested interest in his or her account in either a lump-sum amount, or in installments (monthly, quarterly, or annual) over a specified period of time, not exceeding the participant's life expectancy (or the joint expectancy of the participant and designated beneficiary). In-service withdrawals are also permitted for certain financial hardships or when a participant attains age 59½.

Notes receivable from participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Each participant may have only one outstanding loan at a time. Loan terms shall not exceed five years, unless the loan is to acquire the participant's principal residence. The loans are secured by the balance in the participant's account and bear interest at a rate of prime plus 3%. These rates range from 6.25% to 11.50% on loans outstanding at December 31, 2024, and the loans mature through 2040. Loans are repaid in equally amortized payments over the term of the loan. Payments are due at least monthly, per the Plan's loan policy. A loan is considered in default when a participant cannot pay the loan in full within a 90-day cure period. A default loan is treated as a deemed distribution and it is treated as a reduction of net assets.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value (except for fully benefit-responsive investment contracts). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Benefits Governance Committee determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Note 2. Summary of Significant Accounting Policies (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make the scheduled repayments and the Plan Administrator deems the participant to be in default, the participant's note receivable is reduced and a benefit payment is recorded based on the terms of the Plan. Allowances totaling \$635,628 and \$572,479 for credit losses have been recorded as of December 31, 2024 and 2023, respectively.

Contributions: Contributions from plan participants and the matching contribution from the Plan Sponsor are recorded in the year in which the underlying compensation is paid. Profit-sharing and non-elective contributions are recognized upon authorization and in the year the underlying compensation is paid. All participant and employer contributions are participant directed. Participant contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction in contributions.

Payment of benefits: Benefits are recorded when paid.

Expenses: Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Administrative expenses include fees related to the administration of notes receivable that are charged directly to the participant's account and certain recordkeeping fees paid by the Plan. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent events: The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified or Provided by Lincoln Financial Group Trust Company, Inc. (Trustee)

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

Note 4. Fair Value Measurements (Continued)

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Registered investment companies (mutual funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another.

The Plan evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits.

Note 5. Fully Benefit-Responsive Investment Contract

The Plan has a traditional, fully benefit-responsive guaranteed investment contract with Lincoln Financial Group Trust Company, Inc. (LFGTC) that is reported at contract value. LFGTC maintains the contributions in a general account. The account is credited with contributions, earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1%. Such interest rates are reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

Note 5. Fully Benefit-Responsive Investment Contract (Continued)

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the IRC or the failure of the trust to be tax-exempt under Section 501(a) of the IRC
2. Premature termination of the contracts
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreement without the consent of the issuer

Note 6. Related-Party and Party-in-Interest Transactions

Lincoln Financial is the custodian and Lincoln Financial Group Trust Company is the trustee of the Plan; therefore transactions with the custodian and trustee qualify as party-in-interest transactions. The Sponsor also paid certain administrative expenses of the Plan. Income received from the trustee related to a revenue sharing arrangement totaled \$119,831 for the year ended December 31, 2024. This revenue is used to offset administrative expenses of the Plan.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would continue to be 100% vested in all contributions.

Note 8. Tax Status

The Plan has adopted a preapproved plan document that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the IRC. The Plan has been amended since adopting the preapproved plan document; however, the Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken any significant uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 10. Nonexempt Transactions

During 2024 and 2023, the Plan Sponsor inadvertently failed to deposit \$12,992 and \$66,754, respectively, of participant contributions within the required timeframe as stated by the Department of Labor regulations. The Sponsor deposited lost interest in 2025 for the 2024 late deposits and in 2024 for the 2023 late deposits to correct these failures.

Note 11. Subsequent Event

Effective January 1, 2025, the Plan was amended to allow certain previously excluded NRC non-qualified deferred compensation plan eligible employees to receive employer contributions if the employees were covered by the NANA Regional Corporation, Inc. Employees' Pension Plan and to add the eligibility requirement of employment on the last day of the plan year for matching contributions for Kuna, NC, NMS, QAV, and Aqqaluk employees.
