### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements***

We have performed an audit of the financial statements of the Reisenfeld & Associates 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

**NOTE 1 - DESCRIPTION OF PLAN**

The following description of The Reisenfeld & Associates 401(k) Plan (the "Plan") is provided for general information purposes only. More complete information regarding the Plan's provisions may be found in the Plan document.

***General***

The Plan is a defined contribution plan established by Reisenfeld & Associates, LPA, LLC, (the "Company") under the provision of Section 401(a) of the Internal Revenue Code ("IRC"), which includes a qualified cash or deferred arrangement as described in section 401(k) of the IRC, for the benefit of eligible employees of the Company. All employees who have completed 3 months of service, as defined, are eligible to participate, provided they are at least 21 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). Effective January 1, 2022, the Plan was restated in its entirety.

***Contributions***

Eligible employees can contribute in any amount up to the maximum percentage of compensation and dollar amount as defined by the Plan, subject to certain limitations under the IRC. The Plan provides for automatic enrollment of eligible participants at a deferral rate of 3% of eligible compensation, unless the participant affirmatively elects otherwise. The Plan also provides for an automatic 1% annual increase in the deferral rate on the Participant's anniversary date (up to a maximum deferral rate of 6%). Participants may also contribute amounts representing distributions from other qualified benefit or contribution plans. Participants may allocate contributions made to their account in any of the investment options offered by the Plan.

The Company elected a Qualified Automatic Contribution Arrangement (QACA) Safe Harbor Matching Contribution where the Company matches 100% of the participants first 1% of eligible compensation and 50% on the next 5% of eligible compensation.

Each year at the discretion of the Company an additional matching contribution may be made at a discretionary percentage. Employee deferral contributions are not matched by the Company until the employee has satisfied the eligibility requirements. No discretionary match contributions were made in 2024.

Each year at the discretion of the Company, a profit sharing contribution may be made in any amount, limited to statutory amounts. Eligible participants are allocated contributions in proportion of their compensation to total compensation of all eligible participants. No profit sharing contributions were made in 2024.

***Rollover Contributions***

Participants may rollover their taxable portion of funds previously held for their account in another employee benefit plan to the Plan on a tax-free basis.

**NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)**

***Participant Accounts***

Individual accounts are maintained for each of the Plan's participants to reflect the participant's contributions and Company matching contributions, as well as the participant's share of the Plan's income and any related administrative expenses. Allocations of income and expenses are based on the proportion that each participant's account balance bears to the total of all participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their contributions and the earnings thereon. Vesting in employer contributions and the earnings thereon is based on years of service. A participant is 100% vested after 2 years of credited service.

***Payment of Benefits***

Upon a participant's retirement, death, total and permanent disability, other termination of employment with the Company, or termination of the Plan, the participant's account is distributed under several options. Participants may elect to receive their benefit payment among various options including installment and lump sum. Eligible participants who have attained age 59 1/2 may elect in-service withdrawals.

In conditions of "financial hardship" a participant may apply to the Plan Administrator for approval to withdraw that portion of his or her elective deferral or rollover account balance necessary to meet the financial hardship, subject to the limitations of the Plan and the Internal Revenue Code ("IRC").

Upon termination of the Plan, the assets will be distributed to participants in accordance with the Plan's provisions and existing laws and regulations.

***Forfeited Accounts***

Forfeitures of non-vested Company employer matching contributions are used first for the reduction of future Company employer matching contributions and then for the payment of Plan administrative expenses, as defined by the Plan. The Plan had \$92,439 and \$34,856 of forfeited non-vested accounts at December 31, 2024 and 2023, respectively. There were no forfeitures used by the Plan during the year ended December 31, 2024.

***Notes Receivable - Participant Loans***

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms can range from one to five years for any participant loans. The participant loans are secured by the balance in the participant's account and bear interest at a rate of prime plus 1%, and mature between July 6, 2025 and August 3, 2029. Principal and interest are paid through payroll deductions. A loan application fee is charged to the participant's pretax account.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to use estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from these estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

***Contributions***

Contributions from Plan participants are recorded in the year in which employee contributions are withheld from compensation. Contributions from the Company are recorded in the period in which the related participant contributions are due. No allowance for credit losses had been recorded as of December 31, 2024 and 2023.

***Payment of Benefits***

Benefits are recorded when paid.

***Administrative Expenses***

Certain expenses incurred in connection with the general administration of the Plan are paid by the Plan and are recorded in the accompanying statement of changes in net assets available for benefits as administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

***Notes Receivable – Participant Loans***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

***Excess Contributions Payable***

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

ASC topic *Fair Value Measurements and Disclosures* provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

*Level 1*—Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

*Level 2*—Inputs to valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3*—Inputs to valuation methodology are unobservable and significant to the fair value measurement. Valuation is generated from model-based techniques that use significant assumptions not observable in the market. These unobservable assumptions would reflect our own estimates of assumptions that market participants would use in pricing the asset or liability. Such valuation techniques include the use of option pricing models, discounted cash flow models and similar techniques.

The asset or liability's fair value measurement level within the hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

*Pooled separate accounts:* Valued at fair value by the fund custodian based on the fair value of the underlying securities within the fund, which represents the net asset value of the shares held by the Plan at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 4 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

The Plan holds a traditional investment contract. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than the established floor rate. The crediting rate is reviewed on an annual basis for resetting. The contract cannot be terminated before the scheduled maturity date. The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

**NOTE 4 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT (CONTINUED)**

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code
2. Premature termination of the contracts
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer.

**NOTE 5 - TAX STATUS**

The plan sponsor adopted a Prototype Non-standardized Safe Harbor Profit Sharing Plan, for which a letter from the Internal Revenue Service has been received indicating that an employer who adopts this prototype plan will be considered to have a plan qualified under applicable sections of the Internal Revenue Code (IRC). The plan sponsor has elected not to request a separate determination letter for the Plan. The plan sponsor and the plan's administrator believe that the Plan is currently designed and being operated in compliance with applicable requirements of the IRC. Therefore, they believe the Plan was qualified as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 6 - RELATED PARTY TRANSACTIONS**

Certain plan investments are shares of mutual funds managed by Voya Insurance and Annuity Company (the Trustee of the Plan). As defined by the Plan, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment.

Certain expenses and costs of administering the Plan were paid by Reisenfeld & Associates, LLC and, accordingly, are not reflected in the Plan's financial statements. Investment related expenses are included in net appreciation of fair value of investments.

**NOTE 7 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 8 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, participants will become fully vested in their account balances.

**NOTE 9 - INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE (UNAUDITED)**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, Voya Retirement Insurance and Annuity Company, the Trustee, has certified that all the financial data related to investments used in the preparation of the statements of net assets available for benefits, statements of changes in net assets, and the supplemental schedules is complete and accurate.

**NOTE 10 - SUBSEQUENT EVENTS**

Management has performed an analysis of the activities and transactions subsequent to December 31, 2024 to determine the need for any adjustments to and/or disclosures within the financial statements for the year ended December 31, 2024. Management has performed their analysis of subsequent events through October 14, 2025, the date the financial statements were issued and determined no adjustments were needed.

**NOTE 11 - QUALIFIED NONELECTIVE CONTRIBUTION (QNEC)**

During the year ended December 31, 2024, the Plan Sponsor identified a discrepancy in the elective deferral rates for certain participants. The discrepancy resulted from administrative errors that caused participant deferral elections to be implemented incorrectly, potentially resulting in missed deferral opportunities for a limited number of participants.

In accordance with the Internal Revenue Code and applicable U.S. Department of Labor and IRS correction guidance under the Employee Plans Compliance Resolution System (EPCRS), the Plan Sponsor is in the process of assessing the impact of the error. Based on preliminary analysis, the Plan Sponsor may be required to make a corrective Qualified Nonelective Contribution (QNEC) to the accounts of affected participants. The amount of this QNEC, if required, has not yet been finalized and is therefore not reflected in the accompanying financial statements.

The Plan Sponsor intends to complete its review and, if necessary, fund any required QNECs in accordance with regulatory correction guidelines. Management does not expect the resolution of this matter to have a material impact on the Plan's financial statements.
