Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Inteva Products, LLC Salaried Employees' Savings and Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTE 1 – DESCRIPTION OF PLAN

The following description of the Inteva Products, LLC Salaried Employees' Savings and Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all salaried employees of Inteva Products, LLC (the Company), and certain hourly employees at the Company's Bluffton, Indiana facility. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended.

Contributions: Each year, participants may contribute between 1% and 60% of eligible compensation, as defined by the Plan. Salaried and hourly Bluffton employees are automatically enrolled at a 5% and 3% deferral rate, respectively, upon becoming eligible to participate in the Plan and they may elect to change or discontinue deferrals at any time. Participants may also contribute amounts representing distributions from other qualified plans. Participants older than 50 years of age are allowed to make "catch-up" contributions limited to the amount defined in the Plan Document. The Plan allows for employer matching contributions where the Company contributes 50% of the first 5% of base compensation that a salaried participant has contributed to the Plan, and 50% of the first 6% of base compensation that an hourly Bluffton employee has contributed to the Plan. The Company also contributes a percentage of base compensation based on years of completed service for salaried employees as shown in the following table:

<u>Years of Service</u>	<u>Company Contribution</u>
2 or less years	2% of base pay
3 but less than 11 years	3% of base pay
11 but less than 20 years	4% of base pay
20 or more years	6% of base pay

Certain participants' years of completed service includes one-third of years of service completed at a previous employer prior to becoming employees of the Company. Contributions are subject to certain limitations. During 2024, the Company made total contributions of \$3,840,803.

Unless a salaried participant who is enrolled in the Plan affirmatively elects otherwise, the participant's elective deferral percentage will increase by 1% each year on January 1st until the percentage reaches 12% of compensation. Hourly Bluffton employees' elective deferral percentages are not auto-escalated each year.

Participant Accounts: Each participant's account is credited with the participant's own contributions, an allocation of any Company contributions and an allocation of Plan earnings and is charged with her or his withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings, contributions or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Vesting: Participants are immediately vested in their own contributions plus earnings thereon. Vesting in the Company's contribution plus actual earnings thereon is based upon years of completed service. A participant is 100% vested after three or more years of completed service. Certain participants' years of completed service includes one-third of years of service completed at a previous employer prior to becoming employees of the Company. Participants become fully vested upon reaching the age of 65, retirement, death, disability or permanent layoff, regardless of years of service.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the plan agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Notes Receivable from Participants: A participant may borrow up to the lesser of \$50,000 or 50% of his or her account balances with a minimum loan of \$1,000. Loans will not be processed for any participant whose account balance is not sufficient for the minimum loan amount of \$1,000. The loan will bear interest at a rate commensurate with market rates for similar loans. All loans are covered by demand notes and are repayable through payroll deductions. Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

Forfeitures: The Plan provides that the forfeitures of terminated participants' non-vested accounts may be used to pay the Plan's administrative expenses or to offset Company contributions to the Plan. At December 31, 2024 and 2023, there were \$1,322 and \$3,017, respectively, of forfeitures available to offset future Company contributions or future administrative fees. During 2024, \$82,945 of forfeitures were used to offset the Plan employer matching contributions, and \$110,961 of forfeitures were used to offset Plan administrative expenses.

Payment of Benefits: Upon termination of service due to death, disability or retirement, or one year after a leave of absence, a participant is eligible to receive an amount equal to the value of the participant's vested balance in his or her account. Benefit amounts under \$1,000 are automatically distributed to participants. Participants or their beneficiaries upon the death of the participant may elect to receive their vested account balances as an annuity or as a single lump sum. Benefits are recorded when paid. Participants that have not attained age 59½ may make "hardship withdrawals" as defined by the Internal Revenue Code. Participants in service may also make in service withdrawals upon reaching age 59½.

Administrative and Investment Management Expenses: Loan origination fees associated with notes receivable from participants and the Plan's record keeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses of the Plan. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income reported by the Plan. All other expenses of the Plan are paid by the Company.

Subsequent Events: Management has performed an analysis of the activities and transactions subsequent to December 31, 2024 to determine the need for any adjustments to or disclosure within the financial statements for the year ended December 31, 2024. Management has performed their analysis through October 13, 2025, which was the date that the financial statements were available to be issued and has determined that there are no subsequent events to disclose.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Investment Valuation and Income Recognition: The Plan's investments, other than fully benefit responsive investment contracts, are reported at fair value as further described in Note 4. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contracts, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTE 3 – CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, the trustee of the Plan.

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

NOTE 4 – FAIR VALUE MEASUREMENTS (Continued)

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Pooled Separate Accounts: The fair values of participation units held in pooled separate accounts are based on the net asset values reported by the fund managers as of the financial statement dates and recent transaction prices. Each pooled separate account provides for daily redemptions by the Plan, limited to one transfer per thirty-day periods, with no advance notice requirements, and has redemption prices that are determined by the fund's net asset value per unit.

Collective Trusts: The fair values of participation units held in the collective trusts are based on the net asset values per unit as reported by the funds' managers. The collective trusts provide for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – TRADITIONAL FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan held a traditional fully benefit-responsive investment contract with Principal Life Insurance Company (“Principal”; “Issuer”) that was reported at contract value, which was generally the amount a participant would have received if he or she had initiated a withdrawal or transfer from the contract under the provisions of the Plan. Contract value represented contributions made to the contract, plus earnings, less participant withdrawals and administrative expenses. The investment contract was terminated during 2024, and the Plan no longer held any fully benefit-responsive contracts as of December 31, 2024.

Principal maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract provided stability of principal and provided a specified interest rate that was guaranteed to the Plan. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There were no reserves against contract value for credit risk of the Issuer or otherwise.

Certain events could have limited the ability of the Plan to transact at contract value with the Issuer and could have resulted in a deferral of the payment at contract value for up to 12 months. Such events included but were not limited to the following: (1) removal of a group of participants from plan coverage as a result of temporary absence, change in position or other occurrence qualifying as a temporary break in service under the Plan; (2) transfer or other change of position resulting in employment by an entity controlling, controlled by, or under other common control with the employer; (3) cessation of an employment relationship resulting from a reorganization, merger, layoff, or the sale or discontinuance of all or any part of the Plan sponsor’s business; (4) removal from the Plan of one or more groups or classifications of participants; (5) partial or complete plan termination; or (6) plan disqualification. The Plan administrator did not believe that the occurrence of any such event, which would have limited the Plan’s ability to transact at contract value with participants, was probable.

NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Investment management fees are paid for by the Plan to investment managers who qualify as parties-in-interest. These investment management fees are reflected in the financial statements as a reduction of the return on the Plan's investments. The Plan held investments in collective trust funds issued by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company which qualify as party-in-interest investments. The investment contract and pooled separate accounts are issued by Principal Life Insurance Company, an affiliate of Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company which qualifies as a party-in-interest investment. Additionally, party-in-interest transactions include notes receivable from participants at December 31, 2024 and 2023. During 2024, the Plan paid administrative fees of \$295,798 to Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company which qualify as party-in-interest transactions.

NOTE 7 – INCOME TAX STATUS

The Internal Revenue Service issued an opinion letter dated June 20, 2022 indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (IRC).

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
