Opinion on the 2024 Financial Statements

We have audited the accompanying financial statements of HeiTech Services, Inc. Health and Welfare Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits (modified cash basis) and benefit obligations (modified cash basis) as of December 31, 2024, and the related statements of changes in net assets available for benefits (modified cash basis) and changes in benefit obligations (modified cash basis) for the year then ended, and the related notes to the financial statements (2024 Financial Statements).

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits and benefit obligations of the Plan as of December 31, 2024, and the changes in its net assets available for benefits and changes in benefit obligations for the year then ended in accordance with the modified cash basis of accounting.

Our opinion is not modified with respect to this matter.

Responsibilities of Management for the 2024 Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting; and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the 2024 Financial Statements

NOTES TO FINANCIAL STATEMENTS

For the Years Ended December 31, 2024 and 2023

1. DESCRIPTION OF PLAN

The following description of the HeiTech Services, Inc. Health and Welfare Plan (Plan) provides only general information about the Plan's provisions. Participants should refer to the plan agreement for a complete description of the Plan's provisions.

General

The Plan was established on May 1, 2008, and is a contributory defined contribution and defined benefit health and welfare plan established by HeiTech Services, Inc. (the Company or Plan Sponsor). The Plan has a defined contribution feature in consideration of the premium reserve accounts maintained for each Service Contract Act (SCA) employee. The Plan sponsor established a trust fund to serve as a funding vehicle for the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is managed by trustees, which are primarily representatives of the Corporation. The trustees retained the services of a third-party administrator, GSA National (GSA), which specializes in administration services for benefit plans and trusts. The Plan also retained United Healthcare, Delta Dental of California, Mutual of Omaha, and other carriers to provide insurance, claims processing, and benefits.

Eligibility and Benefits

The Plan provides health benefits (medical, prescription, dental and vision) for eligible employees of the Company and their dependents. The Plan also offers voluntary life insurance, short and long-term disability, and other fringe benefits. All employees of the Company, including employees who worked under federal contracts covered by the McNamara-O'Hara Service Contract Act (the Act), or any other federal, state or local prevailing wage law, who are regularly scheduled to work at least 30 hours per week are eligible to participate in the Plan on the first day of the month following their date of hire. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Self-Insured Benefits

The Plan's dental benefit is self-insured. The claims for the self-insured benefit are processed by the third-party claims processor under an administrative service only (ASO) arrangement. The claim processor pay claims directly to or on behalf of the participants and are then reimbursed by either the Plan's trust or the general assets of the Company. Ultimate responsibility for payments to providers and participants is retained by the Plan.

Fully Insured Benefits

The Plan fully insures all other benefits. The Plan purchases annual insurance contracts for these benefits. Premiums for these benefits are paid to the insurance companies from assets of the Plan's trust or general assets of the Company.

Experience-Rated Contracts

Certain insurance contracts are subject to experience-rating adjustments. Experience ratings (calculated as the difference between premiums paid and the total of claims paid and fees charged by the insurance company) are determined by the insurance company in the following year and may result in a premium surplus or deficit.

Health Savings Accounts

The Plan offers Health Savings Accounts (HSAs) to eligible participants in conjunction with a high-deductible health plan (HDHP). HSAs are tax-advantaged accounts that allow participants to save and pay for qualified medical expenses. Contributions to HSAs may be made by both the employer and the employee, subject to annual limits established by the Internal Revenue Service (IRS). HSA contributions are deposited into individual custodial accounts held in the name of each participant. During the years ended December 31, 2024 and 2023, the employer contributed \$4,900 and \$1,600, respectively, to participant HSAs. Participant contributions to HSAs are made through payroll deductions. These contributions were made directly to the participants' custodial accounts. The Plan does not retain legal title to these funds, and the accounts are not considered plan assets under ERISA Title I. As such, the financial activities of the HSAs are not included in the Plan's financial statements.

Contributions

The Plan is funded by employer, employee, and COBRA contributions. In addition to deductibles and copayments, participants contribute specified amounts, determined annually, for coverage of themselves and their dependents. These amounts are determined based on a review of the Plan's payment trends and an estimation of expected costs for the following year, as recommended by an independent third-party specialist.

For employees covered under the Act, employer contribution rates were established annually by the Plan in accordance with prevailing wage rates and health and welfare rates for employees covered under the Act. The Plan sponsor adjusted the health and welfare contribution rates midyear annually upon renewal or modification of the contract by the federal government. The Plan sponsor provided qualified fringe benefits for each employee

Contributions (Continued)

covered by the Act up to the statutory limitations. For the years ended December 31, 2024 and 2023, the Company contributed based on The Act's effective health and welfare contribution rate established by the Department of Labor (DOL) as follows:

- \$4.80 per hour through July 2023,
- \$4.98 per hour through July 2024, and
- \$4.80 per hour thereafter.

The Plan sponsor may also elect to take premium rebate credits against the required health and welfare contributions for qualified fringe benefits provided by the Company outside of the Plan in meeting the health and welfare contribution rate requirement under the Act and as required for the Plan to meet its obligations to Plan participants and service providers. The Company also contributes excess funds in participant premium reserve accounts, as defined and maintained by the Plan, to a qualified retirement plan established for the benefit of Plan participants.

The Company makes contributions to the Plan as needed to fund claims in excess of participants' contributions. Any deficiency of the Plan's net assets over benefit obligations is funded by the Company on a pay-as-you-go basis.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America (US GAAP). Accordingly, certain liabilities and expenses are recognized when paid rather than when the obligation is incurred. Interest income and contributions are recognized and recorded when cash is received rather than when it is earned. In the same manner, expenses and claims are recognized and recorded upon disbursement of cash.

Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, disclosure of estimated health claims IBNR, disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates. An estimate that is particularly susceptible to significant change in the near-term is the IBNR. Although it is not possible to measure the degree of variability inherent in this estimate, management believes that the amount reported is adequate. Any adjustment determined to be necessary is reflected in current operations.

Cash

Cash is defined as currency on hand, in demand deposits.

Concentrations

The Plan maintains cash balances in financial institutions that at times may exceed federally insured limits. As of December 31, 2024 and 2023, the Plan did not have any deposits in excess of the Federal Deposit Insurance Corporation (FDIC) insurance limits. The Plan has not experienced any losses in such accounts and believes it is not exposed to any significant credit risks on cash.

Premium Rebates

The Company also may elect to take premium rebate credits for benefits provided by the plan sponsor outside of the Plan in meeting the health and welfare contribution rate requirement under the Act and as required for the Plan to meet its obligations to plan participants and service providers. The Plan may also direct the plan sponsor to contribute excess funds in participant premium reserve accounts, as defined and maintained by the Plan, to a retirement trust fund established for the benefit of plan participants. Whether the qualified fringe benefits are provided for employees through the Plan or directly by the plan sponsor, the Corporation is required to demonstrate compliance with the prevailing wage and health and welfare contribution rate requirements. The Plan is designed to facilitate compliance.

For the years ended December 31, 2024 and 2023, the Company applied premium rebates credits of \$357,099 and \$273,367, respectively, for qualified fringe benefits funded directly by the Company for plan participants outside of the Plan, including excess prevailing wage contributions to a retirement plan and leave paid in excess of statutorily required amounts.

Any premium rebate credits unapplied as of the end of the reporting period are reflected as accrued premium rebate liabilities in the accompanying financial statements. As of December 31, 2024 and 2023, the Plan reported no significant accrued premium rebates for unapplied rebate credits for benefits provided by the Company to plan participants outside of the trust. The premium rebate credits are generally determined by the Company and per funding policies adopted by the Plan and are applied to monthly contributions to the Plan.

Premium Reserve

Where required, the Plan maintains accounts for each participant working on contracts covered by the Act. Some contracts require the plan sponsor to demonstrate compliance with the prevailing wage and health and welfare contribution requirements on an individual participant basis and others only require demonstration on an average participant basis. As such, the accrued premium reserve represents the unexpended contributions remaining in the participants' premium reserve accounts, as defined by the Plan, or amounts necessary to meet compliance on an average basis for employees working on contracts requiring average based compliance. The Corporation makes contributions to premium reserve accounts for employees covered by the Act at the prevailing health and welfare fringe contribution rate established by the Act up to the statutory limitations set forth under the Act.

The accumulated eligibility credits or unexpended amounts remaining in the participant premium reserve accounts are either used to fund qualified fringe benefits or are directed to a retirement trust fund for the benefit of participants and as such, are reflected as accrued premium reserve obligations in the accompanying financial statements. As of December 31, 2024 and 2023, the Plan reported accrued premium reserve obligations of \$33,282 and \$32,794, respectively, for accumulated eligibility credits available for benefits or funding as excess prevailing wage contributions to a retirement plan.

Payment of Benefits

Premiums paid by either the Company or the trust are recorded as insurance premiums in the accompanying statements of changes in net assets available for benefits. Dental benefit claims paid by the Plan are recorded as claims paid in the accompanying statements of changes in net assets available for benefits.

IBNR is estimated by the Plan's benefit consultant based on claims data provided by the Plan's self-insured claims administrator. This analysis and estimate is based on a series of regression and trend analyses of claims paid and other factors. Given the improvement in the timeliness of claim payments realized by the Plan and nominal effective interest rates, management's estimate for claim reserve did not include an escalation factor.

Where required, the Plan maintains accounts for each participant who worked on contracts covered by the Act. Accrued premium reserve is reported in the accompanying statements of benefit obligations and represents the unexpended contributions remaining in the participants' premium reserve accounts.

Administrative Expenses

Certain expenses, such as administrative, recordkeeping, accounting, bank, and other fees are paid by the Plan and reported in the accompanying financial statements as costs are incurred. Certain expenses and administrative services of maintaining the Plan are paid/performed by the Company and are excluded from these financial statements. During the years ended December 31, 2024 and 2023, the Plan paid administrative expenses of \$96,988 and \$75,490, respectively.

3. PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan sponsor has the right under the Plan to modify or discontinue any terms, conditions, or benefits of the Plan at any time and terminate the Plan subject to the provisions of ERISA, the insurer's contract, and the contract administration agreement. Expenses incurred prior to a termination, modification, or amendment of the Plan would be paid as provided under the terms of the Plan prior to its termination, modification, or amendment. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

4. TAX STATUS

The trust established under the Plan to hold the Plan's assets has not applied for exemption from federal or state income taxes. The Plan is required to pay federal and state taxes on unrelated business income as defined by the Internal Revenue Code (IRC). Unrelated business income consists of investment income earned on the excess of the net assets available for plan benefits over the required reserve balance allowable under the IRC. The Plan sponsor believes the Plan does not have any net taxable income for the years ended December 31, 2024 and 2023; therefore, no tax liability is reflected in these financial statements.

US GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

5. PARTY-IN-INTEREST TRANSACTIONS

Delta Dental is the self-insured claims administrator of the Plan. GSA is the Plan's third-party administrator. Therefore, transactions with these parties qualify as party-in-interest transactions. The Plan paid fees to Delta Dental, and GSA related to administrative services rendered for the years ended December 31, 2024 and 2023. Certain administrative functions are performed by officers or employees of the Plan sponsor. No such officers or employees receive compensation from the Plan.

6. RISKS AND UNCERTAINTIES

The Plan is subject to various risks and uncertainties that may affect its ability to provide benefits to participants. These include changes in healthcare regulations, fluctuations in healthcare costs, demographic shifts in the covered population, and potential changes in employer contributions or plan design. Although the Plan does not currently hold any investments, it remains exposed to operational and external factors that could impact future funding requirements and benefit obligations. Plan management monitors these risks and works with advisors and service providers to mitigate potential adverse effects.

6. RISKS AND UNCERTAINTIES (Continued)

Some of the Plan’s participants are employees of the Company working under contracts with the federal government, many of which are subject to the Act. As such, federal contracts are subject to termination clauses whereby the government may terminate contracts for cause or convenience. Any contract terminations or funding delays caused by political, budgetary, or other administrative matters may affect employees participating in the Plan and the ability and necessity of the Plan sponsor to fund and maintain the Plan.


