As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Notes to Financial Statements

Note 1: Description of Plan

The following information of Bank of Ireland Group U.S. Retirement Plan (the "Plan") provides only general information. Members should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was restated as of January 1, 2019. The Plan was originally established as the Retirement Plan of First NH Banks, Inc., effective January 1, 1985. The Plan was later merged with The Governor and Company of the Bank of Ireland Employees' Retirement Plan on December 31, 1994.

The Plan is a noncontributory defined benefit plan. Contributions to provide benefits under the Plan are made by the Plan Sponsor and Plan Administrator, The Governor and Company of the Bank of Ireland (the "Company"). The Plan covers employees of the Company. The contributions are held in trust by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company. The contributions are made in amounts sufficient to meet the minimum funding standards of the Employee Retirement Income Security Act of 1974, as amended, (ERISA) and the Internal Revenue Code. Company contributions of \$1,270,919 and \$0 were made for the years ended December 31, 2024 and 2023, respectively. According to the restated Plan documents, administrative costs will be paid by the Plan, unless directly paid by the Company. For 2024 and 2023, administrative costs of \$156,052 and \$153,293, respectively, were paid by the Plan.

The Plan was amended in November 2004 for the purpose of freezing benefit accruals and Plan membership, effective December 31, 2004. The amendment provides that no additional benefits will accrue under the Plan to any member, former member or employee after December 31, 2004, and that a member's normal retirement benefit shall not exceed the benefit earned under the Plan as of December 31, 2004. Furthermore, the amendment provides that no individual shall be allowed to become a member or reinstate membership in the Plan after December 31, 2004. The Plan is subject to the provisions under ERISA, as amended.

The Plan was amended in 2024 to terminate the Plan effective December 31, 2024, and management determined that liquidation was imminent. Management determined it would be in the Company's best interest to terminate the Plan citing current rate environment and the Plan's funded status. Final distributions are expected in 2025. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements.

Benefits

The Plan provides for retirement benefits to be paid in the form of annuities to Plan members who have reached the age of 65 and who have retired from active service. Such benefits are defined in the Plan and are based on compensation levels and years of service. The Plan also provides for specified benefits for surviving spouses and for early retirement of Plan members on the later of the date age 55 or 10 years of service have been reached, for eligible members, at proportionately reduced benefits. These benefits have been frozen pursuant to the previously discussed November 2004 amendment.

Note 1: Description of Plan (Continued)

Vesting

Participants with five years of service are generally considered to be 100% vested, while participants with less than five years of service are not vested at all. All participants are fully vested at age 65. The vested retirement allowance is equal to the normal retirement allowance computed on the basis of compensation and credited service and is deferred to commence on an employee's normal retirement date. As of December 31, 2024 and 2023, all participants are fully vested.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying 2024 financial statements of the Plan are prepared on the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP). The accompanying 2023 financial statements of the Plan are prepared on the accrual (ongoing) basis of accounting in accordance with GAAP.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions in net assets during the reporting period. Actual results could differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants on the measurement date. See Note 7 for a discussion of fair value measurements.

Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued. In June 2025, substantially all of the Plan's assets were transferred to Principal as part of the liquidation of the Plan.

Note 3: Actuarial Assumptions

Accumulated Plan benefits are those future periodic payments, including lump-sum distributions, that are attributable under the Plan's provisions to service rendered by employees as of the valuation date. Accumulated Plan benefits include benefits expected to be paid to: (i) retired or terminated employees or their beneficiaries, (ii) beneficiaries of employees who have died, and (iii) present employees or their beneficiaries. The actuarial present value of accumulated Plan benefits is determined by the Plan's independent actuary, Principal Life Insurance Company, and is that amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal or retirement) between the benefit information date and the expected date of payment. The more significant assumptions underlying the latest actuarial valuation (January 1, 2024) are as follows:

Interest rate: 4.75%

Mortality table: Based on the Society of Actuaries Pri-2012 White collar base rate mortality table projected generationally using MP-2021. MP-2021 is the most recent improvement scale published by the Society of Actuaries in October 2021.

Normal retirement: Age 65

Valuation method: Average of the adjusted market value over the last 2 years preceding the valuation date.

Funding method: Funding target is the present value of the benefits accrued on the valuation date.

The foregoing actuarial assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of accumulated Plan benefits. As discussed in Note 1, the Plan was amended to terminate effective December 31, 2024.

Note 5: Plan Termination

In the case of termination of the Plan, the assets of the Plan that are available to provide benefits shall be allocated and applied as of the effective date of termination of the Plan, according to the classifications and order of precedence provided under Title IV of ERISA.

Note 5: Plan Termination (Continued)

Certain benefits under the Plan are insured by the Pension Benefit Guaranty Corporation (PBGC) if the Plan terminates. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits, and certain disability and survivor's pensions. However, the PBGC does not guarantee all types of benefits, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination, and there is a statutory ceiling, which is adjusted periodically, on the amount of an individual's monthly benefit that the PBGC guarantees. Whether all participants receive their benefits should the Plan terminate at some future time will depend on the sufficiency, at that time, of the Plan's net assets to provide for accumulated benefit obligations and may also depend on the financial condition of the plan sponsor and the level of benefits guaranteed by the PBGC.

As discussed in Note 1, the Plan was amended to terminate effective December 31, 2024.

Note 6: Contract with Insurance Company

The Plan is a party to a group annuity contract with Principal Life Insurance Company, under which all contributions received by the Plan are deposited with the insurance company and invested in mutual funds or pooled separate accounts selected by the Plan sponsor.

The pooled separate accounts are accounts that are segregated from the general accounts of Principal Life Insurance Company. The funds invested in the pooled separate accounts by Principal's Group Annuity Contract holders may be invested in stocks, bonds, mutual funds, mortgages, real estate, other separate accounts or cash and cash equivalents. The pooled separate accounts are credited with the income and expenses and gains and losses of the underlying investments. Principal holds title to all assets held within the pooled separate accounts and the Plan owns accumulation units in each of the accounts. The change in value from year to year of the Plan's accumulation units held in the pooled separate accounts is recorded in the accompanying financial statements. See Note 7 for a discussion of fair value measurements.

Note 7: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of quoted prices for similar assets in active markets, quoted prices for identical or similar assets in inactive markets, observable inputs other than quoted prices or inputs derived principally from or corroborated by observable market data by correlation or other means; and Level 3 inputs consist of inputs that are unobservable and significant to the fair value measurement and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. An asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Note 7: Fair Value Measurements (Continued)

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

The pooled separate accounts are valued, as a practical expedient, at the net asset value (NAV) of the respective accounts based on the quoted market prices of the underlying assets held in these accounts. This practical expedient would not be used if it was determined to be probable that the funds would sell the investments for an amount different from the reported NAV.

The mutual funds are valued at the quoted market prices of the shares held by the Plan. The mutual funds held by the Plan are deemed to be actively traded.

Note 8: Information Prepared and Certified by the Custodian

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments and interest and dividend income for the years then ended, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Principal Trust Company), the Custodian of the Plan.

Note 9: Related Party and Parties-in-Interest Transactions

Certain Plan investments are units of pooled separate accounts managed by entities related to the custodian, all of whom are member companies of the Principal Financial Group. The fair value of these accounts at December 31, 2024 and 2023, was \$219,214 and \$201,563, respectively. Administrative expenses paid by the Plan to Principal Life Insurance Company were \$99,694 in 2024 and \$97,709 in 2023. Investment related expenses are included in the net appreciation (depreciation) in fair value of investments.

The Plan also has arrangements with the Custodian, entities related to the Custodian and various other service providers which qualify as party-in-interest transactions under ERISA.

Note 10: Tax Status

The Internal Revenue Service issued an opinion letter, dated March 30, 2018, in which they stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has since been amended and restated, management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, the Plan is qualified, and the related trust is tax-exempt. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

Note 11: Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Plan contributions are made, and the actuarial present value of accumulated Plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimation and assumption process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

Methods prescribed by law

Liability measure Funding target is the present value of the benefits accrued on the valuation date.

Methods selected by plan sponsor

Asset method The asset valuation method is prescribed by law for plans that elect to use a value other than market value.

For each of the preceding two years, an expected value of assets at the end of the year is compared to the end of year market value. The resulting gain or loss is recognized evenly over three plan years.

The expected value includes contributions, distributions, any deducted administrative expenses, and expected earnings (based on the lesser of the assumed interest rate or the maximum allowable rate). The deferred gains and losses are added to the current market value and then restricted to no more than 110% and no less than 90% of that market value.

When actual returns exceed the assumed return, the actuarial value of assets will lag below market value. The lag and the smoothing effect are limited since the value must be within 10% of market value.

Segment rates 24-month average with no weighting to prior law basis. Use rates where October is the last month included in the average.

PBGC premium basis Variable rate premiums are calculated using census, market value of assets and the one-month average of corporate bond rates in effect on the valuation date. You elected this Standard interest method for the 01/01/2023 plan year and the method must be used for five years before a change can be made.

Methods elected by actuary

Retirees Assets and liabilities for current and future retirees are included.

Vested benefits A benefit is included in vested benefits if it meets the requirements under PBGC. The benefit is multiplied by the participant’s vesting percentage applicable to each benefit on the valuation date.

The following ancillary benefits are always treated as nonvested: disability benefits payable to retirement age unless in pay status, pre-retirement death benefits in excess of the survivor annuity death benefit and post retirement death benefits for non-retired participants except as noted in the Plan provisions.

Assumptions and methods elected by actuary - plan accounting (ASC 960)

With the exceptions below, all assumptions and methods are the same as those used in determining your plan's regular funding target and target normal cost.

Mortality Based on Pri-2012 White collar base rate mortality table projected generationally using MP-2021.

The Society of Actuaries (SOA) is an actuarial organization that periodically reviews mortality data and publishes mortality tables and improvement scales. In October 2019, the SOA released the Pri-2012 Mortality Tables for private-sector retirement plans in the U.S. The Pri-2012 report contains different sets of mortality tables based on complete dataset or various subsets. The White collar base rate table was selected based on information provided by the plan sponsor.

Pri-2012 section 12.4. provided three approaches for designated beneficiaries in the calculation of joint-and-survivor annuities. We believe "Approach 1" is reasonable for this plan and has been selected due to data limitations in identifying contingent survivors. In addition, we believe beneficiary mortality isn't materially different while both participants are alive.

Mortality improvement MP-2021 is the most recent improvement scale published by the SOA in October 2021.

In selecting this assumption, we considered the other parameters available in the MIM-2021-v4 application tool issued by the SOA in October 2023 and consider the selections in MP-2021 reasonable. Based on the sponsor's input, plan experience does not show a need for long-term excess death or Covid death load adjustments.

Interest rate used to value liabilities 4.50%

The interest rate used to value ASC 960 liabilities is developed as long-term expected geometric return on plan assets. Arithmetic expected return is calculated as the weighted average of broad asset classes' arithmetic returns of the plan's target asset allocation, and then converted to the geometric under lognormal distribution assumption. For details, see Long-Term Capital Market Assumptions link.

Treatment of administrative expenses

No adjustments are made for administrative expenses, either through a reduction in the discount rate or by calculating a present value of future expenses.

Plan sponsors may change their administrative expense handling at any time. Our approach provides consistent handling of ASC 960 liabilities from year to year, whether expenses are paid with plan assets or directly by the employer.

Note - expenses paid with plan assets are required to be included in funding normal cost. As a result, the plan is reimbursed annually through required funding. Exception – contributions are not required due to assets sufficiently in excess of liabilities to fund both expenses and normal cost. In this case, administrative expenses are taken from the excess assets.

The optional form conversion basis is 7.0% interest and 1971 Group Annuity Mortality Table – Male for payments other than lump sums.

The optional form conversion basis uses the applicable interest rate and applicable mortality table as set forth in Code Section 417 for lump sum payments. The applicable interest rate uses the second calendar month preceding the first day of the stability period which is the plan year.
