## INDEPENDENT AUDITOR'S REPORT

Trustee and Plan Administrator  
Infinity Plumbing Designs 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Infinity Plumbing Designs 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for plan benefits for the year the ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution, agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **NOTE 1 – DESCRIPTION OF THE PLAN**

The following description of Infinity Plumbing Designs 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### General

The Plan is a qualified defined-contribution plan established January 1, 2018, and amended effective January 1, 2019, by Infinity Plumbing Designs, Inc. (the “Employer”), under the provision of Section 401(k) of the Internal Revenue Code (IRC). The Plan provides for a qualified cash or deferred arrangement, as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Employer.

#### Administration

The Plan is administered by the Employer and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Principal Life Insurance Company (the “Custodian”) is responsible for the custody of the Plan’s assets and is the Plan’s recordkeeper. Andrew Carlson (the “Trustee”) is responsible for the management of the Plan’s assets.

#### Eligibility

Any employee who has attained age 21 and completed 90 days of consecutive service is eligible to participate in the Plan. Employees who are considered independent contractors are not eligible. Acquired employees may be excluded from the Plan for a period of time, as determined by the Employer and in accordance with requirements of the IRC. Participation in the Plan may begin on the first day of the month on or after eligibility requirements are met.

#### Participant Contributions

Participants are automatically enrolled based on the Plan’s default elective deferral of 5% of the participants’ pretax eligible compensation, unless the participant elects a different percentage. Participants may elect to contribute, on a pretax basis, up to 100% of their eligible compensation, in an amount not in excess of the maximum allowed by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make additional catch-up contributions. Participants may also make contributions to the Plan on an after-tax basis, as Roth deferrals, as defined in the Plan agreement and subject to the limitations under the IRS, as listed above. Participants may also roll over amounts representing distributions from other qualified benefit or contribution plans.

#### Employer Contributions

The Employer may make discretionary matching contributions to all active participants who have 1,000 or more hours of service in the Plan Year. The Employer may also make discretionary nonelective profit-sharing contributions to the Plan allocated as of the last day of the Plan Year. For the year ended December 31, 2024, no discretionary contributions were made.

### **NOTE 1 – DESCRIPTION OF THE PLAN (Continued)**

#### Vesting

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Employer's discretionary contribution portion of their accounts is based on years of continuous service. A participant becomes 20% vested every year following a full year of service as defined, and continues to vest at the rate of 20% for each successive year of service until they are 100% vested after five years of credited service.

#### Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Employer's contribution and Plan earnings, and charged with an allocation of administrative expenses to the extent that were not paid by the Employer. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Investment Options

Participants may direct participant and Employer contributions, as desired, in any of several investment options offered by the Plan. Participants may change their investment options any time throughout the year, via the internet website, or by using the automated telephone system offered by the custodian.

#### Notes from Participants

Participants may borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000, or 50% of their accounts' balances, whichever is less. Note terms range from one to five years, except for notes related to the purchase of a primary residence, which may be longer. The notes are secured by the balance in the participant's account and bear interest at a rate that a bank or other professional lender would charge for a note in a similar circumstance. Current note interest rates range from 5.25% to 10.50%, as of December 31, 2024, and 2023, and mature through November 2028. A participant may have no more than one note outstanding at one time. Interest income is recognized when earned. Principal and interest are paid ratably through payroll deductions.

#### Benefit Payments

Upon termination of employment with the Employer, a participant will receive a lump-sum disbursement if his or her vested account balance is \$5,000 or less. If the vested account balance is greater than \$5,000, the participant is entitled to maintain their account in the Plan, receive a lump-sum amount, monthly annuity or direct rollover to another qualified plan. In the event of death or total and permanent disability, a participant's beneficiary or the participant is entitled to the total value of the participant's account.

#### Financial Hardship Distributions

The Plan allows for hardship withdrawals in accordance with IRS regulations. Among other things, the withdrawal must be necessary in light of immediate and heavy financial needs of the participant and is limited to certain purposes.

### NOTE 1 – DESCRIPTION OF THE PLAN (Continued)

#### Forfeitures

A participant's accounts are forfeited if the Employer contribution portion has not been fully vested at the time of withdrawal or termination. These amounts may be used to reduce Employer contributions and/or make additional discretionary Employer contributions. During the Plan years ended December 31, 2024, and 2023, no forfeitures were used to pay Employer contributions. As of December 31, 2024 and 2023, there were no forfeitures available.

#### Administrative Expenses

Most administrative expenses for maintaining the Plan are paid by the Employer. Certain administrative fees are charged to the individual participant's account. Expenses that are paid by the Employer are excluded from these financial statements.

### NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Presentation

The accompanying financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

#### Use of Estimates

The preparation of the Plan's financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for plan benefits and changes therein and, when applicable, disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset, or paid to transfer a liability, in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Management fees and operating expenses charged to the Plan for its investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for applicable investments.

#### Notes from Participants

Notes from participants are measured at their unpaid principal balance, plus any accrued unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses have been recorded as of December 31, 2024 and 2023.

#### Payment of Benefits

Benefit payments to participants are recorded when paid.

### NOTE 3 – INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Life Insurance Company, the custodian of the Plan, has certified the completeness and accuracy of all investments and notes from participants reflected on the accompanying statements of net assets available for plan benefits as of December 31, 2024 and 2023, and the supplemental schedule, Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes from participants reflected in the statement of changes in net assets available for plan benefits for the year ended December 31, 2024.

### NOTE 4 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets,
- Quoted prices for identical or similar assets or liabilities in inactive markets,
- Inputs other than quoted prices that are observable for the asset or liability, and
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

### NOTE 4 – FAIR VALUE MEASUREMENTS (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs, and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Common collective trusts:* Units held in common collective trusts (CCT) are valued using the net collective asset value practical expedient (NAV practical expedient) of the CCT as reported by the CCT managers. The NAV practical expedient is based on fair value of the underlying assets owned by the CCT, minus its liabilities, and then divided by the number of units outstanding. The NAV of a CCT is calculated based on a compilation of primarily observable market information. The CCT have a daily redemption frequency, no redemption period or restrictions and have no unfunded commitments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value, or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### NOTE 5 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Principal Life Insurance Company; therefore, these transactions qualify as exempt party-in-interest transactions permitted by the United States Department of Labor Rules and Regulations. The Employer and Plan administrator are also parties-in-interest with respect to the Plan. Fees paid by the Plan to the custodian amounted to \$9,345 for the year ended December 31, 2024. Notes from participants and the related interest income of \$2,018 are also considered related party transactions.

### NOTE 6 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities, including common collective trusts. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for plan benefits.

### **NOTE 7 – FEDERAL INCOME TAX STATUS**

Effective February 17, 2022, the Plan adopted a non-standardized form of a prototype profit sharing plan sponsored by Principal Life Insurance Company. The prototype plan has received an opinion letter, dated June 30, 2020, from the IRS as to the prototype plan's qualified status. The prototype plan's opinion letter has been relied upon by this Plan. The Plan administrator and the trustees believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan, and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. Plan management has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability, asset, or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **NOTE 8 – PLAN TERMINATION**

Although it has not expressed such intent, the Employer, by action of its Board of Directors, reserves the right, at any time, to amend or terminate the Plan. Upon termination of the Plan, further contributions to the Plan shall cease. Net assets available for benefits would be distributed to the participants based on each participant's interest in the Plan and all participants would become 100% vested in all contributions.

### **NOTE 9 – PROHIBITED TRANSACTIONS**

As required by ERISA Section 2510.3-102, the Employer is required to segregate participant contributions from its general assets and remit them to the Plan as soon as administratively feasible.

During the Plan year ended December 31, 2023, the Employer inadvertently failed to remit certain participant contributions totaling \$769, respectively, of participant deferrals within the required timeframe as stated by the United States Department of Labor (DOL). In April 2023, the Sponsor paid lost earnings on \$190 of the \$769 of late participant deferrals outside of the DOL's Voluntary Fiduciary Correction Program, which were paid from the Sponsor's assets and not from assets of the Plan. In September 2024, the Sponsor paid lost earnings on \$579 of the \$769 of late participant deferrals outside of the DOL's Voluntary Fiduciary Correction Program, which were paid from the Sponsor's assets and not from assets of the Plan.

### NOTE 10 – OPERATIONAL DEFECT

During the year ended December 31, 2023, it was discovered that the Plan’s provisions were not properly applied in the daily operation of the Plan. The definition of compensation for participant contributions as defined per the Plan document was not properly applied when calculating contribution amounts totaling \$8,950. In September 2024, the Plan Administrator deposited \$6,050 of the \$8,950 of total missed contributions as qualified nonelective contributions (QNEC) and corresponding interest to make the affected participants and the Plan whole. The Plan administrator will deposit \$2,900 of the \$8,950 of total missed contributions into the Plan as qualified nonelective contributions (QNEC) to make the affected participants and the Plan whole, including interest during the year ended December 31, 2025.

During the year ended December 31, 2023, it was discovered that the Plan administrator failed to capture participant deferral election changes. The Plan administrator determined the affected participants and will deposit \$4,648 into the Plan as qualified nonelective contributions (QNEC) to make the affected participants and the Plan whole, including interest during the year ended December 31, 2025.

During the year ended December 31, 2024, it was discovered that the Plan’s provisions were not properly applied in the daily operation of the Plan. The definition of compensation for participant contributions as defined per the Plan document was not properly applied when calculating contribution amounts. The Plan administrator determined the affected participants and will deposit \$19,090 into the Plan as qualified nonelective contributions (QNEC) to make the affected participants and the Plan whole, including interest during the year ended December 31, 2025.
