Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of P1 Technologies, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements are comprised of the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of P1 Technologies, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The accompanying notes are an integral part of these financial statements and should be read in connection therewith.

Note 1. Description of Plan

The following brief description of the P1 Technologies, Inc. 401(k) Plan (the “Plan”) provides only summarized information. The Plan document should be referred to for a more complete description of the Plan’s provisions. The Plan initially became effective December 15, 2023, when a significant portion of the 401(k) component of the Company’s Employee Stock Option Plan was transferred to the newly adopted P1 Technologies, Inc. 401(k) Plan.

The Plan is a contributory defined contribution retirement plan commonly known as a 401(k) plan. Employees of the Company can participate in the Plan starting the first day of the month on or after they become eligible, provided they are at least age 18. Participants who are not employed on the last working day of a plan year are generally not eligible for an allocation of Company contributions for such year.

Contributions:

Participants are able to contribute, subject to certain restrictions, up to 100% of their annual compensation. Employees may designate their deferrals as either pre-tax or after-tax contributions. Contributions made on a pre-tax basis reduce the taxable portion of the employee’s compensation by the amount of the deferrals. Contributions made on an after-tax basis (“Roth 401(k) deferrals”) do not have the effect of reducing a participant’s taxable compensation at the time of deferral. Additionally, unlike most distributions of funds from pre-tax contributions, distributions from Roth 401(k) deferrals (and in most cases the earnings thereon) are not taxed to participants upon distribution. Participants may elect to make both pre-tax and after-tax contributions.

The Company may make matching contributions at its discretion. The Company made matching contributions of \$185,436 allocated to eligible employees not to exceed 3% of wages deferred for 2024.

Participants may also transfer amounts to the Plan from other qualified retirement plans, including diversifications from the Company’s Employee Stock Ownership Plan. Referred to as rollover contributions, they are not subject to matching contributions by the Employer. Participants are 100% vested in rollover contributions and the investment earnings thereon.

Participant Accounts:

A separate account is maintained for each participant. Each participant’s account is credited with (1) the participant’s elective and rollover contributions, (2) the Employer’s matching contributions, and (3) allocations of earnings and losses from the respective investment funds. Investment earnings and losses are allocated to participant accounts based on the relative amount of each participant’s balance in each of the respective investment funds. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Note 1. Description of Plan (Continued)

Vesting:

Participants are immediately 100% vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service. Participants are considered to have completed one year of service for purposes of vesting upon completion of 1,000 hours of service at any time during the Plan year.

Notes Receivable from Participants:

The Plan provides for participant loans. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates as determined quarterly by the Plan trustee.

Payment of Benefits:

The vested balance of a participant's account is paid in the form of a lump sum as soon as administratively feasible following termination of employment. In-service withdrawals are permitted in the case of a financial hardship, subject to ERISA and Plan provisions and restrictions.

Forfeitures:

Forfeitures of nonvested balances from terminating participants will be used to reduce future employer contributions or administrative expenses of the Plan.

Plan Expenses:

A substantial portion of the administrative expenses of the Plan are paid by the Employer. However, certain investment-based expenses are paid from Plan funds and allocated to all participants. Additionally, certain transaction related fees directly related to particular participants are paid from the accounts of the participants initiating the transaction. Forfeitures of nonvested participant account balances may be used to pay Plan administrative expenses. Substantially all expenses paid from Plan funds are paid to the custodian.

Participants are charged an administrative fee to process benefit distributions (such as withdrawals of all or a portion of a participant's account). The amount of the distribution paid to the participant is reduced by the amount of the fee. These fees are included in "Administrative Expenses" in the Statements of Changes in Net Assets Available for Benefits.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting:

The Plan's financial statements are presented on the accrual basis.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

Use of Estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investments:

The Plan's investments are stated at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Interest income is recorded on the accrual basis as earned. Purchases and sales of securities are recorded on a trade-basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold (realized) as well as held (unrealized) during the year.

Notes Receivable from Participants:

The Plan's participant loans are stated at actual loan value (contract value). Actual loan value is measured as the total unpaid principal balance plus any accrued but unpaid interest. The aggregate actual loan value does not differ materially from fair value.

Interest income on loans is recognized in the financial statements when loan payments are made by participants.

Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits:

Benefits are recorded when paid.

Date of Management's Review of Subsequent Events:

The financial statements include the effects of events occurring subsequent to the date of the financial statements to the extent they provide evidence about conditions existing as of such date. Events subsequent to the financial statement date have been evaluated for such purpose through October 15, 2025, which is the date the financial statements were available for issuance.

Note 3. Certification of Investment Information

Principal Life Insurance Company ("Principal") is the trustee of all of the Plan's investments. Information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including all investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest on investments, and interest on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Life Insurance Company (the trustee of the Plan).

Note 4. Related Party and Party-in-Interest Transactions

Plan investments are comprised of shares of pooled separate accounts and general account investments managed by the Plan's trustee, and therefore, these transactions qualify as party-in-interest transactions. Administrative fees paid by the Plan were \$20,171 and \$-0- for the years ended December 31, 2024 and 2023, respectively.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note 5. Fair Value Measurements

The fair value measurements authoritative literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

Level 1 Fair Value Measurements

All of the Plan’s investments in pooled separate accounts are valued at the net asset value (“NAV”) of shares held by the Plan at year end. Net asset value is calculated using observable quoted market prices.

General investment accounts are valued at contract value and therefore not reflected in the fair value measurement tables.

The following table sets forth by level, within the fair value hierarchy, the Plan’s investments at fair value as of December 31, 2024 and 2023:

Gains and losses included in changes in net assets available for benefits, for the years ended December 31, 2024 and 2023, are reported in net appreciation (depreciation) in fair value of investments.

The Plan’s policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, there were no transfers between levels.

Note 6. Investment in Principal Guaranteed Option

The Plan invests in the Principal Life Insurance Company Principal Guaranteed Option (“PGO”), which is a group annuity contract and is considered a traditional guaranteed investment contract. The PGO is designed to provide preservation of principal, liquidity at contract value, and a competitive rate of return. Principal Life Insurance Company (“Principal”) maintains the assets supporting the contract within its general account.

The contract is fully benefit-responsive, and therefore is reported at contract value, which is the relevant measure for participant transactions. Contract value represents contributions made to the contract, plus earnings, less participant withdrawals and administrative expenses.

Note 6. Investment in Principal Guaranteed Option (Continued)

Under the terms of the contract, interest is credited daily at a rate determined by Principal, subject to a minimum guaranteed rate as specified in the contract. The crediting rate is based on the yields of the underlying investments, adjusted for expenses and market conditions, and may be reset periodically. Participants may direct transfers to other investment options subject to certain prohibited transaction or equity wash provisions, as defined in the contract.

Principal is required to maintain sufficient assets to meet participant withdrawals at contract value. The contract does not permit Principal to terminate the contract at an amount other than contract value, except in the event of a Plan-level termination or other events as defined in the agreement. The Plan may, at its option, terminate the contract with a 12-month advance notice (or as otherwise specified) and receive contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The occurrence of certain events (e.g., complete or partial Plan termination, changes in Plan administration, failure of the Plan to qualify under the Internal Revenue Code, or material breaches of the contract) could limit the Plan's ability to transact at contract value or could result in termination of the contract at a value other than contract value. The Plan does not believe that any such event is probable.

As of December 31, 2024 and 2023, the contract value of the Plan's investment in the Principal Guaranteed Option was \$1,855,555 and \$7,814,835, respectively. The average crediting rate for the years ended December 31, 2024 and 2023 was between 4 and 5%.

Note 7. Federal Income Tax Status

The P1 Technologies, Inc. 401(k) Plan is comprised of the trustee's Group Prototype Basic Savings Plan and the related adoption agreement. The trustee has obtained a determination letter dated June 2020 in which the Internal Revenue Service stated that the Prototype Plan and certain amendments to the Plan were in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the trustee believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Note 8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 9. Risks and Uncertainties

The investment securities held by the Plan are exposed to various risks such as interest rate risk, market risk, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.
