Opinion

NOTES TO FINANCIAL STATEMENTS

AS OF AND FOR THE YEARS ENDED DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF THE PLAN

General - The following description of Automatic Data Processing, Inc. Flex 2000 Plan (the “Plan”) is provided for general information purposes only. The Plan is a health and welfare plan established May 1, 1977 to provide for survivor, medical, dental, vision, personal accident insurance, employee assistance programs, long-term disability benefits and flexible spending accounts for eligible associates of Automatic Data Processing, Inc. and Subsidiaries (“ADP”, the “Company” or the “Plan Sponsor”) under the Plan. Participants should refer to the Plan document for a complete description of the Plan’s provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

The Company and the trustees entered into an agreement on June 28, 1984, establishing the Automatic Data Processing, Inc. and Subsidiaries Employee Welfare Benefit Trust (the “Trust”). Assets of selected plans are invested in the Trust. The trustees control and manage the operation and administration of the Plan. The Plan allows eligible associates to elect between receiving taxable compensation or purchasing certain non-taxable employee benefits.

Survivor Benefits - All full-time associates of ADP, as defined, are automatically covered for basic life insurance and accidental death and dismemberment insurance (“AD&D”), beginning on the first day of active employment. This coverage is available at no cost to the associate.

Medical, Dental and Vision Benefits - All full-time associates of ADP are eligible for medical, dental and vision coverage on their first day of active employment. Part-time associates must work a minimum of 20 standard hours per week to be eligible for medical, dental and vision coverage. There are four different coverage options: associate only, associate plus spouse/domestic partner, associate plus child(ren), and family coverage. The associate plus spouse/domestic partner, associate plus child(ren), and family coverage options extend benefits to the associate’s eligible dependents, as defined. Benefits from the medical and dental plans include payment of covered expenses, as defined, with part of the cost of coverage borne by the associate through pretax payroll deductions. The full cost of coverage is borne by the associate through pretax payroll deductions for vision benefits. Payroll deduction amounts vary depending upon the coverage option selected. The majority of medical benefits, which include prescription drug benefits, are self-insured and the Plan pays administrative service fees to Aetna Inc. (“Aetna”) and United Healthcare, Inc. The HMOs offered through Kaiser, HMSA, and Triple-S are fully-insured. The Preferred Provider Organization (“PPO”) for dental benefits is self-insured and the Plan pays monthly administrative service fees to Aetna. The Dental Management Organization (“DMO”) for dental benefits is fully-insured and the Plan pays monthly premiums to Aetna. The vision benefits are fully-insured and the Plan pays monthly premiums to Vision Service Plan Insurance Company per coverage option.

Long-term Disability Benefits (“LTD”) - Full-time associates and part-time associates working 20 or more hours per week are eligible to purchase LTD coverage within 31 days of hire. Associates are automatically enrolled in LTD coverage at hire but can opt out of coverage at any time. Associates can purchase LTD at any time thereafter subject to providing evidence of insurability. LTD benefits provide disability income at 60 percent of the participant’s usual base pay, as defined, after 182 consecutive days of disability and up to a monthly maximum benefit of \$15,000 in both 2024 and 2023. Benefits under the Plan continue until normal retirement age provided the participant’s illness or injury continues to meet the definition of disability.

1. DESCRIPTION OF THE PLAN (continued)

However, if the disability begins at age 62 or older, there is a schedule of benefits that may include coverage past normal retirement age. The long-term disability benefits are fully-insured and the Plan pays monthly premiums to Prudential Insurance Company of America per covered participant, as defined in the contract. Disabilities for self-reported symptoms and mental illness generally have a limited pay period of 24 months.

Personal Accident Insurance Benefits - All full-time associates of ADP are eligible to purchase personal accident insurance coverage within 31 days of hire. Coverage options consist of “single” and “family”, with eight benefit options ranging from \$25,000 to \$1 million. The full cost of the coverage is borne by the associate through pretax payroll deductions. Payroll deductions vary depending on the coverage and benefit options selected. Personal accident insurance provides additional financial protection in the event of death or loss of a limb, sight, speech, hearing or paralysis as the result of a covered injury. The personal accident insurance benefits are fully-insured and the Plan pays monthly premiums.

Employee Assistance Program - All full-time and part-time associates employed by ADP (and their household members) regardless of whether the associate is enrolled in the ADP medical plan or any other ADP benefit plans are eligible for benefits under the employee assistance program on date of hire. This program is available at no cost to the associate. The employee assistance program provides confidential counseling services in such areas as marital and family difficulties, substance and alcohol abuse, mental health, stress and financial concerns. Up to eight free counseling sessions are provided per issue per Plan year to covered persons. The benefits provided are fully-insured.

Flexible Spending Accounts (“FSAs”) - All active associates working 20 or more standard hours per week are eligible to enroll in the Health Care FSA (“HCFSA”) or the Limited Purpose Health Care FSA (“LPFSA”) and the Dependent Care FSA (“DCFSA”) within 31 days of their date of hire. Associate contributions to the FSAs are on a pretax payroll deduction basis and all contributions remaining in the accounts at the end of the Plan year are forfeited and revert back to ADP. If the associate is enrolled in the Consumer Driven Health Plan (“CDHP”) option, the associate cannot contribute to the HCFSA but may contribute to a Health Care Account (see below) and the LPFSA.

For both the HCFSA and the LPFSA, associates can elect to contribute between \$100 and \$3,050 annually in 2023 and between \$100 and \$3,200 in 2024. The LPFSA is the same as the HCFSA except that the amounts contributed may only be used for the reimbursement of eligible dental and vision expenses. In 2023 and 2024, associates were not allowed to carryover unused HCFSA or LPFSA funds from 2022 and 2023 respectively.

In 2023, Non-Highly Compensated Employees could contribute up to \$5,000 into their DCFSA and Highly Compensated Employees could contribute up to \$1,500. In 2023, the associate is considered highly compensated if 2022 earnings were \$135,000 or more. In 2024, Highly Compensated Employees (earnings from ADP were more than \$150,000 in 2023) could contribute up to \$1,500 into their Dependent Care FSA. Non-Highly Compensated Employees could contribute up to \$5,000 into their Dependent Care FSA.

For the years ended December 31, 2024 and 2023, total forfeitures from the FSAs amounted to approximately \$0.5 million and \$0.6 million, respectively.

1. DESCRIPTION OF THE PLAN (continued)

Health Savings Account - In 2023, associates could elect to participate in the CDHP and contribute up to a maximum of pretax \$3,250 (single coverage) or pretax \$6,650 (all other coverage levels) for CDHP Option 1 and \$3,100 for single coverage and \$6,250 for all other coverage levels for CDHP Option 2 into a Health Savings Account. In 2024, the pretax contribution limits were \$3,550 (single coverage) or \$7,200 (all other coverage levels) for CDHP Option 1 and \$3,400 for single coverage and \$6,800 for all other coverage levels for CDHP Option 2. In 2023 and 2024, for the CDHP with HSA Option 1, ADP contributes \$600 per year for an Individual and \$1,100 per year for all other coverage levels. For the CDHP with HSA Option 2, ADP contributes \$750 per year for an Individual and \$1,500 per year for all other coverage levels. In 2023 and 2024, all ADP contributions are prorated for HSAs opened after January 1. All contributions are deposited into a separate custodial account for each associate and are non-forfeitable.

Health Care FSA - Contributions to the HCFSA can be used to pay for eligible health care services for the associate and covered family members that are not reimbursed by any health care plan.

Dependent Care FSA - Contributions to the DCFSA can be used to pay the cost of day care expenses incurred for eligible dependents including such expenses as in-home child care or child care at a qualified day care center while the associate and/or spouse are working.

Contributions - Contributions to the Plan for certain benefit programs are made by ADP in amounts deemed necessary to provide for a portion of the benefits discussed above and are determined by an actuary. During the years ended December 31, 2024 and 2023, the Company contributed approximately \$266.9 million and \$249.8 million, respectively, to the Plan to provide benefits.

Associate contributions to the Plan are based on the type of benefit and option coverage selected. The cost of coverage borne by the associate is funded primarily through pretax payroll deductions with the exception of long-term disability.

To the extent required by the Consolidated Omnibus Budget Reconciliation Act of 1986 (“COBRA”), an employer is required to provide terminated associates with continued coverage for up to 18 months (29 months if totally disabled), identical to the coverage being provided under the Plan. In addition, widows, divorced spouses, spouses of Medicare-eligible associates, and dependent children who become ineligible for coverage under the Plan must be provided with similar continued coverage for up to 36 months. The cost of the continued coverage is borne by the terminated associate or other qualified beneficiaries. Contributions from former associates represent payments received from terminated associates or other qualified beneficiaries electing to continue such coverage.

Limitation on Coverage - Benefits provided under the Plan may be limited or reduced based upon such factors as the age of the participant for the life insurance benefits and the cause of the loss of life, limbs, or sight for the AD&D insurance benefits and may be reduced by amounts payable under Workers’ Compensation, any group insurance contract, or any other applicable federal or state law that provides income including social security for the health and disability benefits.

Termination of Coverage - Coverage under the Plan will generally end for a participant on the earlier of the date on which the participant’s employment ends with ADP, the date on which the participant requests termination of coverage, or the date on which the participant stops paying the required contribution amounts. Coverage for dependents under the above plans will generally end on the earlier of the date the dependent is no longer eligible or the date coverage ends for the participant.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investments - All security transactions are accounted for on the date the securities are purchased or sold (trade date). Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Fair Value of Investments - See Note 4 - "Fair Value Measurements."

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosures of contingent assets and liabilities. Actual amounts could differ from those estimates. Estimates that are particularly susceptible to change include assumptions used in determining the health claims incurred but not reported ("IBNR"), health claims payable and other actuarially determined amounts and fair values of investments. The significant assumptions used to determine the Plan's benefit obligations have been disclosed in Note 3 - "Benefit Obligations."

Benefit Payments - Premiums paid by either the Company or the Trust are recorded as insurance premiums in the accompanying statements of changes in net assets available for benefits. Claim payments are recorded when paid by the third-party claims processors. These payments are recorded as benefits paid in the accompanying statements of changes in net assets available for benefits.

Administrative Expenses - The Company maintains administrative service agreements with various insurance companies and their affiliates to process claims and disburse payments under the Plan. These administrative service fees and other related Plan expenses, including benefits paid to the extent such expenses exceed participant contributions plus earnings on the Plan's investments, are paid by the Plan, unless paid by the Company.

3. BENEFIT OBLIGATIONS

The Plan obligations at December 31, 2024 and 2023, for IBNR claims as of those dates, are estimated by the Plan's actuary in accordance with accepted actuarial principles. The assumed lag period for claims incurred but not reported ranges from 13 days for prescription drugs to 55 days for medical claims for the year ending December 31, 2024 and the assumed lag period for claims incurred but not reported ranges from 12 days for prescription drugs to 48 days for medical claims for the year ending December 31, 2023. The flexible spending accounts pending final claim submission as of each of the years ended December 31, 2024 and 2023 have been included in the IBNR amount in the table below in the amount of approximately \$1.3 million. Actual payments for claims incurred may differ from the estimated amounts.

4. FAIR VALUE MEASUREMENTS

The Plan applies the guidance in Accounting Standards Codification (“ASC”) 820.10 for assets recognized or disclosed at fair value on a recurring basis. The guidance in ASC 820.10 defines fair value, establishes a framework for measuring fair value, and expands the disclosures on fair value measurements. ASC 820.10 defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants. ASC 820.10 establishes market or observable inputs as the preferred source of fair value, followed by assumptions based on hypothetical transactions in the absence of market inputs.

4. FAIR VALUE MEASUREMENTS (continued)

The valuation techniques required by ASC 820.10 are based upon observable and unobservable inputs. Observable inputs reflect market data obtained from independent sources, while unobservable inputs reflect the Plan's market assumptions. These two types of inputs create the following three-level hierarchy to prioritize the inputs used in measuring fair value.

The levels within the hierarchy are described below with Level 1 having the highest priority and Level 3 having the lowest priority:

- Level 1: Fair value is determined based upon closing prices for identical instruments that are traded on active exchanges.
- Level 2: Fair value is determined based upon quoted prices for similar instruments in active markets; quoted prices for identical or similar instruments in markets that are not active; or model-derived valuations whose inputs are observable or whose significant value drivers are observable.
- Level 3: Fair value is determined based upon significant inputs to the valuation model that are unobservable.

Plan investments included in Level 2 are valued based upon the closing price fair values of the publicly traded underlying investments. These underlying investments are valued under the amortized cost method which approximates current market value. Under this method, the investments are valued at cost when purchased and thereafter, a constant proportionate accretion of discounts and amortization of premiums are recorded until the maturity of the security.

The Plan had no Level 1 or Level 3 investments as of December 31, 2024 or 2023 and there were no transfers in or out of Level 1 or Level 2 investments during the years ended December 31, 2024 or 2023. There have been no changes in the methodologies used to determine the fair values of investments as of December 31, 2024 and 2023.

5. FEDERAL INCOME TAX STATUS

The Trust established under the Plan to hold the Plan's assets is intended to qualify pursuant to Section 510(c)(9) of the Internal Revenue Code (the "Code"). Generally, the Trust's net investment income is exempt from income taxes; however, the Plan may be subject to tax on unrelated business income under Code Section 511. The Trust has obtained a favorable tax determination letter from the IRS dated February 22, 1988, and the Plan Sponsor believes that the Trust continues to qualify and operate in accordance with applicable requirements of the Code.

Accounting principles generally accepted in the United States of America require the Plan Sponsor to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain administrative expenses of the Plan are paid by the Company. Certain administrative functions are performed by officers and employees of the Company, who may also be participants in the Plan, at no cost to the Plan. These transactions may be deemed party-in-interest transactions; however, they are covered by statutory or administrative exemptions under the Code and ERISA's rules related to prohibited transactions.

7. PLAN TERMINATION

Although it has not expressed any intention to do so, ADP may elect to amend or terminate the Plan at any time subject to the provisions of the Plan and those set forth in ERISA. In the event of termination, ADP will contribute the necessary amounts to fund all claims incurred prior to the date of termination. No assets of the Plan may revert to ADP or be used for purposes other than for the exclusive benefit of the Plan's participants.

8. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.
