Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

We have performed audits of the accompanying financial statements of Apolis 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

Note 1: Summary of Plan Descriptions

The following description of the RJT Compuquest, Inc.dba Apolis (the “Company”) 401(k) Plan (the “Plan”) provides only general information. The Plan has changed its name from RJT Compuquest, Inc 401(k) Plan to Apolis 401(k) Plan in the year 2018. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

Plan Objective

The Plan was originally established on January 1, 2011 under the provisions of the Internal Revenue Code Section 401. The Plan is a defined contribution retirement plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The Plan provides tax deferral benefit for all employees of the company as soon as they meet the Plan’s age requirement.

Plan Administration

The Board of Directors of the Company may appoint an administrative committee to administer the Plan. If the board of directors fails to appoint an administrative committee, then the Company shall act as the administrative committee.

Participation Eligibility

All employees of the Company and any participating Affiliates, if applicable, except those covered by a collective bargaining agreement with the Employer, are eligible to participate in the Plan upon completing the Plan’s eligibility requirements. Participant must be at age of 21 to participate in the Plan. Each eligible participant will be automatically enrolled in the Plan as a participant.

Contributions

Under the Plan an eligible employee may make pre-tax elective deferrals or Roth elective deferrals. An employee may contribute any combination of pre-tax elective deferrals and Roth elective deferrals from 1% to 86% of his or her eligible earnings. The total combined amount of an employee’s annual elective deferrals is subject to both the Plan limit on elective deferrals and the Internal Revenue Code limit on deferrals. The Company may decide to make a matching contribution to the Plan, although the Company is not required to make this contribution. The percentage of elective deferrals to be matched will be determined by the Company and allocated to participants at the end of the plan year. The Company may decide to make a non-elective contribution to the Plan, although the Company is not required to do so. The non-elective contribution will be allocated to all employees eligible to participate in the Plan.

Vesting

Participants are always fully vested in their own contributions and respective earnings derived. Participants are fully vested in their total account balance if they terminate employment due to death, disability or attainment age 59.5 which is the early retirement age under the terms of the Plan. If they leave the company for any other reason, they will be vested in their matching contributions and their non-elective contributions account according to the following schedule:

<u>Years of Service</u>	<u>Vested Percentage</u>
Less than 2 years	0%
At least 2 years, but less than 3	20%
At least 3 years, but less than 4	40%
At least 4 years, but less than 5	60%
At least 5 years, but less than 6	80%
6 years or more	100%

Participant Accounts

The value of each participant's account can change depending on several factors, which include: (a) contributions that are made to the account, (b) increase or decrease in the market value of investments, and/or (c) cost of investment management expenses, transactional cost and service charges and participant's loan and loan repayments.

Notes Receivable from Participants

The Plan features a loan program to its participants. The minimum loan amount is \$500. The participants may borrow up to 50% of their vested account balance to a maximum of \$50,000. The loans must be fully repaid through payroll deductions within 5 years unless the loan is used for the purchase of participant's primary residence. Loans used to purchase participant's primary residence may be repaid in a period no more than 30 years. The loans are secured by the balance in the participant's account and bear interest at rates, which are commensurate with local prevailing rates published in The Wall Street Journal and are determined at the time the loan is made, currently ranging from 4.25% to 9.5%. Loan transactions are treated as a transfer to (from) the investment funds from (to) a participant's loan receivable. Loans that are considered uncollectible are treated as deemed distributions and therefore there is no allowance for uncollectible loans.

Payment of Benefits

Upon retirement, disability, death or termination of employment, the participant shall become entitled to the total value of participant's vested account, determined as of the valuation date. The

vested benefits can be received in a single lump sum payment or as a direct rollover to an individual retirement account or to an individual annuity or to another employer's tax qualified plan. The Plan allows for hardship distributions in accordance with IRS regulations. A participant may withdraw any part of their vested account in the event of undue financial hardship.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with generally accepted accounting principles in the United States of America. Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit responsive investment contracts.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may vary or differ from those estimates. Any adjustments applied to estimated amounts are recognized in the year in which such adjustments are determined.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a discussion of fair value measurements. Purchases and sales of securities are recorded on the trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent loans are treated as distributions based on the terms of the Plan document.

Excess Contributions Payable

The amount payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicant participants prior to March 15, 2025. The excess contributions payable as of December 31, 2024 and 2023 were \$64,239 and \$70,415 respectively.

Payment of Benefits

Benefits to participants are recorded when paid.

Risks and Uncertainties

The Plan provides for various investment options in mutual funds. These investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain securities, it is reasonably possible that changes in the values of investments will occur in the near term and those changes could materially affect participant account balances and the amounts reported in the statement of net assets available for benefits.

Note 3: Information Certified by Trustee

The following is a summary of the unaudited information regarding the Plan, as included in the Plan's financial statements and supplemental schedule prepared by or derived from information reported by the trustee of the Plan, Reliance Trust Company, for 2024 and 2023. The Plan administrator has obtained certification from the trustee as of December 31, 2024, and 2023, and for the year ended December 31, 2024, that information provided to the Plan administrator by the trustee is complete and accurate.

Note 4: Income Tax Status

The Plan has received a determination letter from the Internal Revenue Service dated July 8, 2014 stating that the Plan is qualified under Section 401(a) of the Internal Revenue Code (the “Code”) and, therefore, the Plan is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. Plan management believes the Plan is

currently designed and operated in compliance with the applicable requirements of the Code. Therefore, no provisions for income tax have been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5: Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:

- quoted prices for similar assets and liabilities in active markets
- quoted prices for identical or similar assets or liabilities in markets that are not active
- observable inputs other than quoted prices that are used in the valuation of the asset or liabilities
- inputs that are derived principally from or corroborated by observable market data by correlation or other means

Level 3 – Unobservable inputs for the asset or liability. Inputs that are unavailable in active open markets, subjective, supported with little or no market activity such as private transactions for identical assets or liabilities.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024, and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S Securities and Exchange Commission. These funds are required to publish their daily net assets value and to transact at that price.

Common/Collective Trusts: Valued at the net asset value (NAV) of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions may occur daily.

Note 6: Parties-in-Interest

Participants in the Plan are considered parties-in-interest according to ERISA. Generally, transactions between the Plan and parties-in-transactions are prohibited. The Plan made loans to its participants on a non-discriminatory basis and the loans are adequately secured; therefore, they are not considered as prohibited transactions. Reliance Trust Company serves as the Trustee as defined by the Plan and, therefore, these transactions qualify as party in interest transactions. As presented on the statement of changes in net assets available for benefits, the Plan made direct payments to the third-party administrator of \$ 65,577 for the year ended December 31, 2024. The Plan Sponsor/Company pays any other fees directly.

Note 7: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. However, no such action may deprive any participant or beneficiary under the Plan of any vested right.
