Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of CareMetx, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE A - DESCRIPTION OF PLAN

The following description of the CareMetx, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

CareMetx, LLC (the Company, Plan Administrator, and Plan Sponsor) formed the Plan effective January 1, 2016. The Plan is a defined contribution plan covering all employees of the Company who have completed three months of service as defined by the Plan and are at least 21 years old. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan is administered by a third-party administrator.

Plan Merger

The Company acquired PX Technology LLC in 2024. The Plan was amended effective August 1, 2024 to merge the PX Technology LLC portion of G&A Partners, Inc. Multiple Employer 401(k) Plan into the Plan. A transfer in of \$1,855,896 is included in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

Contributions

Participants may elect to defer up to 90% of their compensation as defined by the Plan on either a pre-tax or after-tax basis. Employees who have not declined participation in writing or completed a salary deferral election form as of the date of their eligibility to participate in the Plan will be automatically enrolled in the Plan with a pre-tax deferral rate of 3% and their contributions are invested in a fund designated by the Plan Administrator until changed by the participant. The deferral rate for participants automatically enrolled in the Plan increases by 1% each year in accordance with the Plan document. The Plan provides for a qualified automatic contribution arrangement (QACA) safe harbor contribution to eligible participants, which is 100% of the first 1% of compensation that a participant contributed to the Plan and 50% on the next 5% of compensation that a participant contributed to the Plan.

The Plan also provides for a discretionary non-elective contribution for participants employed on the last day of the Plan year. There were no discretionary employer non-elective contributions made during 2024. The Plan provides for the acceptance of rollover contributions from other plans qualified under the Internal Revenue Code (the Code). The Plan also provides for catch-up contributions for participants who reach the age of fifty by the end of the Plan year.

Participants direct the investment of their contributions into various options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as an allocation of the Company's non-elective contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant account earnings, compensation, specific participant transactions, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their deferral and rollover contributions plus actual earnings thereon. Vesting in QACA safe harbor contributions plus actual earnings thereon is based on years of continuous service and participants are fully vested upon completion of 2 years of credited service. Vesting in discretionary employer matching and non-elective contributions plus actual earnings thereon is based on years of continuous service at a rate of 20% each year. Participants are fully vested in their employer matching and discretionary profit sharing contributions after five years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, subject to certain Department of Labor (DOL) and IRS requirements. Notes receivable terms range from 1 - 5 years or longer for the purchase of a primary residence. Notes receivable are secured by the balance in the participants' accounts and bear interest at rates that range from 4.25% to 9.50% at December 31, 2024. Principal and interest are paid ratably through bi-weekly payroll deductions.

Payment of Benefits

Upon attaining age 59½ or termination of service, a participant may elect to receive a lump-sum amount, installments over a certain period, or partial withdrawal amounts equal to the value of the participant's vested account. During 2024, the Plan's automatic distribution amount increased from \$5,000 to \$7,000 as permitted by the SECURE 2.0 Act of 2022. If the value of the vested benefits credited to the participant's account is \$7,000 or less at the time of termination, the entire account will be automatically distributed to a participant without the participant's consent. In the event of a mandatory distribution of amounts greater than \$1,000 but not exceeding \$7,000, the entire amount will be distributed in the form of a direct rollover to an individual retirement account as designated by the Plan Administrator.

Active participants may request hardship withdrawals from their elective deferral account balances, subject to Plan provisions.

Forfeited Accounts

Forfeitures of employer contributions may be used to reduce future employer contributions, or to pay Plan administrative expenses. Unallocated forfeiture balances as of December 31, 2024 and 2023 were \$51,602 and \$27,062 respectively. Forfeitures of \$191,719 were used to reduce employer contributions for the year ended December 31, 2024.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Investment Valuation

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the trustee. See Note D for discussion of fair value measurements.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make repayments on a note receivable and the Plan Administrator deems the note receivable to be in default, the balance on the note receivable from the participant is reclassified to benefits paid to participants.

Investment Income Recognition

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions and Contributions Receivable

Contributions from Plan participants and related Company contributions are recorded in the year in which the employee's participant contributions are withheld from compensation. Any contributions attributable to the Plan year but not received by the trust by the last day of the Plan year are recorded as a receivable.

Contributions and Contributions Receivable (Continued)

The carrying amount of contributions receivable are assessed for the need to record a valuation allowance. The valuation allowance is an estimate derived from the Plan's historical losses of contributions receivable, adjusted for the Plan Administrator's assessment of current conditions, reasonable and supportable forecasts regarding future events, and any other factors deemed relevant by the Plan. Based on the Plan Administrator's assessment as of December 31, 2024 and 2023, no allowances for contributions receivable were recorded as of December 31, 2024 and 2023.

Other Liabilities

Other liabilities are amounts payable to the employer for excess contributions which are recorded as a liability with a corresponding reduction to contributions. The Plan accrued \$33,436 in other liabilities at December 31, 2023.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and fees for distributions are charged directly to the participants' accounts and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments on the accompanying statement of changes in net assets available for benefits.

The Company received funds from the RIA ERISA budget account totaling \$49,940 in 2024 which were used to pay certain Plan expenses. The receipt of these funds is included in other income on the statement of changes in net assets available for benefits for the year ended December 31, 2024.

Income Taxes

The Company adopted a non-standardized pre-approved profit sharing/money purchase plan with a cash or deferred arrangement which received an opinion letter from the IRS dated October 6, 2020, stating that the underlying pre-approved plan document was designed in compliance with applicable sections of the Code. Although the Plan has been amended since receiving the opinion letter, the Plan Sponsor believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025, the date which the financial statements were available to be issued.

NOTE C - CERTIFICATION

Investment information and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in the fair value of investments, interest and dividends, other income, and interest income on notes receivable from participants for the year ended December 31, 2024 was obtained by management and agreed to or derived from information and certified as complete and accurate by the trustee.

NOTE D - FAIR VALUE MEASUREMENTS

The three levels of the fair value hierarchy, which are based upon the inputs used to measure fair value, are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices in active markets that are accessible at the measurement date for identical unrestricted assets or liabilities (for example, exchange quoted prices).

Level 2 - Inputs to the valuation methodology are observable inputs, other than Level 1 prices, such as quoted prices for similar assets or liabilities in active markets, quoted prices in markets that are not sufficiently active to qualify as Level 1, other observable inputs, or inputs that can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 - Inputs to the valuation methodology are significant to the fair value measurement and unobservable (for example, supported by little or no market activity).

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual funds are valued at the net asset values of shares held by the Plan at year end, as reported on the active markets in which the investments are traded.

The method described above may produce fair value calculations that may not be indicative of net realizable values or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of a different methodology or assumptions to determine the fair values of certain financial instruments could result in different fair value measurements as of the reporting date.

NOTE E - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their total participant account balances.

NOTE F - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE G - RELATED-PARTY TRANSACTIONS AND PARTIES-IN-INTEREST TRANSACTIONS

Party-in-interest transactions include the investment in the funds of the trustee, and related dividend income, interest, and the payment of expenses to the trustee by the Plan. Such transactions are exempt from being prohibited transactions.

Reliance Trust Company (Reliance) provides certain administrative services to the Plan. Reliance received revenue for these services at crediting rates per investment ranging from 0.04% to 0.48% of the funds' balances as of December 31, 2024. These fees reduce the rate of return to the Plan for these investments and are netted within net appreciation in fair value of investments on the statement of changes in net assets available for benefits.

NOTE H - DELINQUENT PARTICIPANT CONTRIBUTIONS

As required by ERISA Section 2510.3-102, the Company is required to segregate participant contributions to the Plan from its general assets as soon as practicable, but in no event more than 15 business days following the end of the month in which amounts are withheld from wages.

During 2022, the Company did not remit \$122,685 of participant deferrals and loan repayments to the Plan timely. As of December 31, 2024, the participant deferrals and the lost earnings associated with these delinquent contributions have been remitted to the Plan.

During 2023, The Company did not remit \$161,599 of participant deferrals and loan repayments to the Plan timely. As of December 31, 2024, the participant loan repayments and the lost earnings associated with \$1,241 of these delinquent contributions have not been remitted to the Plan.
