## **INDEPENDENT AUDITORS' REPORT**

To the 401(k) Committee and Plan Administrator of  
**Aspen Heights 401(k) Plan**

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements***

We have performed an audit of the accompanying financial statements of Aspen Heights 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements (the "2024 financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained a certification from a qualified institution as of December 31, 2024 and for the year then ended, stating that the certified investment information, as described in Note 3 to the 2024 financial statements, is complete and accurate.

### ***Opinion on the 2024 Financial Statements***

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the 2024 financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Aspen Heights 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

#### *GENERAL*

The Plan, established on January 1, 2013, is a defined-contribution plan, subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). Employees of BRG Management, Inc. (the “Employer”, “Company”, or “Plan Sponsor”), are eligible to participate in the Plan on the first day of the month following the completion of five months of service.

Effective on December 29, 2022, the Setting Every Community Up for Retirement Enhancement (“SECURE”) 2.0 Act of 2022 was signed into law. The SECURE 2.0 Act is inclusive of approximately 90 provisions which offer many new benefits to employers and Plan participants. Certain provision changes are related to the following, but not limited to: changes to auto-enrollment and auto-escalation, age of required minimum distributions, catchup contributions, and increased dollar threshold for mandatory distributions. Depending on the specific provision, some will take effect immediately, while others begin in a future year. During 2024 and 2023, the Plan adopted certain required provisions of the SECURE 2.0 Act and is in the process of formally amending the Plan.

#### *CONTRIBUTIONS*

Upon enrollment in the Plan, a participant may direct contributions in 1% increments to any of the Plan’s available investment options. Employees may elect to contribute up to 90% of their eligible compensation on a pretax or post tax basis (“Roth”), not to exceed annual limits established in the Internal Revenue Code (“IRC”). For the year ended December 31, 2024, participant contributions were subject to an overall annual limitation of \$23,000. Participants who have attained age 50 before the end of the Plan year are eligible to make additional catch-up contributions up to \$7,500 (“Catchup Contributions”). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (“Rollovers”). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan Sponsor's matching contributions are based on each participant's contribution, equal to 50% of a participant's elective deferral up to 6% of each participant's compensation, as defined in the Plan document.

### NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED)

#### *CONTRIBUTIONS (CONTINUED)*

The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2% of annual eligible Plan compensation, increasing by 1% each year up to a maximum of 6%, and their deferrals are invested in a designated balanced fund, unless changed by the participant.

#### *PARTICIPANT ACCOUNTS*

Each participant's account is credited with the participant's contributions, Rollovers, and the Employer's matching contributions and earnings or losses from participant-directed investments, net of administrative expenses incurred by the participant, if any. Allocations are based on participant earnings (losses) on account balances, as defined by the Plan document. The benefit to which a participant is entitled at termination or retirement is the benefit that can be provided from the vested portion of the participant's account.

#### *VESTING*

Participants are vested immediately in their voluntary contributions, including Rollovers, plus actual earnings thereon. Vesting in the Employer's matching contributions and earnings thereon vest in accordance with the following schedule:

2	100%

The Plan provides for 100% vesting of Employer's matching contribution and earnings thereon upon death, disability, or attainment of retirement age, as defined.

#### *NOTES RECEIVABLE FROM PARTICIPANTS*

The Plan allows participants to borrow against their vested balances (minimum loan of \$500). The loans bear interest at a fixed rate of the prime rate plus 1%, as opposed to loans transferred in from previous plans which bear interest at varying rates. Interest rates on notes receivable from participants ranged from 4.25% to 9.50% during the year ended December 31, 2024.

#### *NOTES RECEIVABLE FROM PARTICIPANTS (CONTINUED)*

The maximum amount available for loans is the lesser of 50% of the participants vested account balance or \$50,000, reduced by the highest outstanding loan balance during the prior 12-month period. Loan repayment periods are for a maximum of five years unless the loan is for the purchase of a primary residence, in which case a reasonable repayment period is determined at the time of the loan. Loan repayments (principal and interest) are made through payroll deductions.

#### *PAYMENT OF BENEFITS*

Upon termination of service, death, disability or retirement, a participant or the named beneficiary may receive a lump sum equal to the vested value of his or her account or elect among various options to receive monthly installments over a specified amount of years. If the participant's vested account balance is less than \$5,000 at the termination date, then that balance may be distributed in a single lump-sum payment.

#### *HARDSHIP WITHDRAWALS*

A participant who is experiencing a financial hardship may request a withdrawal of all or any portion of such participant's vested accounts, as defined in the Plan document. For the year ended December 31, 2024, no hardship withdrawals were taken.

#### *FORFEITURES*

Forfeitures are those amounts for which a participant is not fully vested at the time of termination. Forfeitures may be used to pay future Plan administrative expenses or to offset future Plan Sponsor contributions. There were approximately \$19,000 of forfeitures applied to offset Plan Sponsor matching contributions during the year ended December 31, 2024. Forfeited accounts available on December 31, 2024 and 2023 amounted to approximately \$71,000 and \$33,000, respectively.

### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### *BASIS OF ACCOUNTING*

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### *USE OF ESTIMATES*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes herein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### *INVESTMENT VALUATION AND INCOME RECOGNITION*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s administrator determines the Plan valuation policies utilizing information provided by the investment advisor and trustee. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

#### *NOTES RECEIVABLE FROM PARTICIPANTS*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses have been recorded as of December 31, 2024 and 2023. Delinquent notes receivable are treated as distributions based upon the terms of the plan document.

#### *PAYMENT OF BENEFITS*

Benefits are recorded when paid.

#### *PLAN EXPENSES*

Certain expenses incurred in relation to the maintenance of the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payment transactions are charged directly to the related participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

#### *SUBSEQUENT EVENTS*

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

### NOTE 3 - INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company ("Reliance"), the trustee of the Plan. This information has not been audited by the Plan's independent auditors.

### NOTE 4 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect the participant account balances and the amounts reported in the statements of net assets available for benefits. The Plan, through its investment advisor, determines the appropriateness of the Plan's investment offerings and monitors investment performance and the risks associated therewith on a regular basis, which the Plan believes minimizes these risks.

### NOTE 5 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC Topic 820, Fair Value Measurements and Disclosures are described as follows:

#### *Level 1*

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

#### *Level 2*

Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

#### *Level 3*

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### *Mutual Funds*

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

##### *Common/Collective Trust Funds*

Valued on the basis of the relative interest of each participating investor in the fair value of the underlying assets of each of the respective common/collective trusts. The underlying assets are valued based on the NAV as provided by the investment account manager. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the trusts will sell the investment for an amount different from the reported NAV. There are no restrictions on redemptions of these investments.

#### NOTE 6 - TAX STATUS

The Plan uses a Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA plan, which received an opinion letter from the Internal Revenue Service (“IRS”) dated October 6, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### NOTE 7 – PARTIAL PLAN TERMINATION

As a result of significant involuntary reductions in the Plan Sponsor’s workforce, the Plan experienced a partial plan termination, as defined by ERISA, that began in 2022 and continued through December 31, 2024. As required by ERISA, participants impacted by a partial plan termination shall become fully vested in their account balances.

During the year ended December 31, 2024, the Plan Sponsor identified certain participants whose accounts had previously forfeited nonvested balances that may have been impacted by the partial termination. The Plan Sponsor is in the process of reviewing and correcting any affected participant accounts to restore forfeited amounts, if applicable. These corrections are expected to be completed in 2025. Management believes that the recognition of the partial termination and related corrective actions will not have a material impact on the overall financial position of the Plan.

#### NOTE 8 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their accounts.

#### NOTE 9 –PARTY-IN-INTEREST TRANSACTIONS

During the years ended December 31, 2024 and 2023, Reliance served as trustee of the Plan, as defined in the Plan document, and therefore, any fees paid by the Plan to Reliance qualify as party-in-interest transactions. ADP also served as the Plan’s record keeper, and therefore, ADP is also a party-in-interest to the Plan. Aggregate fees paid by the Plan to these parties-in-interest during the year ended December 31, 2024 were approximately \$5,000. The Plan also paid approximately \$9,000 during the year ended December 31, 2024 in fees to the Plan’s investment advisor, which also qualify as party in-interest-transactions. Additionally, certain investment related fees incurred by the Plan have been included in net appreciation in fair value of investments as they are paid through revenue sharing rather than as a direct payment.
