**NOTE 1 – DESCRIPTION OF PLAN**

The following description of the Paul, Weiss, Rifkind, Wharton & Garrison LLP Defined Contribution Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General: The Plan is a defined contribution plan established as of April 29, 2004 and administered by the Retirement, Insurance and Pension Committee whose members are appointed by Paul, Weiss, Rifkind, Wharton & Garrison LLP (the “Firm”) to serve for indefinite terms. The Firm also appoints a minimum of four partners to serve as Trustees of the Plan (the “Trustees”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Eligibility and Participation: Eligible participants include (1) salaried staff paralegals, regardless of employment commencement date, (2) salaried nonlegal administrative staff employees first hired by the Firm on or after April 29, 2004, or (3) attorneys elected by the Firm as “counsel” on or after April 29, 2004. Individuals compensated on an hourly or daily rate basis are not eligible to participate in the Plan. Effective January 1, 2024, the Plan was amended to include income partners as eligible participants.

Contributions: All contributions to the Plan are made by the Firm. The contribution allocation is equal to the contribution percentage (as detailed in the table below) multiplied by actual base salary paid to a participant. Consistent with provisions of the Tax Reform Act of 1986, base salary in excess of the Internal Revenue Service (“IRS”) dollar limit is not taken into account. The eligible compensation limit set by the IRS is \$345,000 and \$330,000, for 2024 and 2023, respectively.

In addition, IRS rules limit the amount of total participant and Firm contributions that can be made to an individual’s qualified plans in the aggregate. Total participant and Firm contributions are limited to \$69,000 and \$66,000 for 2024 and 2023, respectively.

The Firm contribution percentage is based on the sum of age in full years and completed full years of service on December 31, 2024 and 2023 (but counting only service as a Plan participant on and after April 29, 2004), determined as follows:

Vesting: A participant becomes vested upon completing five years of service or upon termination of employment due to death or reaching “normal retirement age” while still employed by the Firm. “Normal retirement age” is age 65. The Plan’s vesting schedule is as follows:

Less than 2	0%

5 or more	100%

Participant Accounts: Participant accounts are credited with the Firm’s contribution and allocations of Plan earnings and charged with an allocation of investment management fees. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Contributions may be invested at the election of each participant in various investment options, including a collective trust, a guaranteed investment contract, mutual funds, a money market fund managed by various fund managers, and a self-directed retirement account offered by Schwab Retirement Plan Services, Inc.

Payment of Benefits: The vested balance in a participant’s account is distributable upon termination of employment, retirement, permanent disability or death. Participants must commence distribution of their account balances no later than April 1st of the calendar year following the calendar year in which they attain age 73. At the election of the participant, distributions are made in either the form of a lump-sum payment or in the form of annual installments over a five-year period (or over any other installment term permitted by law).

Administrative and Investment Management Expenses: Expenses of maintaining the Plan are paid directly by the Firm and are excluded from these financial statements. Plan recordkeeping and custodian fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income reported by the Plan.

Plan Termination: Although it has not expressed any intent to do so, the Firm has the right under the Plan document to terminate the Plan at any time, subject to the provisions of the Plan and ERISA. In the event the Plan is terminated, each participant or designated beneficiary will become fully vested in their accounts and will receive the current value of the account in a manner elected by each participant or in a manner prescribed by the Trustees of the Plan. The Firm also has the right to amend the Plan at any time.

Forfeited Accounts: When certain terminations of participants in the Plan occur, the nonvested portion of the participant account, as defined by the Plan, represents a forfeiture. Forfeited amounts of \$207,523 and \$210,004 were used to reduce employer’s contributions during 2024 and 2023, respectively.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared using the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value, other than the fully benefit responsive investment contract, which is carried at contract value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contract, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold during the year.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan utilizes various investment instruments, including mutual funds, money market funds, self-directed brokerage accounts, a collective trust and a fully benefit responsive investment contract. Investment securities, in general, are exposed to various risks, such as interest rate, credit, liquidity, and overall market volatility risks. Due to the level of risk associated with certain investment securities and the sensitivity of certain fair value estimates to changes in valuation assumptions, Plan management believes it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

**NOTE 3 – CERTIFIED INVESTMENTS**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank (the custodian of the Plan).

#### NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3:* Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Mutual Funds and Money Market Funds: The fair values of mutual fund and money market fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Self-Directed Brokerage Accounts: Accounts primarily consist of mutual funds. Mutual funds are valued at quoted market prices, which represent the net asset value of the securities held in such funds (Level 1 inputs).

Collective Trust: The fair value of participation units held in the collective trust held at December 31, 2023 is based on the net asset value per unit as reported by the fund manager. The collective trust provides for daily redemptions by the Plan at reported net asset value per share, with no advance notice requirement.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **NOTE 5 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

The Plan holds a fully benefit-responsive investment contract (guaranteed investment contract or “GIC”) with New York Life Insurance Company (“NY Life”), also referred to as the investments that are reported at contract value. NY Life manages this investment and maintains the contributions in its pooled separate account (branded as the “Anchor Account.”). The assets of the Anchor Account are owned by NY Life. The Anchor Account is credited with earnings on the underlying investments and is charged for participant withdrawals and administrative expenses. Participants ordinarily may direct the withdrawal or transfer of all or a portion of their investments at contract value. There are no reserves against contract value for credit risk of NY Life or otherwise. The contract has no maturity date, but contract years begin on January 1 of each year.

Under the terms of the contract, interest will accrue daily, be credited monthly and the rate cannot be less than zero percent. The crediting rate reflects the book yield on the Anchor Account, adjusted to reflect the amortization of any realized gains and losses. Realized gains and losses are amortized over the target duration.

The Plan’s group annuity contract specifies certain conditions under which distributions from the contract would be payable at amounts below contract value. Such circumstances include Plan termination, Plan merger, premature contract termination initiated by the Company, and certain other Company-initiated events that result in distributions exceeding a set amount. The contract limits the circumstances under which NY Life may terminate the contract. Examples of circumstances which would allow NY Life to terminate the contract include the Plan’s loss of its qualified status, uncured material breaches of responsibilities, or material and adverse changes to the provisions of the Plan. If one of these events were to occur, NY Life could terminate the contract at an amount less than contract value. Currently, management believes that the occurrence of an event that would cause the Plan to transact contract distributions at less than contract value is not probable.

#### **NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Firm. No such officer or employee receives compensation from the Plan.

Certain Plan investments are shares of mutual funds and a money market fund managed by Charles Schwab Trust Bank (“Schwab Trust”). Schwab Trust was custodian during 2024 and 2023 as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Direct and indirect fees paid by the Plan reflect party-in-interest transactions.

#### **NOTE 7 – TAX STATUS**

The Internal Revenue Service has determined and informed the Firm by a letter dated February 14, 2018 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the determination letter, the Plan management and the Plan’s counsel believe that the Plan is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

**NOTE 7 – TAX STATUS** (Continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 8 – SUBSEQUENT EVENTS**

Plan management has evaluated subsequent events for recognition and disclosure through October 10, 2025, which is the date the financial statements were available to be issued.
