We have performed audits of the financial statements of the Paul, Weiss, Rifkind, Wharton & Garrison LLP Members' Pension and Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

NOTE 1 – DESCRIPTION OF PLAN

The following description of the Paul, Weiss, Rifkind, Wharton & Garrison LLP Members' Pension and Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan and administered by the Retirement, Insurance and Pension Committee whose members are appointed by Paul, Weiss, Rifkind, Wharton & Garrison LLP (the "Firm") to serve for indefinite terms. The Firm also appoints a minimum of four partners to serve as Trustees of the Plan (the "Trustees"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Eligibility and Participation: Partners of the Firm are generally eligible to commence participation in the Plan upon their admission to the partnership of the Firm. Income partners are not eligible to participate. Effective December 31, 2004, the Plan was changed from a money purchase pension plan to a profit sharing plan and participation was expanded to include certain salaried nonlegal administrative staff employees with compensation below the "Annual Compensation Limit" as defined in the Plan and amendments. Effective January 1, 2013, the Annual Compensation Limit was (i) \$39,000, but solely with respect to any person who is eligible to participate in the Paul, Weiss, Rifkind, Wharton & Garrison LLP Employees' Pension and Retirement Plan, and (ii) \$63,000 for any person not covered by clause (i).

Contributions: The Plan provides for contributions to be made by the partners through the Firm from their distribution of partnership earnings. For nonlegal administrative staff whose earnings for that year do not exceed the "Annual Compensation Limit" and are active employees in one of the US offices on the last day of the year, the Firm's contribution will equal a percentage of earnings for that Plan year. For both 2024 and 2023 the percentage was 7.5%. Annual contributions for partners are limited in accordance with the formula in the Plan, not to exceed \$46,000 and \$43,500 for 2024 and 2023, respectively.

The Internal Revenue Service limits the amount of total participant and Firm contributions that can be made to an individual's qualified plans in the aggregate. Total participant and Firm contributions are limited to \$69,000 and \$66,000 for 2024 and 2023, respectively. Participants who are 50 or older are eligible to make an additional contribution of \$7,500 for both 2024 and 2023.

Vesting: Participants become fully vested in employer contributions to the Plan after five years of service, after attaining age sixty-five, or upon termination by reason of death or disability. The vesting schedule of the Plan is as follows:

Participant Accounts: Participant accounts are credited with the Firm's contribution and allocations of Plan earnings and charged with an allocation of investment management fees. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Contributions may be invested at the election of each participant in various investment options, including a collective trust, a guaranteed investment contract, mutual funds, a money market fund managed by various fund managers, and a self-directed retirement account offered by Schwab Retirement Plan Services, Inc.

Payment of Benefits: The vested balance in a participant's account is distributable upon withdrawal from the Firm or upon retirement, permanent disability or death. Participants may elect to receive the value of his/her account when they leave the Firm, regardless of their age, or they may choose to defer payment until normal retirement age. At the election of the participant, distributions or withdrawals are made in either the form of a lump-sum payment or in the form of an annuity. Annuity payments may not exceed the life expectancy of the participant or the joint life expectancy of the participant and his/her beneficiary.

Administrative and Investment Management Expenses: Expenses of maintaining the Plan are paid directly by the Firm and are excluded from these financial statements. Plan recordkeeping and custodian fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income reported by the Plan.

Plan Termination: Although it has not expressed any intent to do so, the Firm has the right under the Plan document to terminate the Plan at any time, subject to the provisions of the Plan and ERISA. In the event the Plan is terminated, each participant or designated beneficiary will become fully vested in their accounts and will receive the current value of the account in a manner elected by each participant or in a manner prescribed by the Trustees of the Plan. The Firm also has the right to amend the Plan at any time.

Forfeited Accounts: When certain terminations of participants in the Plan occur, the nonvested portion of the participant account, as defined by the Plan, represents a forfeiture. Forfeited amounts of \$458,489 and \$211,432 were used to reduce employer's contributions during 2024 and 2023, respectively.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared using the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value, other than the fully benefit responsive investment contract, which is carried at contract value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measure for the Plan's fully benefit- responsive investment contract, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold during the year.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan utilizes various investment instruments, including mutual funds, money market funds, self-directed brokerage accounts, a collective trust and a fully benefit responsive investment contract. Investment securities, in general, are exposed to various risks, such as interest rate, credit, liquidity, and overall market volatility risks. Due to the level of risk associated with certain investment securities and the sensitivity of certain fair value estimates to changes in valuation assumptions, Plan management believes it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

NOTE 3 – CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank (the custodian of the Plan).

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

NOTE 4 – FAIR VALUE MEASUREMENTS (Continued)

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Mutual Funds and Money Market Funds: The fair values of mutual fund and money market fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Self-Directed Brokerage Accounts: Accounts primarily consist of mutual funds, and government and agency debt securities. Mutual funds are valued at quoted market prices, which represent the net asset value of the securities held in such funds (Level 1 inputs). Government and agency securities are valued at either the closing price reported in the active market in which the security is traded or valued based on yields currently available on comparable securities of issuers with similar credit ratings (Level 2 inputs).

Collective Trust: The fair value of participation units held in the collective trust as of December 31, 2023 is based on the net asset value per unit as reported by the fund manager. The collective trust provides for daily redemptions by the Plan at reported net asset value per share, with no advance notice requirement.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no unfunded commitments, liquidity, or redemption restrictions on the investments described above.

NOTE 5 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan holds a fully benefit-responsive investment contract (guaranteed investment contract or “GIC”) with New York Life Insurance Company (“NY Life”), also referred to as the investments that are reported at contract value. NY Life manages this investment and maintains the contributions in its pooled separate account (branded as the “Anchor Account.”). The assets of the Anchor Account are owned by NY Life. The Anchor Account is credited with earnings on the underlying investments and is charged for participant withdrawals and administrative expenses. Participants ordinarily may direct the withdrawal or transfer of all or a portion of their investments at contract value. There are no reserves against contract value for credit risk of NY Life or otherwise. The contract has no maturity date, but contract years begin on January 1 of each year.

Under the terms of the contract, interest will accrue daily, be credited monthly and the rate cannot be less than zero percent. The crediting rate reflects the book yield on the Anchor Account, adjusted to reflect the amortization of any realized gains and losses. Realized gains and losses are amortized over the target duration.

NOTE 5 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT (Continued)

The Plan's group annuity contract specifies certain conditions under which distributions from the contract would be payable at amounts below contract value. Such circumstances include Plan termination, Plan merger, premature contract termination initiated by the Company, and certain other Company-initiated events that result in distributions exceeding a set amount. The contract limits the circumstances under which NY Life may terminate the contract. Examples of circumstances which would allow NY Life to terminate the contract include the Plan's loss of its qualified status, uncured material breaches of responsibilities, or material and adverse changes to the provisions of the Plan. If one of these events were to occur, NY Life could terminate the contract at an amount less than contract value. Currently, management believes that the occurrence of an event that would cause the Plan to transact contract distributions at less than contract value is not probable.

NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Firm. No such officer or employee receives compensation from the Plan.

Certain Plan investments are shares of mutual funds and a money market fund managed by Charles Schwab Trust Bank ("Schwab Trust"). Schwab Trust was the custodian during 2024 and 2023 as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Direct and indirect fees paid by the Plan reflect party-in-interest transactions.

NOTE 7 – TAX STATUS

The Internal Revenue Service has determined and informed the Firm by a letter dated November 13, 2017 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan management and the Plan's counsel believe that the Plan is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 8 – SUBSEQUENT EVENTS

Plan management has evaluated subsequent events for recognition and disclosure through October 10, 2025, which is the date the financial statements were available to be issued. Effective January 1, 2025 partners serving in offices outside the continental United States are not eligible to participate.
