Statement of Reasonable Cause For the Delay in Attaching the Opinion of the Independent Qualified
Public Accountant.

The Plan Sponsor, the Third-Party Administrator (5500 preparer) and the Audit Firm are located in either Collier County, Florida or Lee County, Florida. Both counties are areas designated as a Presidentially Declared Disaster Relief area for multiple storms. This includes Hurricane Debby (FL-2024-07), Hurricane Helene (FL-2024-08) and Hurricane Milton (FL-2024-10). This resulted in a delay in wrokin gon the 2024 Plan Year.

The Plan has two Investment Providers. The recordkeeper for the assets held at Vanguard was changed from Newport Group to Ascensus in the 2023 Plan Year with continuing changes in reports and support. The audit process was delayed due to the delay in receiving full trust reports and related detail reports from Ascensus and the related Trust Certification from the Custodian. This delay did not allow the Third-Party Administrator sufficient time to prepare the full valuation reports and complete the reconciliation related to the conversion from Newport Group to Ascensus. Because of the delay, there was not sufficient time for the auditor to complete their audit work by the extended due date of the 5500. However, our Third-Party Administrator was able to complete the 5500.

It is expected that the audit will be completed in a short period of time and an amended return will be filed as soon as it is completed.
