We have performed audits of the financial statements of Julia Dyckman Andrus Memorial, Inc. 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by qualified institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.



In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental Schedule H (Form 5500), Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For



information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of the Plan

The following brief description of the Julia Dyckman Andrus Memorial, Inc. 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan Document or Summary Plan Description for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established on January 1, 2010, which covers all employees of Julia Dyckman Andrus Memorial, Inc. (Andrus or the Employer). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Custodian and Administration of the Plan

The custodian of the Plan was Charles Schwab Trust Bank (Schwab), and Ascensus (previously known as Newport Group, Inc.) served as the recordkeeper. The administrator of the Plan is Andrus. The custodian holds all assets of the Plan in accordance with the service provider contract with Andrus. The Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Effective December 1, 2024, the Plan was amended to reflect a change in the custodian and recordkeeper from Schwab and Ascensus, respectively, to Automatic Data Processing Retirement Trust Services, LLC (ADP) to serve as the custodian and recordkeeper.

Participation

Employees of Andrus' are considered eligible for participation, except for: (1) nonresident aliens; (2) employees covered by a collective bargaining agreement that does not provide for participation in the Plan; (3) leased employees; (4) residents of Puerto Rico; and (5) temporary and seasonal employees. Participant must be 21 years of age to participate in the Plan. Participation in the Plan begins on the first day of each payroll period of the Plan year coincident with or immediately following the satisfaction of the eligibility requirements.

Contributions

Each year, participants may contribute a percentage of their pretax annual compensation, as defined in the Plan, up to the maximum allowable under the Internal Revenue Code (IRC). Participants may also make a Roth contribution.

Andrus' contributions to the Plan consist of Employer 3% safe harbor contributions, Employer discretionary contributions, and Employer discretionary matching contributions. To qualify for these contributions, participants must have completed 12 months and 1,000 hours of service, be age 21 or older, and must not be subject to a collective-bargaining agreement. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined contribution plans (rollovers).

Each Plan year, Andrus makes a contribution to the Plan, on behalf of each participant, in an amount equal to 3% of each participant's annual compensation (the Employer 3% safe harbor contributions).

This contribution is made regardless of whether the participant makes salary reductions under the Plan. Safe harbor contributions for the year ended December 31, 2024 totaled \$473,044.

The amount of Employer discretionary contributions and Employer discretionary matching contributions is determined each Plan year. There were no discretionary contributions made for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of Andrus' contributions, Plan earnings, and administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investment of their account balances into various investment options offered by the Plan. Investment options also include various unitized managed accounts facilitated by Schwab and directed by the Plans investment advisor, Focused Wealth Management. The unitized managed accounts were not an investment option upon the transfer of assets from Schwab to ADP.

Vesting

Participants are immediately vested in salary-reduction contributions, rollovers, Employer 3% safe harbor contributions, and Employer matching contributions. Vesting in the Employer discretionary contribution portion of the participants' accounts is based on years of continuous service (including service prior to the effective date of the Plan) and is as follows:

Notes Receivable from Participants

Participants may borrow against their account balances subject to certain requirements as defined in the Plan document. Loans cannot exceed a maximum of \$50,000 or 50% of the participant's vested interest in the Plan. The loans are generally repaid through payroll deductions. The loan repayment period is no longer than five years, except in limited circumstances, such as the purchase of a principal residence. Interest shall be charged at a rate to be fixed by the Plan administrator and, in determining the interest rate, the Plan administrator shall take into consideration interest rates currently being charged on similar commercial loans by persons in the business of lending money. The interest rates for loans outstanding as of December 31, 2024 and 2023 ranged 8.75% to 10.50%. No more than one note is allowed at any time and repayment of the entire balance is permitted at any time.

Payment of Benefits

Participants make withdrawals from their accounts at age 59½ or prior to that age in the case of hardship, provided all other resources are already utilized. Upon retirement, death, disability, or termination of service, a participant or participant's beneficiary will receive the value of his or her account in the form of a lump-sum cash distribution.

Forfeitures

During 2024, forfeitures of \$24,205 were used to offset Employer contributions, in accordance with the Plan Document. As of December 31, 2024 and 2023, the forfeiture balance was \$26,297 and \$8,874, respectively.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting, in conformity with accounting principles generally accepted in the United States of America (GAAP).

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value, with the exception of the fully benefit-responsive investment contract, which is reported at contract value (see Note 3 for discussion on fair value of investment measurements and Note 4 for contract value measurements). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of the Plan's financial statements in accordance with GAAP requires Plan management to make estimates and assumptions that affect reported amounts of assets, liabilities, revenue, and expenses, as well as the disclosures of contingent assets and liabilities. These estimates include the fair value of investments. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Administrative Expenses

Administrative expenses recorded by the Plan represent custodian fees and other recordkeeping fees paid directly from the Plan to the Plan's custodian. Certain administrative expenses of the Plan are paid directly by Andrus. Expenses that are paid by Andrus are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments.

Contributions receivable

Participant contributions and any related employer matching contributions are recognized in the period during which the Employer makes the respective payroll deduction from the participant's compensation. Non-elective/profit sharing contributions are recorded in the relevant period in accordance with the terms in the Plan document.

3. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds and Exchange Traded Funds - Mutual funds and exchange traded funds are valued at the daily closing price as reported by the fund. Mutual funds and exchange traded funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Unitized Separate Accounts - The unitized separate accounts are valued based on the fair value of the underlying investments held by the fund less its liabilities. The participants trade at the unitized value. The unitized separate accounts hold mutual funds and exchange traded funds and shares in

a money market account that are sufficient to meet the unitized separate account daily cash needs. Unitization allows for daily trades.

Money Market Funds - These are valued at the daily closing price as reported by the fund.

The following tables set forth, by level within the fair value hierarchy, the Plan investments measured at fair value on a recurring basis. As required by GAAP, assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement and presented by general type.

The Plan had no financial assets that were measured at fair value on a nonrecurring basis during the years ended December 31, 2024 and 2023.

4. Investment Contract with Insurance Company

The Plan has a fully benefit-responsive investment contract with Lincoln Financial Group (Lincoln). Lincoln maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Lincoln, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. Withdrawals may be subject to a surrender charge. Upon Plan termination, there will be no surrender charge on Plan withdrawals, provided the account balances are rolled into another contract issue by Lincoln.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. Excess contributions and forfeitures held in the Lincoln Stable Value Fund will earn interest from

the date of deposit to the date of allocation at a rate of interest to be determined by Lincoln for each contract year. The minimum crediting interest rate is 1.00%. The contract does not have a maturity date. Withdrawals from the contract may be subject to a surrender charge.

Certain events limit the liability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

5. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Schwab, Lincoln National Life Insurance Company, and ADP, qualified institutions.

6. Plan Termination

Although it has not expressed any intent to do so, Andrus has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

7. Tax Status

The Plan has adopted a volume-submitter 401(k) plan. The Internal Revenue Service (IRS) has determined, by a letter dated June 30, 2020, that the Plan is designed in accordance with the applicable sections of the IRC. Accordingly, the Plan is permitted to rely on the opinion letter. The Plan administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

8. Party-in-Interest Transactions

Certain Plan investments are managed by Schwab, Lincoln, and ADP and, therefore, these transactions qualify as party-in-interest transactions. Participant loan and distribution processing fees are paid to Ascensus and ADP by participants. The Plan issues loans to participants which are secured by the vested balance of the participants' accounts. Such transactions, while considered

party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

9. Risks and Uncertainties

The Plan holds various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

10. Subsequent Events

Plan management has evaluated events through October 14, 2025, the date on which the financial statements were available to be issued. There were no subsequent events requiring adjustments to the financial statements or disclosures herein.
