1. **Description of the Plan**

The following is a brief description of the BPA International, Inc 401(k) Plan (the “Plan”) and is provided for general information purposes only. Participants should refer to the Plan document and related adoption agreement for a more complete description of the Plan’s provisions.

General

The Plan is a qualified defined contribution pension plan covering eligible employees of BPA International, Inc., (the “Company”). The Plan provides deferred compensation benefits and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan’s investments are administered and held in a trust by the Plan’s trustee, Reliance Trust Company (the “Trustee”), which also serves as the custodian of the Plan. The Trustee is a qualified institution in accordance with 29 CFR 2520.103-5 of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. ADP Retirement Services (“ADP”) is the record-keeper of the Plan. The Plan administrator is responsible for overseeing and ensuring compliance with the Plan document. The Trustee, the record-keeper and the Plan administrator are appointed by the Company.

Eligibility

The Plan covers all employees of the Company upon hire who have attained the age of 21 and have completed 6 months of service. Entrance into the Plan upon meeting the eligibility requirements is the first day of the month following the completion of eligibility.

Participant Contributions

Plan participants may make voluntary pre-tax contributions only, to be placed into a trust fund for their benefits, between 1% and 90% of compensation, generally not to exceed the Internal Revenue Service Code (“IRC”) limits discussed below. Effective January 1, 2023, the Plan participants may also make Roth contributions. Compensation for Plan purposes includes compensation reported on form W-2 including fringe benefits, expense reimbursements, deferred compensation and welfare benefits.

For 2024, the maximum amount of compensation that may be considered for deferral purposes by participants and employer contributions is \$345,000. For 2024, total participant contributions are limited to a maximum of \$23,000. Additionally, for 2024, individuals who are at least 50 years of age can make a “catch-up” contribution not to exceed \$7,500. The maximum annual addition for 2024 that may be contributed or allocated to a participant’s account under the Plan shall not exceed the lesser of 100% of a participant’s compensation or \$69,000 for employees under age 50 and \$76,500 for employees over the age of 50.

1. Description of the Plan

Employer Contributions

The Company, in its sole discretion, may contribute and allocate to each eligible participant's account, a matching percentage of the participant's elective deferrals. Matching contributions, if any, shall be determined as of the end of the Plan year. Any participants who are employed on the last day of the Plan year are entitled to receive matching contributions unless they are not employed on the last day of the Plan year due to normal or early retirement, disability, or death. No matching contribution was made for the 2024 Plan year.

The Company also has the option of making an additional discretionary non-elective employer contribution referred to as a profit-sharing contribution. The profit-sharing contribution is allocated to all participants based on their compensation to the compensation of all eligible participants. The Company did not elect to make a profit-sharing contribution in 2024.

Rollover Contributions

A Plan participant may make a transfer to the Plan of a benefit from a qualified retirement plan of another employer, referred to as a rollover, with certain restrictions.

Investments

Participants, in accordance with the Plan document, direct the Trustee to invest their contributions into various investment options offered by the Plan.

Vesting

Participants are immediately vested in their participant contributions and rollover contributions as well as any earnings thereon. Participants vest in employer matching contributions and profit-sharing contributions as follows:

Participant Accounts

The Plan administrator establishes and maintains a separate account for each participant, which is credited for rollover and voluntary contributions the participants make, Company contributions, and Plan earnings and expenses. Income earned and net appreciation or depreciation on Plan investments, for a given investment, are allocated in proportion to the participant's account balances in that fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. Description of the Plan

Notes Receivable from Participants

Each participant may borrow up to the lesser of 50% of the present value of the participant's vested interest in the account or \$50,000. The notes are secured by the vested balance in the participant's account. No note shall be less than \$500 and only 1 note at a time is allowed. At December 31, 2024, the outstanding notes interest rates ranged from 5.25% to 10.50% per annum. Any such borrowings are to be repaid within five years, unless the note is for the purchase of a principal residence for which the repayment period may not extend beyond thirty years. Principal and interest are to be repaid by payroll deductions.

Forfeitures

Upon termination of employment, participants forfeit their non-vested balances. At December 31, 2024, and 2023 there were forfeited non-vested account balances of \$3,535, and \$3,288 respectively. These accounts may be used to reduce future Company contributions or to pay administrative expenses of the Plan. There were no forfeited amounts used to reduce Company contributions or to pay administrative expenses during the year ended December 31, 2024.

ERISA Budget Account

The Trustee, through its revenue sharing arrangements ("Shared Revenue") with investment companies, shares a portion of the Shared Revenue with retirement plans which it services. During the year ended December 31, 2024, the Plan received \$18,378 of Shared Revenue from the ADP, and it was recorded as "Other income" on the Statement of Changes in Net Assets Available for Benefits. At December 31, 2024, and 2023, the remaining portion of the Shared Revenue, referred to as the ERISA Budget Account in the aggregate amount of \$1 and \$1 respectively, is included in the investment balance on the Statements of Net Assets Available for Benefits. The ERISA Budgeted Account can be used to either reduce Plan expenses or be reallocated to participant accounts. During 2024, \$18,378 were used to pay administrative expenses.

Retirement

The normal retirement age is defined as when the participant reaches the age of 65. At the normal retirement date, the participant is entitled to 100% of their account balance. The early retirement age is defined as when the participant reaches the age of 55. At the early retirement date, the participant is entitled to 100% of their account balance. A participant, who becomes disabled, as defined in the Plan document, is eligible for a disability retirement.

1. Description of the Plan

Distribution of Benefits

Distributions to participants are available upon the following events: retirement, termination of employment, the attainment of age 59 ½, total or permanent disability, or death. A participant's benefit consisting of his/her entire vested account balance can be paid in the form of either a lump sum, partial distribution (provided the minimum withdrawal is \$500), or on an installment basis. A participant with an account balance in excess of \$5,000 may elect to defer payment until attainment of the later of age 62 or the normal retirement age. A participant's written consent will be required for terminated participants requesting a distribution before age 65 if his/her vested account balance is greater than \$5,000. The Plan also provides for hardship withdrawals to participants meeting certain requirements as described in the Plan document. Participants must begin receiving Required Minimum Distributions, under IRS guidelines, upon reaching the age of 73.

Administrative Expenses

Administrative expenses may be paid out of the Plan or by the Company. Administrative expenses that are to be paid from the Plan are first paid from forfeitures, if any, and any remaining amounts are paid from the Plan's trust funds and allocated to all participants on a pro rata basis. The Company incurred certain administrative expenses relating to the Plan without charge to the Plan during 2024.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates and Assumptions

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a discussion of fair value measurements.

2. Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

Investment earnings are automatically reinvested into the investments from which they were derived. Purchases and sales of securities are reflected on a trade date basis. Dividend income is recorded on the ex-dividend date. Interest income is accrued when earned. The Plan presents, in the Statement of Changes in Net Assets Available for Benefits, the net appreciation (depreciation) of the fair value of its investments, which includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024, and 2023.

Payment of Benefits

Benefit payments to participants or beneficiaries are recorded when paid.

Risks and Uncertainties

The Plan provides for various investment options. Investment securities are exposed to various risks including but not limited to, interest rate, market, and credit risks. Due to the level of risk, associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Income Tax Status

The IRS has determined and informed the Trustee by an opinion letter dated October 6, 2020, that the prototype plan, which was adopted by the Company, was qualified under the appropriate sections of the IRC. Once qualified the Plan is required to operate in conformity with the IRC to maintain its qualified status. The Plan administrator and the Plan's legal counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified, and the trust established under the Plan is tax-exempt. No provision for income taxes has been included in the financial statements since the Plan has no unrelated business income tax.

2. Summary of Significant Accounting Policies

Income Tax Status

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or the DOL. The Plan administrator has analyzed the tax positions taken by the Plan and had concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by the IRS and the DOL, however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examination for the years prior to 2021.

Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 15, 2025, which is the date the financial statements were available to be issued.

3. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants would become 100 percent vested in their employer contributions.

4. Investments

For the year ended December 31, 2024, the Plan's investments appreciated (including gains and losses on investments bought and sold, as well as held during the year) in value by \$ 334,088.

5. Fair Value Measurements

The Financial Accounting Standards Board's ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means;
- If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Below is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual funds: Valued at the daily closing price as reported by the fund. Interest-bearing cash and mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

5. Fair Value Measurements

Common collective trusts: Valued at the NAV of units of the particular common collective trust. The NAV, as provided by the common collective trust, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
