We have performed audits of the financial statements of the Hamilton Beach Brands, Inc. Employees' Retirement Savings Plan (401(k)) (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Hamilton Beach Brands, Inc. Employees' Retirement Savings Plan (401(k)) (the "Plan") provides only general information. Reference should be made to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all eligible employees of Hamilton Beach Brands, Inc. and Weston Brands, LLC (collectively the "Employers") who are carried on a U.S. payroll. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Plan Administration: The investments of the Plan are held in a trust at Vanguard Fiduciary Trust Company (the "Trustee"). The Trustee performs investment management and recordkeeping responsibilities for the Plan.

Contributions: All employees on domestic payroll (other than interns) are eligible to participate in the Plan on their date of hire provided that they are not members of a collective bargaining unit, nonresident aliens, or leased employees.

Participants may make before-tax contributions and Roth contributions to the Plan by means of a salary deferral agreement. Participants can contribute from 1% to 25% of their earnings, subject to certain limits that are set forth by the Internal Revenue Code ("IRC"). The Plan provides for (i) automatic enrollment of eligible employees in the Plan with a 3% pre-tax deferral and (ii) an annual 1% increase in the amount of a participant's deferral percentage, up to 7%, unless, in either case, the employee elects to waive these procedures. The Plan allows participants who have attained age 50 by the end of the Plan year to make catch-up contributions in accordance with Code Section 414(v). The Employers make a safe harbor retirement contribution under the Plan equal to 3% of compensation for the plan year. Profit sharing contributions are made under an age-weighted, integrated contribution formula and consist of a minimum (or automatic) payment, and as warranted by business results, a performance-based "additional" amount.

Participants may direct their contributions and any related earnings into investment options in 1% increments. The Plan allows participants to change their investment elections daily.

Vesting: Participants' contributions, the safe harbor retirement contribution, and related earnings are fully vested. Profit sharing contributions are subject to a five-year graded vesting schedule. Also, participants who reach age 55, die, become disabled or die while performing qualified military service while employed are fully vested in profit sharing contributions regardless of service time with the Employers.

Benefits: Benefits equal to the vested value of the participant's account are payable upon retirement, termination, permanent disability, or death. Partial or full withdrawals of the participant's account balance are also available under certain circumstances as described in the Plan. Benefits are paid in the form of a lump-sum payment or installments.

Under the Plan, a participant who is an employee may, at any time, withdraw his or her frozen after-tax contributions and rollover contributions plus earnings on those contributions. Additionally, a participant who is an employee and who has attained age 59-1/2 may withdraw all or part of his or her before-tax, matching, and retirement contributions and earnings on those contributions. Before-tax contributions may be withdrawn by a currently employed participant under age 59-1/2 only in the case of hardship as determined by the Administrative Committee of Hamilton Beach Brands, Inc. (the "Administrative Committee" or "Plan Administrator"). Other withdrawal provisions apply to certain participants, as required by law.

Forfeitures: Forfeitures of terminated participants' nonvested accounts are used to reduce future employer retirement contributions. At December 31, 2024 and 2023, forfeitures of \$120,920 and \$139,924, respectively, were available to reduce future contributions. Forfeitures applied against employer retirement contributions for the year ended December 31, 2024 were approximately \$161,000.

Notes Receivable from Participants: Participants may borrow up to lesser of \$50,000 or 50% of their vested account balance (excluding profit-sharing contributions) with a minimum note amount of \$1,000. Notes are repayable through payroll deductions. The repayment period is generally up to five years. However, if the note is for the purchase of a primary residence, the repayment period is up to 30 years. The interest rate is determined by the Administrative Committee based on prevailing market conditions and is fixed over the life of the note.

Participant Accounts: Each participant's account is credited with the participant's contributions and allocations of (a) the Employers' contributions and (b) Plan earnings/(losses). Allocations are based on participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Expenses: Certain administrative expenses of the Plan are paid by the Employers. Certain recordkeeping and trustee fees are paid by the Plan. Loan origination fees associated with the notes receivable from participants are included in the amount of the initial loan withdrawal. Investment management fees are charged to the Plan as a reduction of investment return and included in investment income (loss) reported by the Plan.

Plan Termination: Although the Employers have not expressed any intent to do so, the Employers reserve the right to discontinue contributions and terminate the Plan at any time subject to the provisions of ERISA and the Internal Revenue Code ("IRC"). In the event of Plan termination, employees will become 100% vested in their account balances and the Plan's net assets would be distributed according to each participant's account balance.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, and credit risks. Market risks include risks associated with ongoing global events. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Notes Receivable from Participants: Notes receivable from participants are recorded at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants.

Payment of Benefits: Benefits are recorded when paid.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and (losses) on investments bought and sold as well as held during the year.

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following describes the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective Trust: The fair values of investments in collective trusts are based on the value per unit as published daily by the investment manager and represent the net asset value of units held by the Plan at year end (Level 1 inputs).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 3 - CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Vanguard Fiduciary Trust Company (the trustee of the Plan).

NOTE 4 - PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employers, and certain others. Certain investments are shares of mutual funds managed by Vanguard Group, Inc. The Plan also invests in a collective trust fund managed by Vanguard Fiduciary Trust Company. Vanguard Fiduciary Trust Company is a wholly-owned subsidiary of Vanguard Group, Inc. Vanguard Fiduciary Trust Company is the Trustee, as defined by the Plan; therefore, these investments and investment transactions qualify as party-in-interest transactions. The Plan also had notes receivable from participants which constitute party-in-interest transactions. The Plan paid fees to the Vanguard Group, Inc., which also constitute party-in-interest transactions.

NOTE 5 - INCOME TAX STATUS

The Plan has received a determination letter from the Internal Revenue Service dated January 15, 2014, stating that the Plan is qualified under Section 401(a) of the Internal Revenue Code (the "Code") and, therefore, the related trust is exempt from taxation. Subsequent to the issuance of the determination letter, the Plan was amended and restated. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Plan Administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan, as amended, is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes the Plan is no longer subject to federal income tax examinations for years prior to 2021.

NOTE 6 - SUBSEQUENT EVENTS

Plan management has evaluated subsequent events for recognition and disclosure through October 15, 2025, which is the date the financial statements were available to be issued.

In February and March 2025, the Plan received approximately \$13.4M (unaudited) of funds transferred from the terminated Hamilton Beach Brands, Inc. Pension Plan as part of a Qualified Replacement Plan transfer. The Plan applied \$3,379,462 of these funds to the 2024 profit sharing contribution.
