Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Pacific Gas and Electric Company Long-Term Disability Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for plan benefits and of plan benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for plan benefits and of changes in plan benefit obligations for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Pacific Gas and Electric Company Long-Term Disability Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Pacific Gas and Electric Company Long-Term Disability Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Pacific Gas and Electric Company Long-Term Disability Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- exercise professional judgment and maintain professional skepticism throughout the audit.
- identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Pacific Gas and Electric Company Long-Term Disability Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter

NOTES TO THE FINANCIAL STATEMENTS

NOTE 1: DESCRIPTION OF PLAN

The following is a brief description of the Pacific Gas and Electric Company Long-Term Disability Plan (“Plan”). The plan document provides a more complete description of the Plan’s provisions.

General – The Plan provides long-term disability benefits covering both bargaining and non-bargaining unit employees of Pacific Gas and Electric Company (“Utility”). Two separate Pacific Gas and Electric Company Long-Term Disability Trusts (“Trusts”) are maintained under this Plan. One trust holds the assets to fund disability benefits for bargaining unit employees and the other trust holds the assets to fund disability benefits for non-bargaining unit employees. The Plan is subject to certain applicable requirements of the Internal Revenue Code (“Code”), as amended, and the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

PG&E Corporation, the Utility’s parent company, established the Employee Benefit Committee (the “EBC”) to provide oversight over the administration and financial management of affiliated company-sponsored employee benefit plans. The EBC also provides corporate governance and administrative oversight on behalf of the Plan. The EBC retains The Bank of New York Mellon/BNY Mellon, N.A., as the trustee (“Trustee”) of the Trusts. The EBC retains Willis Towers Watson as the actuary (“Actuary”) for the Plan.

Eligibility – Bargaining unit employees automatically become eligible for long-term disability benefits on the first day of the month following attainment of regular employment status. Non-bargaining unit employees automatically become eligible for long-term disability benefits on the first day of the month after beginning employment.

Contributions – The Trusts are mainly funded by contributions from the Utility based upon determinations made annually by the Actuary in accordance with an accepted actuarial method and consistent with the basis for rate recovery as authorized by the California Public Utilities Commission (“CPUC”), and subject to the maximum tax deductible limits set forth in the Code.

Employees on long-term disability are responsible for paying 7.5 percent of the actual costs of their medical plan premiums.

At December 31, 2024, the Plan’s ratio of net assets available for plan benefits to plan benefit obligations was approximately 76.0 percent. The remainder of the plan benefit obligations are expected to be funded through future participant contributions, employer contributions, and asset appreciation.

Benefits – The benefits provided under the Plan include long-term disability income replacement and health and welfare benefits for employees on long-term disability. Disability benefit payments provided under the Plan replace 50 percent, 66-2/3 percent, or 70 percent of base pay, with an offset of 50 percent or 100 percent of the amount Plan participants receive in disability insurance benefits from the Social Security Administration, based on the participant’s date of eligibility for Plan benefits.

Administrative Expenses – The Utility pays certain costs of administering the Plan. The Plan pays investment management fees, trustee fees, and certain administrative expenses, including monthly administration fees to third-party health care administrators and insurance companies.

Plan Termination – The Utility’s Board of Directors reserves the right to amend or terminate the Plan at any time, subject to the provisions of ERISA and the applicable collective bargaining agreements. No plan assets may revert to the Utility or PG&E Corporation or any other participating affiliate as long as the Plan is in existence or has unpaid obligations.

Related-Party Transactions – The Plan’s investments include shares of a short-term investment fund managed by the Trustee. These transactions qualify as party-in-interest transactions under ERISA. During the year ended December 31, 2024, there were no material party-in-interest (or related-party) transactions.

Subsequent Events – The Plan has evaluated subsequent events through October 10, 2025, which is the date the financial statements were available to be issued.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with U.S. generally accepted accounting principles (“GAAP”).

Use of Estimates – The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions. These estimates and assumptions affect the reported amounts of assets and liabilities, and changes therein, and the disclosure of contingencies. Actual results could differ from these estimates. The significant assumptions used in the actuarial valuation are discussed below.

Investment Valuation – The Plan’s investments are stated at fair value. The Plan’s management determines the fair value of certain assets and liabilities based on assumptions that market participants would use in pricing the assets or liabilities. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, or the “exit price.” The Plan’s management utilizes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value and give precedence to observable inputs in determining fair value. An instrument’s level within the hierarchy is based on the lowest level of any significant input to the fair value measurement. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). Assets and liabilities are classified based on the lowest level of input that is significant to the fair value measurement. See Note 3: Fair Value Measurements, below.

Income Recognition – Net appreciation in fair value of the Plan’s investments consists of: (1) the net change in unrealized appreciation or depreciation on investments held during the year, and (2) the realized gain or loss recognized on the sale of investments during the year. Purchases and sales of securities are recorded on a trade date basis.

Plan Benefit Obligations – The Plan’s actuary estimates the Plan’s year-end benefit obligations for future disability and medical payments to members considered permanently disabled in accordance with generally accepted actuarial principles and practices. For measurement purposes, the actuary used annual rates of increase in the per capita cost of covered health care benefits for all participants of 7.5 percent for the obligation as of December 31, 2024. The assumed health care cost trend rate for 2024 is approximately 6.75 percent, decreasing gradually to a trend rate of approximately 4.5 percent in 2034 and thereafter. The assumed health care cost trend rate for 2023 is approximately 7 percent, decreasing gradually to a trend rate of approximately 4.5 percent in 2034 and thereafter. The present value of the future estimated benefit payments is based on a discount rate of 5.31 percent and 4.99 percent at December 31, 2024 and 2023, respectively. Disabilities incurred by participants but not yet reported at December 31, 2024 and 2023, are included in plan benefit obligations. The weighted-average health care cost-trend rate assumption affects the amounts reported in the accompanying financial statements.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the Plan’s benefit obligations.

Investments – The Plan’s investment funds are managed by the Trustee and various investment managers who have discretionary investment authority over the investments. The EBC is responsible for the selection of the Plan’s investment funds, but not the selection of the underlying investments. Neither the EBC nor the Utility is involved in the day-to-day investment operations of the Plan’s investment funds.

Derivatives – Subject to certain guidelines, the EBC allows the Plan’s investment managers to use derivative instruments to achieve investment objectives. As of the years ended December 31, 2024 and 2023, the Plan held no direct investments in derivatives.

Benefit Payments – The Utility pays the income replacement portion of long-term disability payments directly to participants. The Trusts reimburse the Utility for these payments. Health and welfare benefits for bargaining unit employees are paid directly from the Trusts. All benefit payments are recorded when paid.

NOTE 3: FAIR VALUE MEASUREMENTS

A three-tier fair value hierarchy is established as a basis for considering fair value assumptions and for inputs used in the valuation methodologies in measuring fair value:

Level 1: Observable inputs that reflect quoted prices (unadjusted), for identical assets or liabilities in active markets.

Level 2: Other inputs that are directly or indirectly observable in the marketplace.

Level 3: Unobservable inputs which are supported by little or no market activities.

Common/Collective Trusts – Units held in a common collective trust (“CCT”) are valued using the net asset value (“NAV”) practical expedient of the CCT as reported by the CCT managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CCT, minus its liabilities, and then divided by the number of units outstanding. The NAV practical expedient of a CCT is calculated based on a compilation of primarily observable market information. There are no restrictions on the terms and conditions upon which these investments may be redeemed.

Registered Investment Companies – These investments held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission and are valued at the daily closing price as reported by the fund. These funds are required to publish their daily NAV and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

Under a market approach, the Plan's fair value measurements incorporate various factors such as the credit standing of the counterparties involved, the applicable exit market, and specific risks inherent in the instrument.

NOTE 4: TAX STATUS

The Internal Revenue Service ruled, by letters dated November 7, 1995, that the Trusts funding the Plan are designed in accordance with applicable sections of the Code and are exempt from federal income taxes. Accordingly, no provision for federal income taxes has been made in the accompanying financial statements. The Trusts have been amended since the letters dated November 7, 1995. The EBC, as plan administrator, believes that the Trusts continue to be designed and operated in accordance with the applicable requirements of the Code.

Plan management evaluates tax positions taken and recognizes a tax liability (or asset) if a Trust has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. No uncertain positions have been identified that would require recognition of a liability (or asset), or disclosure in the financial statements as of December 31, 2024 and 2023. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
